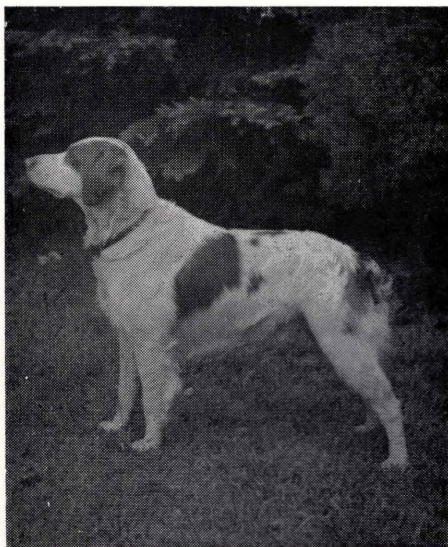

FROM OUR TRAINERS

RALPH HESSELTINE, Overbrook, Kansas:

"My training season this winter was remarkable for its poor weather. We had unseasonable cold in December followed by record-breaking cold in January and February, with heavy ice and snow holding us back all winter. However our bird crop was the very best ever. I've heard the old veterans say the carry-over crop of bobwhite this year was the largest they had ever seen."

Some of the young all age dogs that look good include Major of Valley Forge, owned by Dr. H. Mitchell, Denver; Lou's Happy Red, owned by Mr. C. B. Marshall, Fort Scott, Kansas; Sunka of Minnehaha, owned by Polly Girton of Sioux Falls; and Penny's Ringo Kid owned by Phillip Pittman of Kansas City. Several green all ages I am just starting to break . . . look like they will come on.

JANE THOMPSON, Novi, Michigan:

Left Michigan the day after Christmas with our string of dogs-in-training for our winter training grounds in Leesburg, Georgia. Our work down here is on native quail and this is rough, briary country. It takes a real he-man dog to hunt this country and do it right. I personally think there is nothing like it for making a "bird dog." It really teaches them to dig. Another great feature is that the hunting season is open all the time down here and dogs do not have "dry" hunting but can have a bird shot down for them once in a while, which, as we all know, tends to make the real bird dog.

Our work is done mainly from horseback which lets us see at all times what is going on—a great benefit in straightening dogs' patterns out and also lets us get hold of a dog when necessary in his training.

An unusually heavy rain reportedly

drowned out the first quail hatching last spring, but that there were a number of birds for those who looked for them. I am ready now (March 5) to return to Novi, then on July 1 will leave for summer training camp to train on prairie chicken and ruffed grouse.

I would say we have had a successful training season when I think of the last two trails attended. They were Pinehurst and Carbondale with a total number of placements by my dogs equaling fifteen, and six of those were firsts.

LEE HOLMAN, Whittington, Illinois:

Had several cold days through January but good working conditions most of the time. February seemed to be a better month still, with warmer weather and quail, apparently, easier to find, coming out of the heavy cover where they had laid up on the coldest January mornings. There was a truly good quail crop.

In February, Mr. and Mrs. Robert Seger of Mercer, Pennsylvania came down and we went with them to his place in Tennessee to run a young dog of theirs. All enjoyed seeing the dog run and Mr. Seger took motion pictures of the trip. I was proud to show him two very promising young dogs which I am very glad to have on my string: Ferd's Flag of Leeway and Holley Haven Lucky. Mr. Seger had several shots of the dogs pointing quail. We thought we saw from these two dogs, action that indicated they may be future champs. Mr. Seger is a new owner and I'm sure Brittany fans will be seeing him and his helpers at the field trials.

The following appears as good potential all age material:

Pinoak Guy, Ferd's Concor of Leeway, Fredan's Intern, Cork's Copper Brandy, Beauregard's Billy Boy. All look as if they will make the grade.

A 5,000 acre tract of ground posted for about twenty-five years has recently been made available for training near his Tennessee kennels, and says the place has "lots of quail."

**MAIDZA VAN DEUSEN,
New York, City, New York:**

I am strictly a bench show obedience trainer and handler. I do my training on our hundred acre farm in Roxbury. I have a large, fenced in area for training, kennel facilities, and we are isolated enough so I can give dogs plenty

of running to keep them in good shape while they are in my care.

The only Brittanies I have handled and made champions are my own, Ch. Kaymore's Connecticut Yankee, who seems to be getting quite well known here in the East, and my father's Ch. Winnetka Calvie, not so well known at the moment. I started a Brittany, Ch. Peggy of Kaymore, on the show circuit last summer. I got her half way toward her championship and had to turn her over to another handler, Richard Farnhan, when my mother broke her leg.

WASHINGTON BRITTANY CLUB

The Washington Brittany Club's Fall field trial held on Sept. 12, 13, 14 was of unusual interest because of the first Pacific Coast Regional Pheasant Championship which followed (full report to follow.)

Open All Age Stake

The trial got underway with the stake of primary importance, the Open All-Age, being run on new one-hour contiguous courses consisting of attractive, birdy cover running the gamut from smooth green clover and alfalfa fields to irrigated pasture and creek bottoms. Bird supply was assured with cooperation of the Washington State Game Department in releasing 100 pheasants to supplement native birds on each course.

1st—Fld. Ch. Ouragan Mion Boy.

2nd—Suzanne de Ferncroft.

3rd—Apple Hill Gigi.

4th—Punch of Paradise.

Special mention should also go to Seahurst Ripcroft, bracemate with winner Ouragan Mion Boy. Between these two they had 20 clean finds. W. G. Black of Woodland, California and W. M. Egerton of Vancouver, B.C. served as judges for this 22 entry stake.

Open Derby and Open Puppy Stakes

Simultaneously with running the Open on the new courses, the Open Derby was started using the old Air-

port grounds, and at the conclusion of the Derby, the Puppy Stake began. Both were completed on Friday, and that evening an unusually pleasant time was enjoyed at the Hidden Valley Guest Ranch with dinner and dancing to the tunes of an excellent cowboy style band.

On Sunday the Amateur Stake was held on the new trial grounds, but as regular 30 minute braces. An extra attraction was the beautiful perpetual trophy to winner of this stake presented by Everett Metzger of Portland, Oregon, "The Nancy A Challenge Trophy," commemorating Everett's old

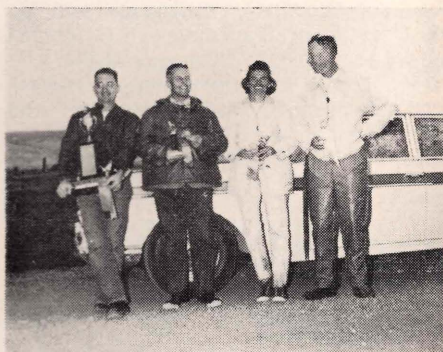

PACIFIC COAST REGIONAL PHEASANT CHAMPIONSHIP

The first Pacific Coast Regional Pheasant Championship, was held September 15, 1958 following the Washington Regional fall trial. Basic planning for this event was done in March, 1958 by a regional committee composed of Dr. T. McWhorter, Sr., California, James Scarbrough, Northern California, Gene Chapman, Golden Empire, Warren Smith, Oregon and Bert Heinz, Washington. It was decided by this committee to stage the event at Ellensburg and run one hour heats on multiple courses, so as to emulate the National Championship stake as closely as possible. The Washington delegate was elected Chairman and in making local arrangements was assisted by Dr. Glen Helmer, Art Stavik, Ed Keefe, Paul Whalen, Don Runciman, Dr. Don Faulkner and Vernon Leatha. The Ellensburg Chamber of Commerce helped make arrangements with farmers whose land

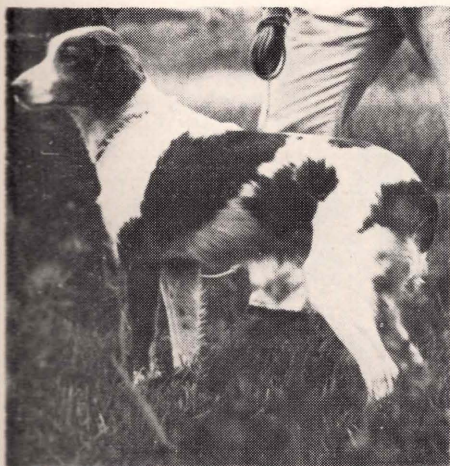
was used, so as to permit judges and others to ride horseback.

After months of planning, it was a disappointment to find AKC would only sanction the event, necessitating a fourth day. It was decided, therefore to run the Regional Open All-Age stake on one-hour courses, as planned; the four placements therein being qualified for the Championship stake along with any other Brittany Spaniels similarly qualified by having placed in any other AKC licensed one-hour stake. We mention these problems to assist other Brittany Regionals desiring to hold their own regional contests. Forewarned, they may stage such an event more easily and happily for everyone concerned than we did the first time!

The Running

The Pacific Coast Pheasant Championship saw only three of the four or more eligible dogs competing, and on Monday morning the first brace was set down on a portion of the same grounds used for the Regional Open All-Age Stake.

Bracemates, Suzanne de Ferncroft, owned by Bert Heinz and handled by Stan Aeck, and Punch of Paradise, owned by Art Stavik and handled by

Dick Shoemaker ran exceedingly well and hunted all the birdy spots. Suzanne had three perfect finds, marred by an unproductive on a running bird. Punch went birdless except for a stop to flush on wild flushing bird.

Apple Hill Gigi, owned by Dr. Glen Helmer and handled by Stan Aeck was then set down with Suzanne de Ferncroft, drawn as bracemate for the bye. Gigi due to her serious neck operation and two days' hard competition in the Regional did not run as well as usual and broke on her first bird. Both dogs then made several perfectly handled finds and at close, both were on point but widely separated. In the excitement Judge Black was thrown from his horse, but both dogs held for him to remount and handlers flush and shoot.

Since no entrant had a perfect series, the judges named Suzanne de Ferncroft as winner but withheld the Championship. Judges W. G. Black of Woodland, California and John Mills, Edmond, Washington are to be commended for initiating this championship stake on a very high plane.

Though it fell short of expectations, this first big Regional event was a success in that it attracted 65 entries compared to a previous high of 52 for Washington Brittany Club trials. Another year we hope the event will draw entries from other regions whose owners will discover that a field trial vacation to the Pacific Coast is rewarding in many ways. If ultimately it leads to the rotation of the Brittany National among the various regions, our dreams will have been fulfilled.

RINGNECK BRITTANY CLUB

With a bumper crop of pheasants, invigorating weather, and topnotch grounds, the Ringneck Brittany Club held its trial on September 27 and 28th over the Spencer, S. D. trial grounds. James Kellogg of Grand Island, Nebraska and Kenneth Larson of Sioux Falls, S. D. passed judgement on the 56 dogs. Everything was in order from the delicious Buffalo banquet to the tremendous meals prepared on the grounds by the ladies of the Spencer V.F.W. The pen-raised quail were some of the strongest ever, as can be attested to by the bird planters, who had a hard time keeping them in the bird-field.

Open All Age Stake

The 22 entry was won by Teka of Siouxland, who climaxed a wide race with several clean finds in the bird field. Teka was above reproach with the exception of one find, when he dropped. This win finishes Teka, much to the delight of his owners and many

admirers. Duc du la Bretagne swept second place with a fair race and two sterling finds. Duc showed the sought after intensity and fire on his birds. Duc was recently purchased from Harlan Wyrick by Hart Workman of Topeka, Kansas. Siouxland Jib, put forward a fast race and came up with two finds. Jib's manners were exemplary in the bird field. Corky of Valley Britt, aging, but nevertheless game, had several good finds and a good bouncy race. Several other dogs put down class heats, but went for naught in the bird field.

Open Derby Stake

Explorer of Richmond went far and wide to sweep first place in the Derby. Explorer showed the punch and fire desired in a good derby dog. Billy's Rocky Rocket pushed the first place dog hard, but not hard enough, as he too, had a class race all the way around. Both first and second place dogs hit the far reaches of the course and then

went some. Butch's Dandy and King Concho of Richmond dropped into third place respectively, exhibiting quite a bit of desire and fire. The judges and the gallery seemed to agree that the derby, with 13 starters, was the class stake of the trial with all dogs showing future promise.

Puppy Stake

King Concho of Richmond, derby placer, walked off with first place honors in the puppy stake. Harve Butler, his handler, had a field day in the puppy stake, as he walked off with all four places. King Concho went high, wide and handsome and looked good doing it. Monty of Richmond, Marty of Richmond and Bomarc of Richmond dropped into second, third and fourth respectively. All these dogs are of the same litter.

Amateur All-Age Stake

The Amateur was won by Jefferson of Minnehaha, with three finds in the bird-field and a fair race. Jefferson was slow to start, but warmed to the job about half way around, and then really took off. Corky of Valley Britt again showed the gallery some excellent birdwork, as well as a fine race. Siouxsland Jib showed well to the front, and came up with a good find in the bird-field. A fourth place was not awarded in the 15 dog stake, because of lack of bird work. Also rans who laid down back courses, but showed immaturity in bird manners were Major of Valley Forge, Sunka of Minnehaha, and Ringneck Buccaneer. These three dogs, along with Jinx of Kampeska, showed worlds of style and desire, but went too far, and chased their birds.

NORTHERN CALIFORNIA

The Northern California Brittany Club held its Fall Field Trial on Sept. 27 and 28 at the Grizzly Island Waterfowl Management Area located a short distance from Fairfield, California.

The dogs were run on one course grounds with pheasants furnished by the California Fish and Game Commission planted in the birdfield. Cover is mostly native grass which was high and dense enough to keep the dogs busy hunting and with the exception of very hot weather, around 100 degrees, the trial was one of the most enjoyed so far. The quality of work displayed by the top dogs was above average and all the dogs held up well in spite of the heat.

Judging was handled by Glen Black of Woodland, Calif.; Duke Cecil of Stockton, Calif.; and Dr. Phillip Thunen of Marysville, Calif.

Headquarters for the drawing was at the Fairfield Motor Inn, Fairfield, Calif. and the Judge's Banquet was held at the Colonial Kitchen also located at Fairfield, Calif.

Open All Age

Jacques Bon Ami had an unusually good ground race, keeping well to the front, hunting out all likely spots; was responsive to the handler and showed good manners on two finds. He

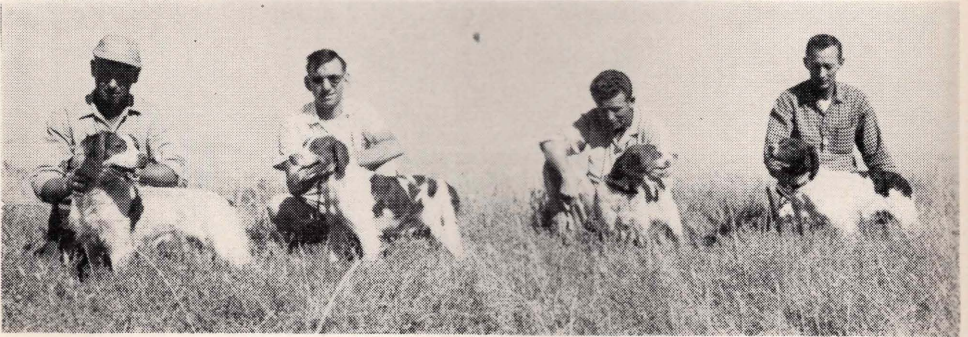
finished strong. Buena Vista Beau started with extremely wide range but slowed some at the end, was stylish on one find and a stop to flush on another. Beau Kiki ran a good steady race hunting his ground well. Excellent manners on one find and a stop to flush on another. Lancer of Richmond ran a class race and was kept from higher placement by one unproductive and moving a little on one of his finds. He had two other finds on which he showed good manners.

Open Puppy

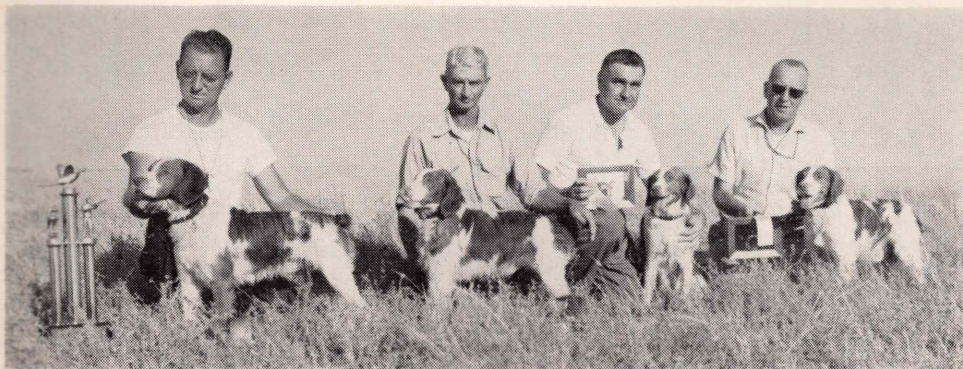
Lund's Trooper, though barely over six months old ran an extremely good race ranging wide, holding to the front with no cutting back. He had one excellent find on which he showed a stylish point, then produced and chased with lots of enthusiasm. Percell's Lucky had a little larger ground race, though not quite as consistent. Showed good nose and style on one find. Bing ran a good race though not as wide as the above placed. And had one find. Buster's Reoid ran a good steady puppy race and dshowed lots of promise.

Open Derby

Brown's Kim ran a class race with an excellent ground pattern. Was very enthusiastic and finished strong. Was

Sir Ted ran a good hard race. Had two finds with good manners and was charged with one unproductive. Buena Vista Beau started strong but tired some at finish. He had two finds on which he showed good manners.

In the last three stakes, out of 12 placements, 4 dogs have already acclaimed their bench championship. They are All-Age dogs: Helgramite Tarquinius, Belloaks Ibby, Belloaks King, and Kaymore's Connecticut Yankee, a Derby.

Judges for the Puppy, Open and Derby Stakes were, Mr. Joseph Stetson of Peekskill, New York, and Mr. Matt Rooney of Redding, Connecticut. Judging the Amateur Gun Dog Stake were Mr. Thomas H. Faile of White Plains, New York and Mr. John J. Smith of Valhalla, New York. The Club wishes to thank them all.

Puppy Stake

Only two placements were awarded in this stake. Brittchester's Highbrow, ran a fair race, flushed a pheasant, but

seemed to have little interest in quail.

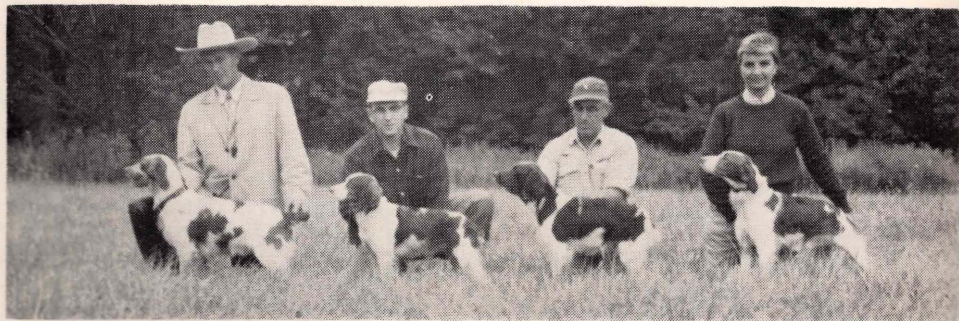
Open All Age

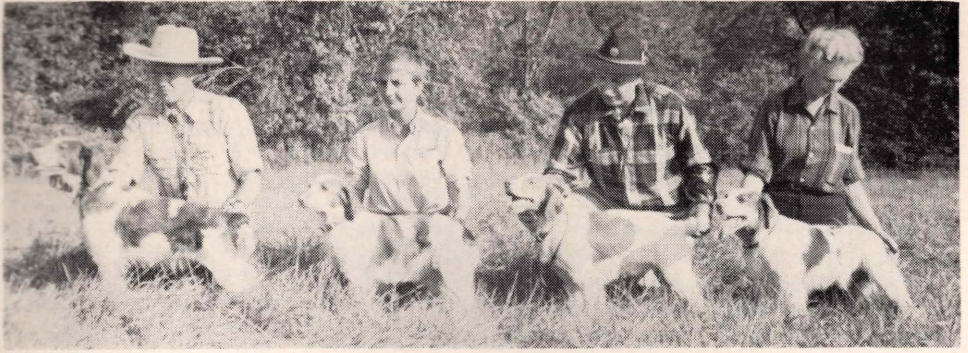

Belloaks His Nibs, ran a fairly good, forward pattern.

Beau Geste de Bare, and Jodee, also turned in good performances.

Amateur Gun Dog Stake

Belloaks Gunner in first place hunted the right places and as he came over a stone wall two birds flew out. Gunner stopped to flush beautifully; later had a nice find, again showing good manners.

Juchoir's Markette ran somewhat spotty in the back course, had a find on the road under trying conditions, and was steady on a find in the bird field.

Belloaks King ran well, though a touch wide for a shooting dog stake; had a nice find and showed good manners.

Belloaks Ibbey ran a fair race in nice shooting range.

Helgramite Excalibur and Helgramite Tinker also showed up well.

Dinner Saturday evening was held at the Deer Inn on Route 6, Brewster. Among other trophies presented, was "Helgramite Hollow's Rotating Ramona," given each Fall for various reasons to be held one year and to be prominently displayed during that year. No one is ever privileged to hold Ramona a second time. The recent recipient of this coveted award was Betty Rodriguez of Norwalk, Connecticut.
