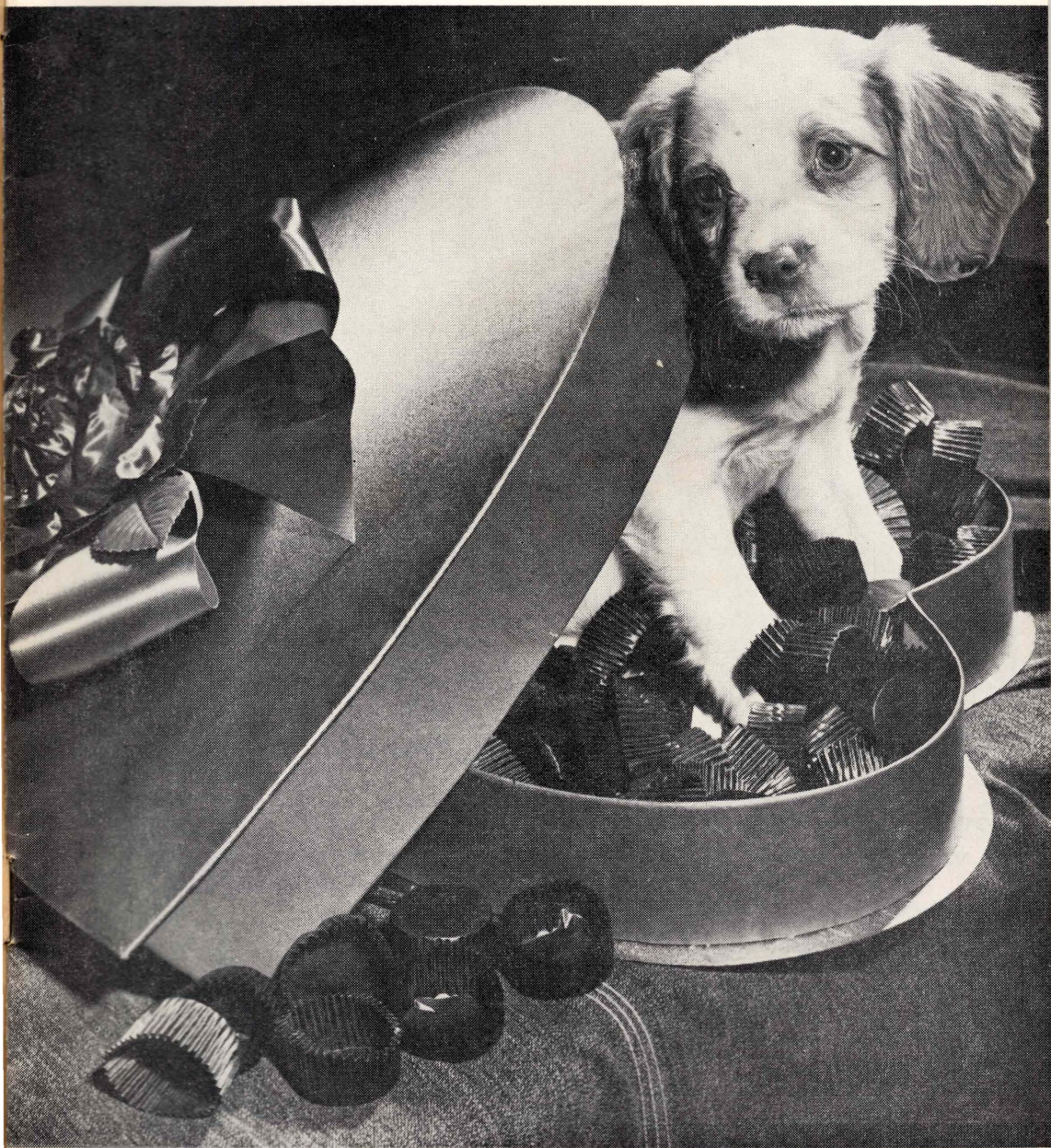

## NATIONAL SPECIALTY SHOW

Our 16th Annual National Specialty Show, which was held at the Crab Orchard Field Clubhouse on November 29th, followed the pattern of the 1950, 1953 and 1956 shows in that it was necessary to find a substitute for the judge. This time, Maxwell Riddle arrived in Carbondale at 1:00 p.m. on the 29th but was taken to the hospital immediately with an infection of the inner ear. We were informed later in the afternoon that Mr. Riddle's condition was serious and that he must remain in the hospital. We were fortunate to have available a judge who has judged Brittanies in some 20 states and who had previously substituted in our National Specialty Show on two occasions. After considerable persuasion, by the officers and show committee, Mr. E. W. Averill of Birmingham, Mich. agreed to withdraw his entries and judge the show.

With 67 entries, this show came within 2 of equalling the highest entry in a National Specialty Show since they were held in Carbondale. Further-

more, in checking the catalog, one would wonder if they were entered for a field trial or for a show. Excluding the puppies, in which there was no field trial stake, there were 52 different dogs shown. Of this 52, 11 were entered in the Futurity, 16 in the Amateur All-Age and 14 in the National Open Championship. Of the 9 Specials Only dogs shown, 6 were also run in one or more of the field trial stakes. Percentage-wise, excluding the puppies, 63% of all the dogs shown were also run in the field trial. Most of the field trial handlers brought dogs to be entered in the show. Can any other breed match this?

### SHOW RESULTS

Best of Breed was awarded to Dual Ch. Dingo's Little Mike, owned by George Wilson of Saginaw Valley and handled by Lee Holman. According to the judge, Mike was the soundest dog in the show, moving with power and precision in every step. While he was in field trial condition, rather than in

show condition, it was felt that this should not be of importance in a show of this character. Mike is a very typey Brittany, as well as a sound one, with the head, ears, nostrils and eyes that a good Brittany should have. He is very tightly coupled and has ample lung room and heart room. In every line, he suggests the enthusiastic, hard-running, tireless, long-scenting field dog that he is. He is a worthy successor to the long line of fine dogs that have preceded him as National Champion. His most serious competition came from Ch. Happy Hunters Brandy Boy, owned and handled by Don Frisch, of Michigan. While this is a more beautiful dog, in some ways, he was definitely overfurnished, a fault carefully described in our show standard, and did not move with as much drive as Mike.

Best Opposite went to Ch. Penny's

Happy Pepi, owned and handled by Arthur J. Parker of Saginaw Valley. This is a beautiful bitch, very typey, and completely sound. She does not have the drive or the power of a Mike or a Brandy, but, for a bitch, she was about as nice a specimen as one often sees. Saginaw Valley seems to be the new seat of show dogs in our club, judging from the fact that they ran off with both of our top awards this year. Michigan and Midwest had better get busy again.

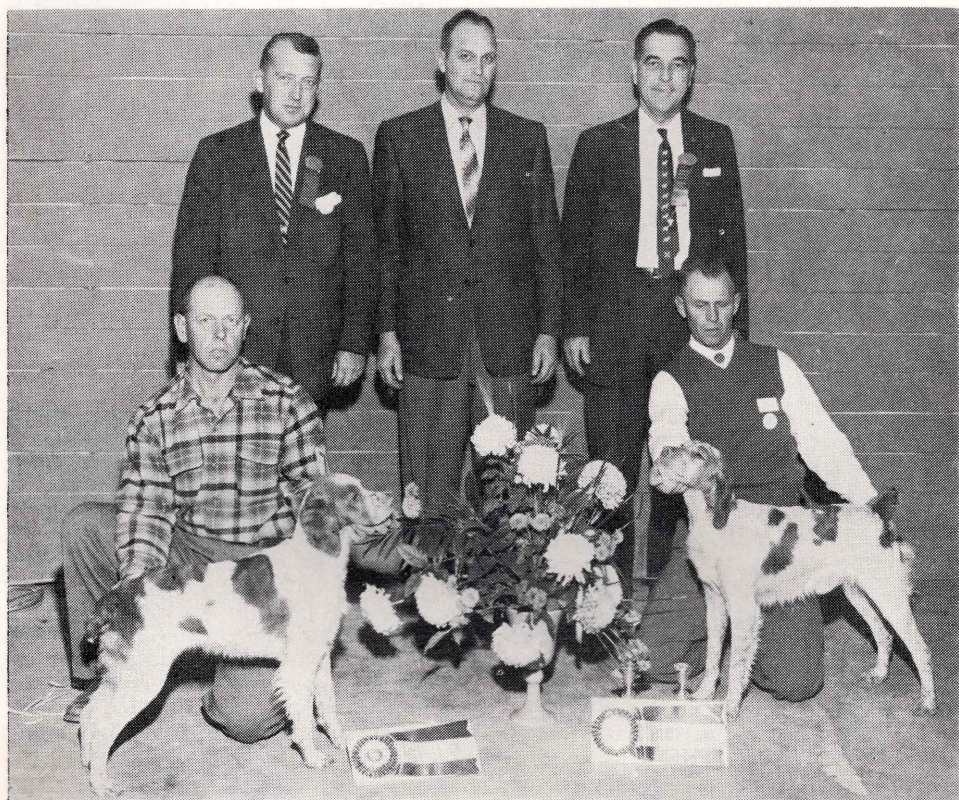
Winners Dog and Best of Winners was F. T. Ch. Towsey, owned by Thomas E. Black of Wichita, Kansas and handled by Del Smith. One year ago, this dog, entered in the first show for both dog and handler, won the Novice class but was beaten out by more experienced dogs later. This year, it appears that Del Smith has taken a few



lessons, since the dog was shown perfectly and his fine points were brought out to the utmost on every occasion. Here is a dog that has just about everything our standard calls for; type, true proportions, fire and drive. He is not yet ringwise enough to comete with seasoned champions but a few more shows and he could give any of them a run for their money. The judge was very complimentary to both the dog and handler, remembering them from last year. His most serious competition came from King of Edough, owned by Dave Olund of Illinois and handled by Lee Holman. This dog also has just about everything we want in a Brittany but did not move with the fire and drive that characterized Towsey's

every step. He is a beautiful dog, though, and Mr. Averill had to go back and forth between them for a long time before he could pick Towsey as a trifle the better, in his opinion. King took Reserve Winners Dog, of course.

Winners Bitch went to Holley Haven Salley, owned and handled by your reporter. Salley has not been at her best recently but she came out of it just in time for this show, where the chips are really down. We don't want to tell you how good she is but—we like her. And so did Mr. Averill. Her toughest competition came from Dave Olund's Carolyn's Ginger. While we couldn't see much of this part of the show, Mr. Averill said that Ginger is a fine bitch, very well-balanced, excel-

lent type and a free mover. With this information, we were very happy that Salley was at her best.

Best Puppy in Show went to Pinoak Punch, owned by Dave Olund and handled by Jimmy Holman. This is a fine mature dog that is ready to move into the toughest competition any time he wants to. With a few shows under his belt, he could give any of them a rough time.

Starting with the Spring Trials, 1959, each Region will be responsible for reporting to THE AMERICAN BRIT-TANY, through a Regional Reporter. This person will send to the Field Trial Secretaries of clubs holding trials the mimeographed forms for listing data on winners in each stake run. She will edit all field trial reports and other material to be published in the magazine, before sending it on to the Editor, Dr. S. Allen Truex. At the conclusion of all trials held within their particular Region, the reporter will prepare charts, both in the Spring and at the conclusion of the Fall field trials. ## ELEVENTH BRITTANY SPANIEL FUTURITY

Chien Fox, white and orange Brittany dog, owned and handled by Richard B. Fox of Orleans, Massachusetts, displayed beautiful style and courage during thirty minutes of spectacular casts and smart hunting with a classic point at the end of a second series callback won the Judges acclaim as the winner.

Second place went to Handjem's Rujohn Rip, orange and white dog, owned by Henry Lardy of Madison, Wisconsin, bred by John W. Lee, Indianapolis, Indiana, and Handled by John Thompson. Rip laid down an excellent derby race, handling well, with a covey find.

Third honors were won by Explorer of Richmond, liver and white dog bred and owned by R. C. Busteed of Canyon, Texas. Handled by H. A. Butler, Jr., Explorer ran well from breakaway to pickup, also handling his birds well.

Fourth, was Lady Desire, orange and white bitch, owned by Larry Stanford of Wichita, Kansas, bred by Thomas R. Atkinson. Lady was sired by last years National Champion, F. T. Ch. Towsey. Handled by Delmar Smith, Lady ran a generally fine race, had many contacts with game and excellent derby manners.

This was the Eleventh Brittany Spaniel Futurity, held over the fabulous Crab Orchard Lake National Wildlife Refuge near Carbondale, Illinois.

Two and one half days were used to run 64 Brittany Spaniels, the largest entry in the history of this National event which is increasing in participation and quality with each running.

This course provides a challenge and test to a bird dog—presenting rough cover to try the courage and stamina of the greatest and the open areas where a dog may show to every advantage. A Brittany performing well on these grounds, will never embarrass

an owner, wherever else he is put down to hunt.

In addition, the weather took a hand and provided other hazzards. The temperature in the low twenties throughout most of the running, plagued the morning braces particularly. The icy ground cut feet and upset scenting conditions, and generally interfered with ideal dog performance. Wild fowl had mostly left the area, but some geese, hardier than their fellows, remained to distract some of the braces.

Judges were Roy Sharpe of Carrollton, Michigan and W. I. (Ike) Brandon of Carbondale, Illinois. This hard riding, conscientious pair, won the respect and confidence of all participants. Realizing that in this breeder's classic, emphasis is properly placed on class performers and dogs of potential championship calibre, they gave each brace of dogs their most careful attention. The placements assigned by these men, and their acceptance by the participants, testify to their competence.

### **The Running**

Everyone of the dogs placed showed their hunting abilities with contact on game, Though bird finding is a most important consideration, a futurity placement must do more than find and point game. A dog must exhibit class and style in doing it.

We are indebted to C. W. "Chuck" Morse and Ruth Lee for the following description of the running—Chuck followed each brace and dictated his comments to Ruth who took them down in shorthand in freezing weather.

### **Nanette of Lekcid— Buddington Goode**

Both dogs broke slow at 7:28 a.m., were friendly the entire way, and showed little desire to hunt. It was quite



apparent that the frost and frozen ground slowed them up. There was a covey find at 7:44 that neither dog seemed to smell, not clear which of the dogs actually pushed the birds out. Location as on the previous day when Yankee Boy's Tommy was running.

#### **Belloaks Nicky—**

#### **Becky's Jack of LaRue**

This was a good breakaway at 7:58; both dogs cast well forward with Nicky on the outside early. Jack made some excellent hunting casts and seemed to strengthen as time progressed. At 8:12 a covey was walked up by handlers which both dogs should have had a chance on as they were both in that area. At 8:20 Nicky shortened and was picked up at 8:24, later observed her feet were badly bleeding. Jack finished very strong. His entire race was good Derby race.

#### **Matador of Richmond—**

#### **Rapid of Richmond**

An 8:30 breakaway. Matador broke well, but at 8:35 he fussed in a corner. Everyone felt that he was going to produce a covey, but no covey was seen. He ran a pretty good Derby race, forward. Rapid seemed a handful, got behind quite a bit, and about 8:45 was

lost for some time. Both dogs shortened up the last couple of minutes.

#### **Way-Kan Sally—**

#### **Ferd's Hobo Jake**

Dogs broke at 9:04. at 9:04½ Jake ran through Tom Lunsford's covey and chased it. This was a good brace. Both dogs were putting down good Derby races. At 9:19 by railroad tracks a covey was seen in the air. When brought under official judgement, Sally was there. Jake had crossed the railroad off to side. Reporter's opinion was that Sally flushed the covey. Sally stopped to bump a covey about 5 minutes before pickup. Both dogs were really reaching out at the finish.

#### **Brittchester's Rickatic—**

#### **Peg and Jon's Ginger**

These two broke at 9:43. At 9:45 Rickatic was called off as he was working a single in the middle of field, bird flushed. At 10:08 Rickatic had contact with a covey but did not point. Just previous to this the judges had ridden up a covey. Rickatic finished slow. Ginger ran a good forward course with two nice casts. Showed well out front after being lost for about 4 minutes shortly before pick-up.

**Pacolet's Pollyann—  
Zu-Bee's Mitzi**

Gallery rode up a covey about 5 minutes after breakaway. Both dogs had only fair Derby race. A lot of geese were seen on this brace.

**Davellen Andre—  
L'Ami Jacques**

Broke at 10:50 with both casting well to left. At 10:57 Jacques's handler walked up a covey. Dogs were off to left over hedge, so no possible contact. 11:08 the horse gallery rode up a covey of about 15 birds. At 11:10 Jacques had an opportunity on a single from this last covey but showed no tendency to point. At 11:14 Andy had a wonderful opportunity to point the largest covey seen so far; approximately 30 birds, but showed no tendency to stop. He put the birds out and chased. Both dogs ran medium races, Jacques had the edge.

**Showman's Flashy Britnik—  
Dingo's Gizmo**

Both of these dogs put down a pretty good Derby heat, particularly Gizmo showed a lot of enthusiasm, good tail

and head and good application. Gizmo took nice casts to the right spots all through, but was birdless. At this point Gizmo seemed to be the one to beat. It is the opinion of the reporter that the condition of the course hampered both dogs.

**Pio—  
Ferd's Concor of Leeway**

Down at 1:02, a good breakaway. Both dogs ran real well, good Derby races, well forward. Concor was a handful and a little hard to handle but comments from the gallery were that he was certainly out looking for birds. This was about the story until about 1:25 when Conky let down for three minutes. Pio was shorter than Conky, and just after pickup, pushed out a single bird and chased. In all fairness to Conky, he finished with a nice long cast and was called back to pickup.

**Mr. Sullivan—  
Tommy's Yankee Ned**

Mr. Sullivan was short to start, and checked in considerable. After they crossed the road into open, he stretched out and showed good application thereafter. At 2:02 handler called point; the dog corrected moved up hillside about 50 feet. Handler called point again which did not come under official observation. When the judges arrived, covey was in the air and Mr. Sullivan was chasing. Pickup time was right after this. Ned had a beautiful breakaway, made some of the nicest forward casts seen to date and an excellent forward race all the way. The only time that he got behind was when he went through heavy multiflora rose fence, was on the wrong side and had to come through. Ned showed the same good race throughout the entire 30 minutes.

**Pacolet's Captain Peck—  
Pacolets Bushbuster**

Broke fair, ran a fair race. Dogs were very similar in color. Shortened a little after the first 15 minutes. Finished same.

**Hel's Oklahoma Dream—  
Gladwin Tony**

Away at 2:45. Tony ran a fairly good Derby race, forward most of the time. At 3:06 he had a non-productive under



a little cedar tree and again at 3:11 a non-productive in honeysuckle. Dream ran an excellent forward race; made nice casts to birdy places, forward all the way. At 3:05 Dream pointed along the little hedgerow which proved to be non-productive. Both dogs finished strong.

**Pacolet's Flying Banner—  
Richmont's Rochette**

Breakaway at 3:17 was good. Gallery flushed a buck deer at 3:30. Both dogs cast way to the right, apparently chasing geese. This was a good course on which to show dogs, and both showed real well; ran forward with class. Pacolet's Flying Banner ran a little better, better gait and a little wider. Both dogs hunted well. No birds.

**Chien Fox—**

**Fredan's Interne**

Broke at 3:52, with both dogs showing well. After crossing to the wood and coming out in the open field, Chien and Interne worked to the left showing excellent casts. Interne came in but Chien stayed out and hunted the entire

left side in better-than-average Brittany casts. Interne came to handler, followed the road, and seemed to be less interested in hunting than Chien. This seemed to be the story throughout the entire thirty minutes.

**Mike's Rambler—**

**Vickki's Peggy of LaRue**

Broke at 7:25. At 7:30 judges rode up a covey at the approach to cornfield. Both dogs were well to left and not involved. Vickki came in and pointed where the covey had flushed. At 7:35 Mike's Rambler was picked up. Vickki ran a fair Derby race and at 7:44 had a covey find right in front of the gallery. She was real tight, crouched a bit, but had good Derby maners. Handler flushed the birds in front and Vickki gave a short chase.

**Lady Desire—**

**Dalmo Ace in the Hole**

Both dogs broke well at 7:55. At the end of the field at 7:58 Ace had a covey of about 20 birds. Dog was tight and showed excellent Derby manners. Handler flushed in front and the dog gave a short chase. At 8:07 Ace was working to left and the horse gallery rode up a covey. At 8:10 Lady Desire had a single; excellent manners, handler flushed in front. When started on, she had another single on which she was mannerly. At 8:11 Ace was working a covey; didn't establish point. Birds flushed and she chased. At 8:12 Lady Desire had one single; good Derby manners. At 8:14 Lady Desire pointed in the honeysuckle. Handler was unable to flush. At 8:15 as we crossed through into third field both dogs observed on point about 75-100 feet from each other. Both handlers called point, Lady Desire had a covey; Ace had a single. Both showed good Derby manners. At 8:16 Lady Desire had a single on which she was steady. Ace was at the same time working a covey on the hill, but reporter didn't see Ace point that covey (Reporter apologized, he could not see action of both dogs at this point). At 8:20 Ace's handler called point but when the dogs came under official observation, both were moving. By that time Lady Desire had joined Ace. Two separate coveys—about 30 birds total

flushed. Both dogs ran as good a forward course as would be possible with the number of birds involved.

**Buckeye Skipper—  
Way Kan Dinah-Mite**

At 8:34 Dinah had a find on a single right next to road. Handler did not call point but it was given official credit as point. Good Derby manners. At 8:44 Skipper had a non-productive just after we had passed through hedge. Then there was indefinite work immediately on top of hill. Handler fired over the dog, bird was in the air, dog was seen moving. At 8:45 Dinah went through a covey. Skipper at the same time was pointing another portion of the covey on which he showed all-age manners. At 8:45½ Skipper pointed where the other covey had just gotten up. At 8:55 after we crossed back into last field Dinah made a wide cast to left, way out on a limb and had excellent find with good character. After about 30 seconds she moved in and flushed a single before handler could

get to her. Both dogs were very wide, but appeared gaited.

**Belloaks His Nibs—  
Dingo's Sandy**

A 9:04 start. Both dogs fought the cover pretty good for Derbies. Sandy was lost at 9:10 after crossing railroad tracks. At 9:15 gallery kicked up a rabbit that ran right between Jane's legs. At 9:10 the horse gallery rode up Tom Lundsford's covey on which Nibs should have had an opportunity. Sandy was brought back, still within time and showed real well, but had no birds.

**Pittsburgh Gateway—  
Beauregard's Billy Boy**

Breakaway at 9:37. At 9:44 Gateway was picked up. Billy Boy at 9:49 had a covey next to railroad just after we were turning. Handler was trying to bring him around. He also won for owner Phillips the West Coast Amateur Trophy for the year. Tied for second place are DUC DE LA BRETAGNE and RENDEVOUS ELIAS. Both completed their championships this fall with 5 point wins. Duc is the first Nebraska champion. Elias is the third Britt shooting dog that Howard Clements has campaigned regularly. His Tennessee Luke was also an AKC champion and his first dog, Allamuchy Valley Luke was a pillar of the breed and blazed the way in all-breed trials before Britts were well known as a breed. It is good to see a man hunt his dog as heavily as Howard and then prove them in trials.

With 5 ribbons each the 3 girls—DWIGHT'S HALLOWE'EN SPOOK, BELLOAKS IBBY, and DINGO'S DINAH. PAUL'S WHITE FLASH now sports the title of Dual Champion and is the second Dual for the Sullivan's. SKYWOOD'S TANTIVY can also claim the precious F. T. Ch. prefix. GOVERNOR LEO finished in an Open Stake with 36 entries. BELLOAKS GUNNER'S four placements were all firsts. 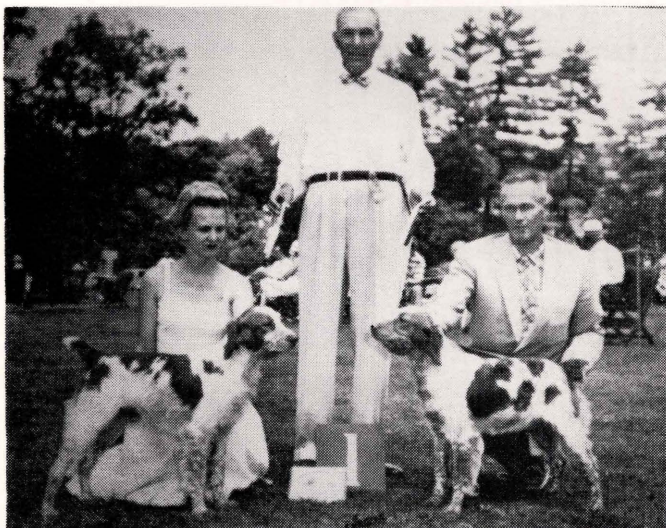

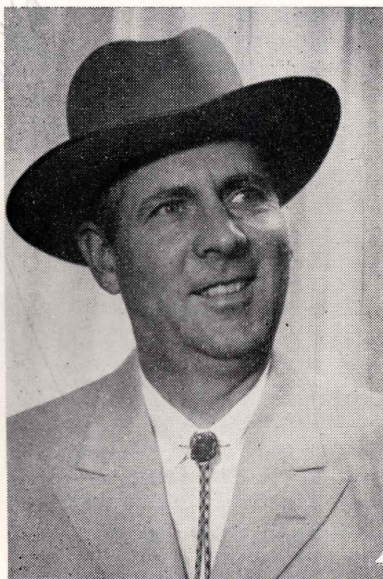

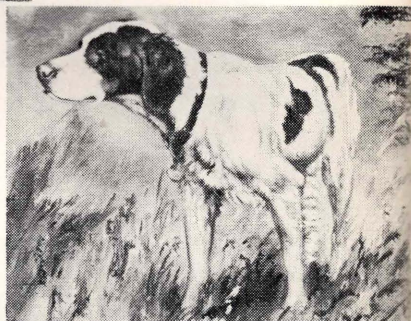
