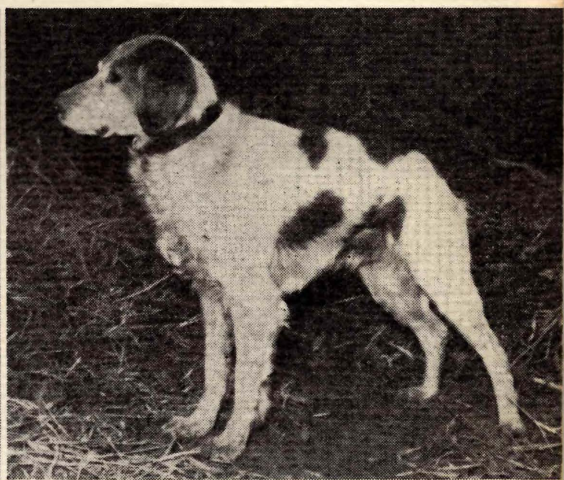
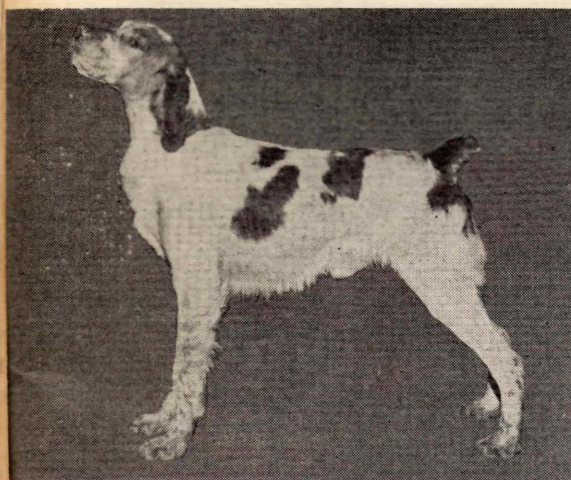

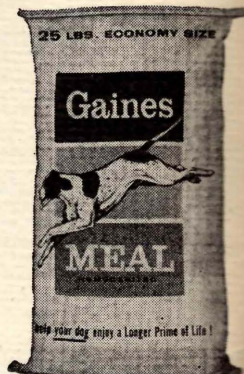

EDITORIAL

With this issue the American Brittany begins a new chapter in its long and turbulent history. We hope this will settle many of our problems. In order to let you better understand, let us look at some of these problems.

First, the American Brittany Club has grown until the demand for newsprint has tremendously increased. More field trials, increasing bench show activities, expanding organizational and administrative problems have all added to the reporting difficulties. All of this has coincided with an increase in printing cost.

Second, the increase in mailing cost occurring at a time when our magazine was becoming heavier each issue, making the total postage cost a substantial item in our annual budget. In order to decrease this mailing expense, we would like to mail under a second class permit, which will allow bulk mailing. To secure such a permit we must publish a minimum of four issues per year. Our thoughts then turned toward this plan, but soon someone suggested six or even eight issues a year. Finally it appeared that ten or twelve issues would be even better. It was felt that very little extra effort would be required since the deadline would not be so demanding. If an article missed one issue, another would be along next month. After special meetings of the officers and much correspondence, the following conclusions were reached concerning a monthly publication:

1. Better communication between national officers and regional clubs and members would result. This would greatly strengthen the breed and organization.

2. Advertising on a monthly basis would have real advertising value. Our ads in the previous issues have been only contributions. We hope these contributions will continue—we need and appreciate their support. Now we offer everyone an excellent advertising medium for their Brittanies well within your price range.

3. More interest in the futurity by

better publicity and explanation, especially to our new breeders. Eventually a good cash guarantee to the breeder of first place dog would be an even greater stimulant

4. More appeal to Brittany owners should stimulate increase in membership.

5. More appeal to members should help keep them on our active rolls.

6. Advanced notice of dues as published in the magazine will help regional clubs with their collections.

7. The monthly magazine would offer more current and up-to-date reporting. However it is of much broader scope than this. The many communications between clubs and individuals which have become so costly will now be published in the magazine. This will save time and cost—cost of paper, printing, and mailing—for it will be cheaper to insert a notice in the magazine than to make a special mailing. The annual presidents letter and election of delegates alone will save over \$200.

After receiving numerous bids from different printers, the bid of The Chilli-cothe Bulletin was finally accepted. This bid was in line with other bids and allows Ann and Fred White to assume the most important job of proofreader and advertising manager.

We will try this plan for one year. If all goes well, twelve issues will be published. If we find ourselves pressed financially, we can omit the two late summer issues. So much criticism resulted from the charges for pictures used in the magazine that this charge will no longer be made. This cost will be covered by the change in dues to the national (from \$3.50 to \$4.00 for each active member). So get us some good pictures of individual dogs that you would like to see in print. We will use all possible. This is **your** magazine. Your contributions, support and suggestions will help it serve you better.

SIXTEENTH ANNUAL NATIONAL TRIALS American Brittany Club, Inc.

A new National Champion Fld. Ch. Hellou's Yankee Timber, was crowned at Brittany National Trials held at Crab Orchard November 30-December 6th. Timber's owner is Bernard Neiberger of Meridian, Kansas, and he was trained, campaigned on the Brittany circuit, and handled in this biggest of all Brittany events, by Ralph Hessel-tine of Overbrook, Kansas.

It was a thrilling sight to see "Timmy" dig deep into heavy cover on that bitter cold Friday morning and locate his quarry. Plenty of pluck, plus the positive manner in which he pointed and his flawless manners on game, left little doubt in anyone's mind that "this was the dog." A superb performance is gratifying to judges and gallery alike in any trial. It is especially desirable in a stake of such prominence as the Brittany National Championship Stake. Little wonder then that the decision handed down by Judges George R. Sharpe, Carrollton, Michigan, and Curtis Miles of Cleveland, Ohio, naming Fld. Ch. Hellou's Yankee Timber the Champion of 1958, was received with thunderous applause!

Timmy's trophies, to carry home to Kansas for a year, consist of the bronze Brittany statue (Alan R. Stuyvesant Trophy) and the Walter B. Kleeman Memorial trophy. A sterling silver replica of the Kleeman Memorial Trophy will be his for permanent possession.

Equally thrilling was the performance of Fld. Ch. Ferdinand of Leeway to win the National Amateur All-Age Stake. This is the second time Ferdinand has won the Amateur. He did it in 1956 when his owner, John W. Lee of Indianapolis, Indiana, handled him. A year ago, handled by Mrs. Lee, he placed third, and this year it was again the distaff side of the family who had the thrill of trailing Ferd in his van-

guard of glory. However, were it not for "sharp eyes" in the horse gallery (Namely Dr. Carroll Conklin of Marion, Ohio) a spectacular covey find of Ferd's might have been overlooked.

The incident recalls a similar experience in 1956 when it was Ralph Hessel-tine, spotting Fld. Ch. Jeffrey of Argard lost on point in hedge, that contributed to that magnificent Brittany's win of the National Open Stake. Since Brittany trials are conducted with handlers on foot, and periscopes are not allowed, handlers are grateful indeed to the sportsmanlike help from those high on a horse. A stylish back, and another find by Ferd deep in thicket (again brought to attention by the horse gallery), added luster to the class race laid down by Fld. Ch. Ferdinand of Leeway.

Louis E. Tippet of Portland, Oregon and Amos Greer, Gladwin, Michigan, Brittany owners and handlers themselves, were the popular judges of this event.

The Amateur All-Age Stake, first in the trial of Brittany events in the week-long National Trials, has grown in size and quality over the years. In 1951 when the late Ray Machlett of New Canaan, Connecticut presented a sterling silver rotating trophy for the winner, to encourage greater participation by amateurs in running their own Brittanys in the Nationals, there were only 16 dogs entered. In 1958, owner-handlers who had qualified 33 dogs by virtue of placements in Brittany Regional All-Age events, set a new record.

This year also saw the greatest number of women handlers (8) who had the additional incentive of trying for a leg on the Belloaks Ginger Memorial Trophy awarded to "the best dog handled by a woman amateur handler." When Ferdinand was the announced

winner, the James B. Bells of Palm Beach Florida who presented the trophy in 1954 (Mrs. Bell won the National Amateur Stake in 1953) promptly announced that the win would also retire the present Ginger Trophy, and they would put up another in its place.

All of the four placed dogs in both the Amateur and the National Championship Stakes were A.K.C. Field Champions of Record. Dingo's Little Mike has the added distinction of being a Dual Champion. When Mike went "Best of Show" at the Brittany Specialty Show on Saturday night, and then took a red ribbon in the Amateur Stake, it was almost a foregone conclusion that he would be unchallenged to the claim of "National Dual Dog." However, Towsey was "Winners Dog" at the Show and he could exceed Mike in points should he gain the Championship title. Hence there was keen competition right up to the end as to who would be the recipient of the Dual Award.

Both Dingo's Little Mike and Towsey are fine Brittany specimens, carrying out the high purpose of the American Brittany Club "to strive to keep the Brittany forever a Dual dog."

A quick glance at the list of starters in the National Championship Stake shows that more than half are already Field Trial Champions. Since only "finished" Brits placed in 1958, it is apparent there could—even now—be a further limiting qualification for running the National Championship Stake. Had it been open only to A.K.C. Field Trial Champions, the outcome in 1958 would have been the same.

Brittany Nationals don't just happen. They are the product of a long year of planning on the part of committees. The 1958 Nationals actually began exactly a year ago at 1957 Nationals when Jack Secor of Niles, Michigan, President of the American Brittany Club, appointed Charles W. Morse as Field Trial Chairman. Mr. Morse's duties, in addition to scheduling all Brittany Regional trials so there would be no conflicts in the four major circuits, included organization of committees etc. preparatory to National Trials.

Mr. Morse asked the following to be Chairmen of Committees:

Field Trial: John W. Lee.

Specialty Show: Henry Holleyoak.

Trophies: Marcelle Bell.

Reporting: Ruth Lee.

Photography: Jack Bradley.

Hosts: Jack Secor, President, American Brittany Club and Ruth Secor.

The decision was also made a year ago to hold the 1958 Nationals (for the ninth consecutive year) at the famed Crab Orchard Wildlife Refuge, Carbondale, Illinois.

Since the member clubs of the national American Brittany Club are now divided into Regions, and there are nine individual clubs holding trials in the Central Region alone, it meant once again the National Trial would come very late in the fall. An unusually balmy autumn suddenly gave way to winter's ice and snow just about the time Brittany folk from the far flung regions of the United States were journeying to Carbondale. Air-line strikes hampered participants from Washington, Oregon and California, but when the opening day arrived, Sunday, November 30th, a count of noses showed representation from 16 states of the Union, and from 21 of the 29 Regional Brittany Clubs!

The Field Trial Committee responsible for conduct of the trial, was likewise "national" in scope, and with one

exception every member of that committee was on hand throughout the week to assist the Chairman, John W. Lee of Indianapolis, Indiana. Members of this committee were the following:

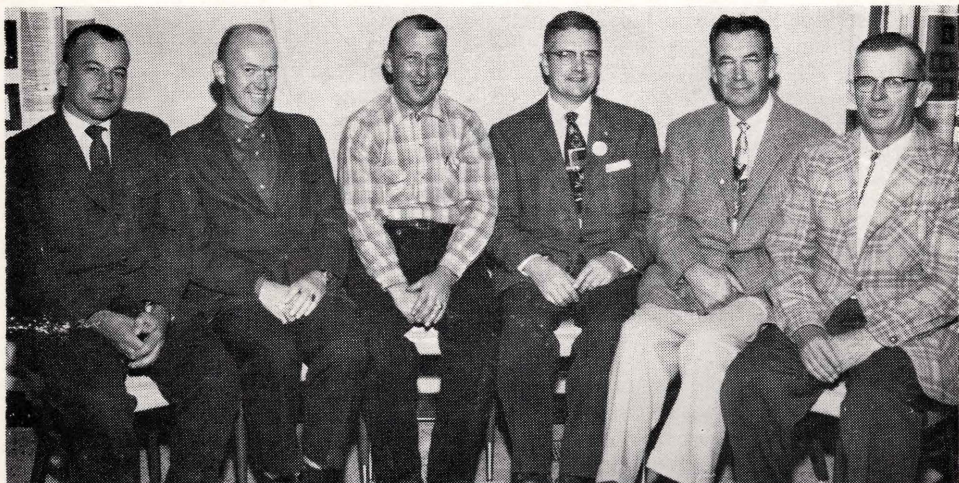

But with the best of intentions, Brittany boosters would make a "bust" of running trials at Crab Orchard if they did not have help from the host club, The Crab Orchard Field Trial Club. Especially this year were Brittany fans indebted to Ike Brandon, Secretary of the Crab Orchard F.T.C. who came out on the first morning of the trial to consult with Tom Lunsford, marshal,

and lay out courses best suited for running the 45 minute heats of the Amateur Stake. Ike then doubled as judge with Roy Sharpe for the Brittany Futurity (reported elsewhere), and stayed on to see that the courses for running the National Championship Stake were satisfactory.

The quail crop was a bumper one this year at Crab Orchard, but growing conditions were also ideal, so much of the territory used for multiple-course Brittany Nationals in past years was unsuitable. However, there is so much running area available at Crab Orchard, it did not take Ike Brandon and the marshal, Tom Lunsford, long to come up with satisfactory arrangements. For the most part the courses were evenly matched as to open area in which to show a big-running dog, along with plenty of objectives and fringe thicket areas bordering lespedeza fields.

With good course layouts, and the knowledgeable marshaling of veteran Tom Lunsford, it would seem all factors had been reckoned with. But one re-

mained—the uncontrollable weather—and it acted up maliciously! On two mornings for the big National Championship Stake not only was there snow on hard frozen ground, but a bitter wind from the northwest made it almost unbearable to exist in the saddle. All of the horse gallery would have preferred to have the marshal keep them moving with the wind behind them. But Tom was determined to do right by the little Brittans — take them to where he knew there were birds—and sure enough he did! It was a grueling test for the little Brittany, or any bird dog for that matter, to go out and find birds under such disagreeable conditions. But because enough of them did, and did it with style and class to boot, the Brittany National trials this year were hailed happily as “most successful.” Once again, the loudest cheers are for ice-covered F. T. Ch. Hellou's Yankee Timber, who ran his race and found his birds when the weather was at its very worst. If ever a Brittany earned a National Championship, Timmy certainly did in 1958!

Equally as hard as the Brittany were the breed of judges imported to Crab Orchard for these trials. For many years George R. ("Roy") Sharpe has been most accomodating in fulfilling judging assignments at various Brittany Regionals. It was a courtesy long over-due to ask this popular arbiter of field trialing to come to Crab Orchard for the Nationals. But no one knew when Roy agreed to judge both the Futurity and the National Championship Stake that the Futurity would attract 64 starters, and thus it would mean five long days in the saddle for him. There was nary a word of complaint, however, from this rugged soul from Saginaw.

When Curtis Miles, Cleveland, Ohio

telephone to ask whether the unseasonable snowstorm would mean a postponement of the trials, and was told "No, the Brittany's run in all kinds of weather," he might have thought that was an idle boast. But he came to find out that was true, and his two and a half days of judging the Brittany National Championship were bitter cold reminders that it can be just as disagreeably cold at Crab Orchard as when icy blasts buffet Cleveland. Grateful indeed were all the Brittany people, but especially the Field Trial Committee, that these two fine gentlemen asked no favors but stuck by the grueling task of naming a National Brittany Champion.

was likewise unfamiliar with trials "run in snow" even though his partner, Amos Greer knows nothing but snow for much of the year in northern Michigan. Coming from widely separated sections of the country, these two strangers at the start found their common interests of training and campaigning field trial dogs, made their judging assignment a mutually happy experience. Their rapt attentiveness to the job at hand brought many favorable comments from the amateur handlers.

AMATEUR ALL-AGE STAKE

Brittany Nationals at Crab Orchard always commence with the Amateur, and always more quail are counted on the first day out than ever after. This year's running was no exception, despite the fact that snow covered the ground on Sunday, November 30th, when the first brace was set down. Sun warmed things up a bit as the day commenced, but it was not until the second days' running of the Amateur that definitive birdwork which netted placements were recorded.

First brace out on Monday set a high standard when Fld. Ch. Yankee

Boy's Tommy running a well applied race, encouraged birds and was credited with a stop to flush as gallery rode up the hill and found him standing. Later discovered on point in woods, Tommy's performance. His style on the considerable time it took his handler-owner, John A. Costelow of Hoyt, Kansas, to reach him. An additional covey find directly in front which handler flushed, indicated it would take a whale of a dog to beat Tommy's performance. His style on point was beautiful to behold. Tommy was started along his training by Thomas W. Cox, and "finished" by Ralph Hesseltine, Overbrook, Kansas.

Then in the next-to-last brace of the stake, tension mounted. As bracemates Fld. Ch. Ferdinand of Leeway and Dual Ch. Dingo's Little Mike raced away, reaching for the limits yet handling readily, it was at once apparent that "class" races were being laid down. Would these two also come through with class birdwork? Dingo's Little Mike was the first to come across birds; in high weeds he was seen standing where birds had lifted. Coming out of heavy stuff and into open, Ferdin-

and went into high gear as he streaked up an open field to edge and worked the area forward all the way to draw. Mike elected the nearer multiflora fencerow, but both disappeared as the course turned. Some five minutes later Ferd was seen on point, a good 100 yards away but not far from the spot where last seen heading up the draw. Handler raced down the hill to rout birds for him with Ferd never relaxing a muscle. Meanwhile, Mike dove into honeysuckle and came up with a covey; just a few minutes later he again styled on point with brace mate honoring stylishly. Mike's handler executed the flush and shot for both dogs who clearly showed they understood their roles full well. Dingo's Little Mike pinned a single in multiflora coming out of the honeysuckle. At close, Ferdinand was lost on point in thicket that proved, on relocation, to be another single.

Judge dismounted on this find and breasted the briars with handler to reach him. Ferd's performance was marred by an unproductive at edge of cornfield (geese tracks visible in the mud), and retrieve to handler of a crippled quail. But in the estimation of the judges those blemishes were minor compared with the tremendous exhibition of class running, knowledgeable hunting, and beautiful styling both in pointing and backing his brace mate.

Others with creditable performances, and all-age manners to flush and shot were: Fld. Ch. Belloaks Gunner, Vickki of LaRue, Paul's White Flash, Dual Ch. Duchess of Holley Haven, Dual Ch. Helgramite Tarquinius, Fld. Ch. Skywood's Tantivy, and Lady Ball de Mac-Eochaidh. Running of the Amateur was concluded late Monday afternoon, December 1st.

BRACE-BY-BRACE ACCOUNT—AMATEUR

**Fld. Ch. Belloaks Gunner—
Vickki of LaRue**

Both of these were about equal in running and ground pattern; good shooting dogs. Gunner pointed a covey; Vickki backed right behind and almost simultaneously. Perfect manners for both although Gunner turned to watch birds take off. 5 coveys counted.

**Fld. Ch. Rendezvous Elias—
Fld. Ch. Saxon of Fredann**

"Pete" had two unproductives; very stylish on second. Sax backed on sight at first; on second refused, even on command. Races of both these two exceeded those of first brace.

**Mitzi—
Paul's White Flash**

Flash ran an exceptionally good searching race; Mitzi started strong, slowed to end. Four coveys seen. On the first when gallery arrived Mitzi was seen coming out of region. Second covey was a short distance further on in open field with Paul's White Flash credited with stop to flush.

**Dual Ch. Duchess of Holley Haven—
Fld. Ch. Duc du la Bretagne**

These two were evenly matched, running good races and hitting all likely spots. Duchess established point coming into wooded area. Handler failed to produce. Duc was lost on point in honeysuckle along side of road. Handler finally reached dog and fired as one single flushed. Duc stayed and more birds were flushed. Real nice work. After road crossing at edge of thicket Duchess had stop to flush of large covey.

**Ch. Penny's Happy Pepi—
Helgramite Shamandre**

Ten minutes after the breakaway, Pepi retrieved a goose. At 25 minutes Pepi was seen standing; lead horse of gallery walked up covey of birds in front of Pepi. Handler did not see birds and did not shoot. Shamandre ran the larger race, hunted well and was deep in cover, lost for about 4 minutes near "Clem's corners."

Fld. Ch. Buttons and Bows—
Fld. Ch. Gladjoe's Pride

"Gregg" ran exceptionally well, very wide to the edges and went deep into cover. Buttons ran a forward race. No birds.

Tommy's Papillion Sue—
Rebecca of Minnehaha

Both ran short races. At 25 minutes birds were seen ahead of judges and gallery in high cover. When they arrived, both dogs were moving. Sue got off on deer for about 5 minutes; Ted Cwik headed her off in good shape.

Dual Ch. Belloaks King—
Sir Mo-Lay

At about 5 minutes down King jumped a deer and the deer in turn jumped a large covey of quail. Mo-Lay stopped on side of hill as though on point; meadowlarks. Just before road crossing, large covey lifted; the second such game opportunity. Going around woods King charged into thicket, chased one bird; stopped on flush of second.

Fld. Ch. Yankee Boy's Tommy—
Fld. Ch. Jefferson of Minnehaha

Tommy ran a forward race, well applied but medium range. A covey of birds were seen to flush over hill and when the gallery rode up, Tommy was seen standing on point at edge of woods. He was shot over and then sent on. At about 30 minutes Tommy was off to right in woods and discovered on point. As handler was going through fence to reach him, the birds flushed way ahead of Tommy—15-20 yds. Tommy remained steady until handler could get to him and send him on. With about 7 minutes remaining, Tommy pointed by a rail fence and handler flushed a covey of birds about five yards ahead in honeysuckle. Again showed perfect manners. Tommy looked beautiful on point.

Jefferson of Minnehaha ran fairly well, but had no contact with birds.

Dual Ch. Helgramite Tarquinius—
Ch. Brit's Tic Toc Bobby

Both dogs ran the same type of cautious race. In a hedgerow Brit bumped a covey. Very shortly after that in same hedgerow a covey flushed

ahead of gallery; both dogs were moving in the area when gallery arrived. Tarq pointed and held a covey in honeysuckle shortly before pickup; also had an unproductive.

**Ferd's Miss America—
Fld. Ch. Skywood's Tantivy**

Shortly after breakaway Tanty charged into woods at left and disappeared. Gone for about 5 or 6 minutes, but came back on road. When Tanty's followers had caught up with rest of gallery, Miss America was being picked up; she wouldn't run. Tanty stopped at edge of honeysuckle. Handler worked hard for birds but only a rabbit ran out. Later in swale Tanty had a covey find and was mannerly.

**Fld. Ch. Joey of Hunterhaven—
Lady Ball de Maceeahaidh**

Joey ran a fairly applied hunting race. Had a point on strung out covey along ditchbank and handled it well. Then Joey moved forward and pointed a single and had two stops to flush on same strung out covey. Lady busted a covey along road, then later on deep in honeysuckle, had a find and was steady. Lady's race was quite close. On her find she was literally buried in the honeysuckle and had to be lifted out.

**L'Etoile de Dingo—
Holliday Britt**

Both bracemates ran fairly well. Britt's race was more forward. L'Etoile ran to the side and deep in cover. Britt bumped a covey and later had an unproductive out in open field.

**Sue's Jim Dandy Jigger—
Holley Haven Dan**

On a cast to left, Dan raised some meadowlarks. Handler fired. Later on, quail were seen to rise from hedgerow and again handler fired. Dan was moving when handler reached him, but then Dan did have a covey of birds, and though they flushed wild, he was steady. Mary Sullivan, Jigger's handler, brought from California a novel call, likened by the gallery to "a melancholy fog horn on a lonely night." The high point of this brace was when Rose

Szubiellak discovered her husband in the gallery and threatened him with bodily injury. Jigger had no birds.

**Dingo's Dinah—
Fld. Ch. Uno's Rex of Paradise**

Both dogs ran well. Rex was off on deer for six minutes shortly after breakaway. Dinah had unproductive shortly before pickup.

**Fld. Ch. Ferdinand of Leeway—
Dual Ch. Dingo's Little Mike**

Both had good races with wide-going casts; Ferd having a bit of the edge on range. Birds flushed in high weeds; Mike was found standing steady. Ferd seen on point a good 100 yds. from gallery. Stood steady to flush and shot; a beautiful, gorgeous find. After this, going up hill, Ferd came to handler with retrieve of a quail. Around honeysuckle Mike had a good covey find, was sent on, and immediately had another covey find which Ferd honored. Turning them south, Mike had another find on single. Ferd had non-productive at swale at edge of cornfield. Geese tracks. Just before pickup, gallery again saw Ferd standing way off in thicket on point. Handler was unable to flush. Ferd relocated and handler flushed a single quail; Ferd steady to flush and shot.

Dual Ch. Belloaks Ibbey

Running as a bye, was rather restricted, an average shooting-dog race. At about 5 minutes judge called handler's attention to dog making game. Ibbey made a circle, birds flushed, and Ibbey stopped. Just before pickup on a relocation Ibbey got too close; stopped as birds lifted.

NATIONAL CHAMPIONSHIP STAKE

Two and a half days of running were required for sizing up the potential of the 64 dogs entered in the Futurity, so it was not until Thursday afternoon that the National Championship Stake, (one hour heats)) got underway. Only Brittans who had formerly placed first or second in an Open All-Age stake at Brittany Regionals are eligible to compete for the "National Championship" title, and the starters included the best from every Region of the country. There was Paul's White Flash and Punch of Paradise from the West Coast, seven East Coast Region winners, thirteen from the Midwest Region the great plains states, and an even dozen from the Central Region—Michigan, Illinois, Indiana and Ohio.

When one looks back over recent Brittany National history, it is dramatically apparent that Brittans from the Great Plains have been successful in winning the National Crown. Towsey in 1955 was followed by Jeffrey of Argard, then Towsey again in 1957. Hellou's Yankee Timber is the third National Brittany Champion to come from the prairies to the "Little Egypt" section of Southern Illinois, look for quail, and go home wearing the crown! Is this just happenstance, or does it mean that the far-stretching plains are conducive to developing the muscle and stamina needed for the competitive hunting of a field trial dog? Is it that breeders of Brittans in the Plain States are developing a superior product? Whatever the answer, it is a fact that Brittans from Clubs in the Midwest Region have more than held their own at recent Brittany National trials.

Certainly snow on the ground and skittish quail the first day, followed by warmer temperatures with feeding quail on the second day, had a lot to do with the outcome of the Amateur stake. But this variation in tempera-

tures and quail scenting conditions was as nothing compared to the fluctuations experienced in the Championship Stake. Drizzling rain on Thursday turned to snow overnight and the temperature fell sharply. Friday morning's climate was so severe as to warrant the remark "You were beaten by the weather before you even put your dog down!" Nothing much was recorded except grim stoic expressions on faces in the gallery, until Hellou's Yankee Timber made his bid. Then suddenly frozen features began to thaw and eyes lighted up as they watched this magnificent Brit, just as cold and miserable as they (he was covered with ice), forge ahead through thickets to find what he was looking for . . . quail.

Only an experienced quail dog could know that on such a morning the quail would be in hiding—deep. And only a Brittany with a rugged constitution could stand the punishment that Timmy took. Such dauntless courage, and finish on game when he was found on point in heavy cover, made everyone in the gallery feel like taking off their hat in tribute when Timmy completed his hour's exhibition. (Only of course they didn't dare—it was too cold!)

Saturday's early morning conditions were about the same; frozen ground and bitter temperatures. Towsey on the first brace Saturday, as Gladjo's Pride in the first brace Friday, made the most of their bad break in drawing this first brace of the morning, and ultimately were called back to run a second series.

However, quail cannot go two days without eating, and as Ol' Man Sol finally warmed things up late in the morning on Saturday, the birds began to move out. Rendezvous Elias, named to second place was able to show his prowess both in locating feeding birds, and finished manners by honoring brace mate. While lacking the

range, the speed and the punch of Hellou's Yankee Timber, Rendezvous Elias, or "Peter" as he is affectionately called by his proud owner Howard Clements, Chicago, Illinois, left little doubt that he knew the quail hunting alphabet from A to Z. Pete has made an enviable record this past year in Brittany Regional trials with eleven placements, including firsts in the open at Michigan and Pennsylvania, and a first in the Amateur last Spring in Indiana. Pete owes his training to Lee Holman, Whittington, Illinois, who handled him in this event.

At lunchtime on Saturday—the last day of the trials—there were great expectations. That sun was really warming things up. Those quail would really be on the move in the afternoon, and there were some powerfully big Brittans to go. Anything could happen, and anything *did* happen. Right after lunch when Freckles VII and Ozark Chieftain were set down, it took about 12 minutes before they settled down to hunting and started chalking up covey finds and singles with such rapidity the scribe ran out of white space on the page! However, it was Chief, running as big as the country would allow, that caught the attention and eventually netted him a third place. Owned by Dr. A. J. Blair of Troy, Kansas, he was handled by first-place handler, Ralph Hesseltine.

And then came disaster. "Pride runneth before a fall and a haughty spirit before destruction". If Ferdinand of Leeway was overly confident because of his win in the Amateur, he soon saw he had a top-notch challenger in his bracemate, Belloaks Highflyer. Just a minute after they were released, these two came charging back along a draw neck and neck, and while there was some speculation about a covey

lift along that draw, there was a clean-cut deliberate chase of a single when Ferdinand, full of steam, went up hillside. As though to make doubly sure no doubt remained he then returned, pointed momentarily, and routed the rest of the covey with all the gusto of a Derby! Needless to say, handler snapped on the leash after a very contrite dog returned when bidden to the spot, and pointed. Though Ferd lasted only three minutes, Highflyer took a little longer to erase himself from contention in much the same manner, but less flagrantly than Ferd.

As previously mentioned, Gladjo's Pride and Towsey were called back to run, giving their first-series running exhibition the benefit of better scenting conditions, should they seize the opportunity. Gladjo's Pride, running wider than his bracemate, went through a covey and stopped to flush. Towsey was working at edge of brushline when birds were seen to lift. No point was called, but Towsey was observed standing. As soon as these two were picked up, gallery returned to the stables where a decision was handed down immediately.

The brace by-brace account which follows is the product of Field Reporter, Richard L. Culbert of Sioux Falls, South Dakota. Dick is another stalwart soul who with the judges and marshal rode every brace, reporting to the "Press" his observations at the conclusion of each brace. It is apparent some creditable performances were rendered (in the order of their running) by: Jefferson of Minnehaha, Belloaks King, Punch of Paradise, Tommy's Yankee Ike, Buddington Prince, Skywood's Tantivy, Helgramite Tarquinius, Dingo's Little Mike, Duc du la Bretange, L'Etoile de Dingo and Britton's Kipo.

BRACE-BY-BRACE ACCOUNT—NATIONAL CHAMPIONSHIP STAKE

(Reported by Richard L. Culbert)

Fld. Ch. Jefferson of Minnehaha Dual Ch. Belloaks King

Breakaway at 12:07. King had a point in fiirst field; non-productive. After passing through fencerow there was some indefinite work. When brought under official judgement, Jeff was seen fussing in roadway, King went in front of him. When birds were in the air, both were mannerly to gun. King roaded up on covey find; mannerly; Jeff stopped on command. At 12:37 King pointed in a fencerow; Jeff backed, Dogs sent on and when Jeff's handler walked up two birds, King stopped on command. At 12:47 Jeff roaded and locked up on covey on hillside. Good manners. 12:57 Jeff started roading along hedgerow; birds were seen to get out, considerably ahead of dog and he continued moving. Both races were restricted with Jeff a little on the outside, starting slow but hunting better during the second half.

Tommy's Papillion Sue Punch of Paradise

As they broke away, Sue was running a forward race but rather limited. Punch ran much wider, but presented a little difficulty at course turnings. At 30 minutes Sue pointed, moved, flushed covey and chased. At 39 minutes Punch's handler called point; brace-mate did not honor and went through birds. Punch broke, but stopped on command. Sue was picked up. At 50 minutes Punch pointed into honeysuckle, moved up as handler attempted to flush; unproductive. At 55 minutes Punch hit a feediing covey hard. Handler bird flush in commendable manner, showing good form on his birds.

Tommy's Yankee Ike Fld. Ch. Buddington Prince

These two broke away in heavy cover with Ike being a little wider and the outside dog. As time went on, the rain increased in intensity. At 40 minutes Prince pointed and Ike moved along

in front of hedge and established point independently, with both pointing well into the wind, Ike's handler was unable to produce, but gallery reported seeing birds go out as horses approached.

Britt de la Fontaine Vallee Fld. Ch. Skywood's Tantivy

At three minutes point was called for Britt in heavy cover; he showed clean manners on covey. At seven minutes point called for Tanty when he swung into the wind; Britt honored. Birds were flushed all around Tanty. As the last went out, Tanty turned to watch their flight. He continued hunting in an attractive manner with high head, but slowed appreciably at mid-way. Britt evidenced a little reluctance to handle and was picked up upon reaching road. At 52 minutes point called for Tanty; handler unable to produce.

Fld. Ch. Gladjoe's Pride Major of Valley Forge

Thursday's rain turned to snow overnight and when the fiirst brace Friday morning broke away, snow blanketed the frozen ground, and the temperature was well below freezing. So the quail apparently were driven into heavy cover. In spite of this, both brace-mates laid down good ground heats, but bird work was at a premium. At 15 minutes, both dogs headed into wind were observed making game and a large covey flushed wild out of heavy honeysuckle thicket. Both continued hunting hard without further bird contact.

Beaucoup Becky of Richmond Palcoet's Whist

Again the snow on ground, freeziing temperatures, and bitter winds made this a disagreeable brace to follow on horseback. It was just as disagreeable for the Brits who showed distaste for the snow. At 38 minutes point was called for Whist in the timber which Becky honored. Whist's handler was

unable to produce birds. Dogs continued to hunt but slowed noticeably the last twenty minutes.

Dual Ch. Helgramite Tarquinius
Fld. Ch. Hellou's Yankee Timber

At seven minutes down, Tarq was making game around the edge of a heavy briar patch and finally pinned his birds. Handler flushed two birds; Tarq showed commendable manners. In the meantime, Timmy had become lost and finally found on point in the heavy cover. He had a covey well located and showed perfect manners. The dogs continued to hunt hard, with Tim being the much wider dog, reaching out and hitting all objectives and likely cover. At 57 minutes handler called point for Timmy who was locked up on a covey in multiflora hedgerow beside road. Once again Timmy showed perfect manners. He finished strong, going away.

Toward the latter part of hour, Tarq roaded bird into cover, finally pushed it out; stopped to flush.

Fld. Ch. Joey of Hunterhaven
Helgramite Shamandre

Joey hunted hard all the way, but found no birds. Shamandre, at 18 minutes out, started winding and making game. As we headed from field to brush, handler tried to call him off because geese had lifted from the area just recently. However, Shamandre went straight through the goose-scent area and locked up at edge of brush. It was a very commendable find with good manners.

Shamandre ran a limited race. At 20 minutes down, his handler called point for dog at edge of the multiflora hedgerow. Unproductive, and again at 49 minutes he was found on point in a big briar patch at bottom of draw; unproductive.

Belloaks Leo—
Fld. Ch. Sooner Ranger

As they broke away, it was apparent Leo was much the wider dog, but showed a reluctance to handle. At 24 minutes Leo ran right through a covey of birds, chased, and was picked up.

Sooner Ranger ran a very restricted race. At 26 minutes he was working

birds but point was not established when birds got out immediately in front of dog; credited with stop to flush.

Dual Ch. Dingo's Little Mike—
Shawnee's Hellou Fancee

At three minutes down, there was a divided find; birds flushed in front of both dogs with both handlers firing. At 10 minutes Mike had a stop to flush and sat down on covey. At 15 minutes

Mike's handler walked up a covey; both dogs were in the general vicinity but neither had contact. At 30 minutes Mike feathered in on a covey and stacked up near rail fence. It was a good clean find. A short time later Mike walked right through a covey and as it went out he continued moving. At 34 minutes judge rode up a single; 37 minutes marshal flushed single. At 38 minutes Mike was making game when off to one side a covey was ridden up.

Fancee's race was restricted; a typical shooting-dog pattern.

**Fld. Ch. Saxon of Fredann—
Fld. Ch. Duc du la Bretagne**

On the first portion of this brace, after breakaway, Sax was the wider. At 12 minutes gallery rode up covey; neither dog involved. At 17 minutes as gallery was topping a rise, a covey was seen to flush from the draw directly ahead. Both dogs came in from the right; it was evident neither dog had had contact. Sax pointed at the spot where covey flushed; handler unable to produce any strays. At 27 minutes Duc had a commendable covey find and then Duc stretched out and reached wider for objectives. About this same time Sax showed signs of tiring. At 52 minutes, Sax was fussing, making game on widely scattered covey on hillside; charged with stop to flush. Sax then went on and pointed where a single had been seen to flush. At 55 minutes Duc's handler called attention to Sax standing in high cover. Point was called but nothing with feathers was produced.

Just before pickup Duc made a long forward cast along fencerow and encountered the trail of a deer which was seen by gallery crossing through the area. Duc responded readily to handler and kept his attention on hunting for birds.

**Fld. Ch. Towsey—
Holley Haven Lucky**

Saturday broke clear and cold with the mercury at 17 degrees when the first brace was turned loose. Both dogs were hunting the cover well, and at 19 minutes Towsey was observed making game across in front of gallery along fencerow, going directly into wind. With

one big jump he landed right in the middle of a covey, wheeled and stopped to flush. Towsey's race was wide and forward. The only times he came from behind was when the course turned and he was off completing a cast in likely cover. Midway through the brace Holley Haven Lucky shortened up. Both dogs slowed toward the end.

**Paul's White Flash—
Fld. Ch. Yankee Boy's Tommy**

Both dogs broke well and hunted hard with Tommy always on the outside. At 26 minutes Tommy whirled and pointed into the wind with his head high. Flash came in and honored. In spite of intensive efforts on part of handler, birds were not produced, and Tommy sent on. The snow on ground was covered with quail tracks showing evidence of recent game. At 55 minutes point was called on Flash stacked up in honeysuckle; again unproductive. Both dogs finished strong.

**Fld. Ch. Governor Leo—
L'Etoile de Dingo**

At five minutes down, Leo's handler walked up a covey in an area traversed by Leo some time before. Dingo came in from the side and was active in the general vicinity. At 35 minutes Leo had unproductive which Dingo backed. At 37 minutes point was called for Dingo deep in brush. Handler flushed a covey and Dingo showed acceptable manners. At 53 minutes Dingo had unproductive; he started slow but warmed up after seven or eight minutes and ran a good hunting, but not a class race. Leo ran to the outside but slowed noticeably during the last thirty minutes.

**Britton's Kipo—
Fld. Ch. Rendezvous Elias**

At 8 minutes down, Kipo swung into point momentarily and Pete honored on sight. Kipo corrected and went on. At 9 minutes Pete had a very stylish find on edge of brush and Kipo honored. It was a good big covey that got out on both sides of the brush; both dogs mannerly. At 14 minutes Kipo had a find on single directly in front of gallery; straightened up a bit as the birds went out. At 53 minutes Pete was making game at edge of ditch. The birds flushed out of multiflora giving

Pete a stop to flush. Just before pick-up, Pete's handler called point who relocated twice and handler flushed a large covey. Pete took one jump as the birds went out and stopped at command.

**Freckles VII—
Ozark Chieftain**

At three minutes a covey flushed wild in front of gallery; neither dog involved. At 5 minutes gallery rode up another covey and at 11 minutes Freckles had an unproductive. 12 minutes Freckles had a good find on covey; Chief was credited with a back—he did not see the other dog, was whoaed to stop. At 18 minutes Chief had stop to flush on single. At 7 minutes Chief stacked up on point and Freckles, not seeing him, came in and pointed part of the same covey. Neither dog saw each other. Chief's handler came in and called it and both handlers fired as the birds went out. The birds were located directly in front of Chief and on all sides of Freckles who sat down on point. At 40 minutes Chief pointed, relocated, stopped as the covey flushed. Then at 41 minutes Chief had a good covey find. Freckles had a stop to flush at 52 minutes and find on feeding covey on hillside, at 58 minutes. Chief ran as big as the country would permit, and

made final find on singles near the road where gallery waited for pickup. Freckles ran a much more restricted race.

**Dual Ch. Belloaks Highflyer—
Fld. Ch. Ferdinand of Leeway**

Immediately after the breakaway and with both dogs flying out across country, they were called back to make draw crossing and came charging down along draw engaging in a race when covey flushed from draw. It is doubtful whether either dog saw the birds, so intent were they in out-running each other. Coming up hillside, Ferdinand

bumped a single quail, chased it, and then swung back to rout the rest of the covey and chased. He was summarily picked up, just 3 minutes after being set down. At 9 minutes High had a stop to flush. Handler went in front to flush and the dog softened. Another single went out from the same area. At 20 minutes High had another stop to flush and then, away out on a limb, bumped some birds.

The large group of people in attendance expressed their approval of the plans to increase magazine publication, circulation, and general activities.

Hellou's Yankee Timber was bred by Mr. Dale Johnson, and is by Yank's Rebel (he is from Tudor's Yankee Boy), out of Bonne Bergere. He was whelped March 10, 1954, and I have had him since he was nine months old. He is orange and white and lightly ticked. Timmy completed his championship at the Missouri Trial on March 3, 1957. He had three derby firsts, won the Illinois Spring Trial February 25, 1957 (a four point open), then completed his championship the next weekend at the Missouri Trial with another four point win.

Timmy had 17 wins prior to the 1958 Nationals. We didn't run Tim last year after the Nationals with the exception of the Ringneck Spring Trial in which he went second in the Open all-Age. He wasn't run this fall until the Nationals. I am sure that people in our area are familiar with the dog, and also with my comments on him. They would tell you that I have always remarked that Timmy was the easiest to train Britt I have ever worked with. He has an excellent nose, and even as a young dog was always serious in his hunting manners. I certainly hope I have the good fortune in getting another like him some day.

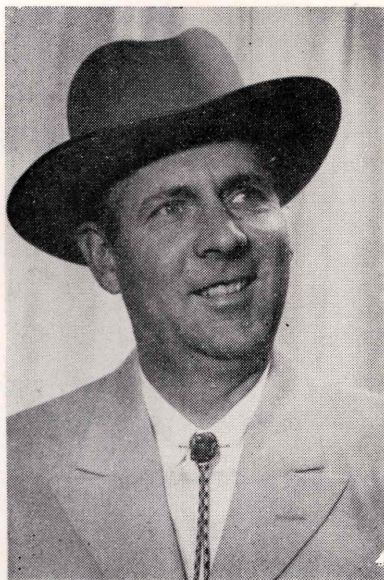
