



#### NORTH JERSEY BRITTANY CLUB

The North Jersey Brittany Club held its annual spring trial at the Collier Mills Public Shooting Grounds on April 11 and 12. Enjoying one of the most successful trials on the Eastern circuit this year, the members of the club wish to thank all those who participated to make this a very good trial. Although marred by inclement weather, rain Saturday and rain changing to snow Sunday. Everyone concerned thought the judicial chores were handled superbly by Jack Fitzpatrick of Belmar, New Jersey and Jack Farren of Lakehurst, N. J.

#### OPEN DERBY

With the beginning of the Puppy Stake Saturday morning, and numerous puppies there were, John Dall, "The Birthday Boy" brought in Rosehill Mike to take top honors. Mike ran a very wide puppy race and handled nicely when asked to do so. John Dall also took second place honors with Ponkapoag Bearcamp Tim. Tim ran a hunting back course and cut up the bird field thoroughly. Brittchesters Way-Kan ran good Puppy Race and although marred with a unproductive, proved she had nose for birds. Kaymores Joe of Weymouth with Phil Morehouse handling took fourth place honors. Out of twenty-five puppies entered, it was a nice win for Rosehill Mike.

#### OPEN ALL AGE

Immediately following the Puppy Stake the Open All Age got underway and in the first brace, Pacolets Whist, owned by W. T. Davis and handled by Phil Morehouse proved he was the dog to beat. Whist ran a wide race in the open and had three good birdfield finds with good manners. Although his performance was marred by an unproductive, Whist's work was above all others in this stake. Cherrystone's Alla-

muchy Tim owned and handled by Bob Fitzgerald, club president, ran a limited race and before entering the birdfield had one of the most stylish finds of the day on a wild pheasant. Tim showed perfect manners and this was enough to earn him second place honors. Kaymore's Connecticut Yankee handled by Phil Morehouse, ran a very wide race for the first half of his course but slowed down upon entering the birdfield. However, Yankee had one good find, and stopped on command on a flushing bird. Jacques of Kaymore, handled by Phil Morehouse ran a fair race and had one find being steady to wing and shot to take fourth place honors. Three were fifteen entrys in this stake.

#### OPEN DERBY

Sunday morning began looking like the haze and drizzle would disappear, but before the day was over, more was to come and than some. Getting underway bright and early in the Derby Stake, which showed some nice bird work and also big running Brittanies, Pepper's Jet, owned and handled by Thad Cwik ran the class race of the stake and also pointed and chased a pair of quail to take top honors. Jet

showed at the right places at the right times in his back course sprint to gain the judges nod over some very good derbies.

Although only ten entries were in this stake, it was a very good stake from a spectators viewpoint, barring the weather. Rapid of Richmont, handled by Bob Burbank, ran a thorough searching race, had one birdfield find and chased to his hearts content. The third and fourth place dogs were braced together. Belloaks Jim Bell, handled by Phil Morehouse and Pompton Falls Patches, owned and handled by Jack Rockwell, field trial chairman placed third and fourth respectively. Jim Bell had one good find, coupled with a nice Derby race and Prompton Falls Patches had a nice find at the edge of the birdfield which he chased wholeheart-

As Sunday wore on and the Amateur All Age stake got underway, scenting conditions became poor, and quail planted in the bird field got up and walked around as if taking a Sunday stroll. Rain changed to snow and dogs coming into the birdfield were charged with unproductives through no fault of their own.

#### AMATEUR ALL AGE

In the final brace of the day Hel-Gramite Shamandre, owned and handled by W. E. Stevenson, ran the class race of the Amateur Stake and coupled two good finds to take top honors. Shamandre's win also finished him off as a champion. Helderberg Misty, owned and handled by Herbert Marr, ran a very good race and stopped to flush to other dogs bird. Just before pick-up time, Misty had a nice find at edge of birdfield which she stopped on command when bird flushed. Poupee Homme Brittany, owned and handled by Lew Dollman, ran a good shooting dog race and kept busy throughout the back course. She had one find upon entering the birdfield and moved at wing but stopped on command. No fourth place was awarded.

The North Jersey Brittany Clubs fall trial will be held at the Flatbrook Tract, Bevans, N. J. and club members are sponsoring a Richard Christman Memorial Trophy for the Amateur All Age stake. This trophy will have to be won three times by the same owner or twice by the same dog to be retired. Club members are sincerely hoping that all who attended our spring trial will attend our fall trial and bring friends along too.

The Spring Field Trial of the Southern New England Brittany Club, Inc. was held at Helgramite Hollow in Brewster, N.Y. on May 2nd and 3rd. The Puppy and Derby Stakes were run on the property of Dr. F. W. Birkman; the Open and Amateur Gun Dog Stakes on that of Mrs. R. R. Machlett. Quail were used and were, unfortunately, poor-flying in general. Despite dire predictions the weather was fine. A fire on the other side of the Western hill brought smoke, a fire engine, and a tinge of apprehension on Sunday afternoon; but the fire companies had everything under control very shortly.

Dinner Saturday evening was held at the Deer Inn, Brewster, N.Y. The chief trophy event was the retirement of the Machlett Memorial Trophy by Dual Ch. Belloaks Highflyer, who won it for the second time in the Open. Highflyer belongs to J. M. Bell, Jr. of Palm Beach,

Fla., and was handled by Phil More-house of Salem Depot. N.H.

Again there were four bench champions in the twelve placements in the last three stakes, showing that the Brittany Club objective of keeping the Brittany a Dual dog, is still being adhered to. They were: Dual Ch. Belloaks Highflyer; Dual Ch. Kaymore's Connecticut Yankee; Dual Ch. Belloaks Ibby, and Dual Ch. Wippy de la Vallee Bourrault.

Judges for the trial were Mr. J. Fitzpatrick of Belmar, N. J. and Mr. Blair Crowell of Chappaqua, N. Y. The members of the Club wish to thank them both for their services.

#### PUPPY STAKE

#### 14 Dogs

Sunny Ledge Mike, owned by G. Stavrow of Keene, N. H. and handled by Cecil Parker, also of Keene, won first place with a very good race. He hit cover well, and found two birds.

Kaymore's Sittin' Britty, owned by J. L. Senior, Jr., and handled by Phil Morehouse also ran an attractive race, showing good style to place second. He had two finds.

Third place went to Meester's Wippy II, owned and handled by A. Meester of North Haledon, N. J. This dog ran a nice forward race, making several good casts, and had one find.

Lord Jeff of Helderberg, T. H. Rogers of New Canaan, Conn., owner and handler, placed fourth with a good race and a find.

The Puppy Stake showed some fine prospects.

#### OPEN ALL AGE

#### 18 Dogs

Dual Ch. Belloaks Highflyer, J. M. Bell, Jr., owner, Phil Morehouse handler, took top honors in this stake with a wide active race. He had a steady find which he pointed from about two

Third place went to Kearson's Ponkapoag Sparky, owned by R. T. Lyman, Jr. of Boston, Mass., and handled by J. A. Dall of Warner, N. H. Sparky ran a big wide race, and had one find.

Dual Ch. Belloaks Ibby, owned by Mrs. J. M. Bell, Jr. of Palm Beach, Fla. and handled by Phil Morehouse, took fourth place with a good race and one perfect find. Ibby showed good manners on a poor-flying bird.

#### DERBY STAKE

King of Highbrow, E. Facer owner and handler, ran a nice forward race with two finds and one unproductive, to come in fourth.

Those chosen to judge the winners were Ed Nixon, Flint, Emory Hajos, Hemlock, George Roy Sharpe, Carrollton, and Howard H. Crippen, Dearborn. Not since 1955 have we had snow, and so much of it, and below freezing temperatures. But no Brittany is going to let these things stop him from running in a trial. Also, this was the first time we had used quail at our licensed trial, and everyone was very pleased with the bird work.

#### OPEN ALL AGE

Judging of the 24 Open All Age entries was done by Emery Hajos and George Roy Sharpe. First place winner was Dingo's Little Mike displaying his widely known talents with a very good ground race and three finds and a back. Second was Skywood's Tantivy with a nice ground heat and three finds. Third place was Holley Haven Dan with three finds and good bird dog work. Fourth place was Beau de Campbelle, who worked close and had three nice finds.

#### OPEN DERBY

Judging the 13 Derby entries were Howard Crippen and Ed Nixon. First place winner was Pacolet's Sam, with two finds and a very good consistent hunting race. Second place was Gladwin Smokey who hunted hard all the way and had one find. Third place went to Major Monte with two points in the bird field. Tarq had a very good ground heat hitting the likely cover, had one unproductive point and a nice point on a running bird in heavy cover, handler did not see the bird go out but the judge did and told him. Tarq was sent on and had a point on a dead bird which handler threw out and fired, Tarq was steady to shot.

Sunday morning everyone was on the grounds early but there was a delay due to a horse coming up lame, another

race with style, he was birdy and
showed discrimination between
places where birds had been and

finds where he made flash points

He hunted industriously, handled well and made a good point on a running bird in a hedge row at edge of bird field.

course with an excellent pattern. He had three finds in the bird field in which he was mannerly but spoiled his chance for first place by crouching on the flush.

The balance of the puppies had a lot of fun with the mice, and from the number devoured I'm sure some of them will never want to see another mouse again. All in all they were a very nice group of prospects.



#### OREGON BRITTANY CLUB

The bird score was high with Beau having four pointed birds and three stops to flush. One of Beau's finds on a covey of quail was particularly meritorious. The auto gallery was able to see three of his finds clearly, including the last one where handler lost his gun while on way to the dog on point. Third place went to Ch. Gaard's Sweet Wil-

The puppy stake followed. Top dog was Teddy Speckle Feather, a flashy little dog that covered a good deal of ground. He showed himself to be plenty birdy with both songbirds and gamebirds. Moebee Dick is small but very flashy and showed plenty of birdsense. He had several near contacts with game. The second place dog was Joiner Js Candy, who is also a nice mover. She contacted two birds and had a called point. Handled by Elmer Flack and owned by Sid Joiner. Lund's Trooper was third. He ran a nice race and pointed a bird but

lacked his usual zip. He was handled by owner Lund. Evergray's Tic Toc Tommy was fourth. He is owned by Grace Metzger and is handled by Everett Metzger. He looked good.

The amateur stake wound up the bill. The winner, again, was Beau Kiki. This time the birds were about impossible to pin but Beau worked one way off to the side and finally pinned it by the side of the main road. He lacked the fire he had his first time round. The rest of the dogs did not do themselves too proud. Birds were hard to handle, difficult to find, and no performances were up to what you knew the dogs could do. Old Dual Ch Evergrays Tic Toc Bobby came through with a stop to flush for second, handled by owner Everett Metzger. 



## CENTRAL NEW ENGLAND BRITTANY CLUB

The Central New England Brittany Club was blessed with excellent weather and entries for their annual spring trial which was held at the Division of Fisheries and Game field trial area in Westboro, Mass. on April 25 and 26. This successful and smoothly run affair points up that dividends accrue to organizations that carefully plan and execute their trials. Mr. Thomas Ott, the capable field trial secretary found many willing hands to help him with his duties, which he carried out admirably. The success of the event owes so much to so many that a well done to all is in order.

Mr. and Mrs. James Bell were affable hosts at a cocktail party before the banquet, roast pheasant no less, which was held Saturday evening, after the first days running.

The field trial course was in excellent

condition with plenty of water on the course and adequate ground cover in the bird field. The course is a combination of wooded cover and fields and it really tests the versatility of a bird dog. In some places a dog must reach across open fields to hedge rows and cover while in the wooded areas he can hunt a pattern more conducive to this venue. The Brittany was equal to the task.

Judges for the four stake, 61 dog, program were Herb Lambert of Haverhill, Mass. and Charles Phil Fogg of Newbury, Mass.

#### OPEN PUPPY STAKE

#### 15 Entries

Ponkapoag Bearcat Tim, running as a bye, racked up sterling honors for his handler, John Dall, in this stake. Tim has a consistent and energetic way of impressing on the back course; once cast away, this pup was all business. He climaxed his race with a nice find in the bird field which he held with impressive character until bird was put to flight.

Sunnyledge Mike, handled by Cecil Parker, was bothered some on the back course by his bracemate who introduced himself in puppy fashion. Mike soon got down to business despite a trailing barcemate and ran a good consistent race which was capped with a typical puppy find in the bird field.

Kaymore's Sittin Britty handled by Phil Morehouse, lacked some of the consistency of the two dogs placed over her; however, when she was working she showed an intelligent pattern which carried her to all the likely bird cover. Her lone bird field find was of high character.

Duke of Brittchester, handled by Bob Burbank, started slowly but improved with every jump. Moving with graceful class he breasted most of the likely cover on the course. A tendency to back away from his bird, on one of his two finds, as his handler approached detracted, or this dog might have been higher in the stake.

Rose Hill Mike, high up in this stake really makes one wonder about the advisability of running puppies on birds. Mike, who was handled by John Dall, ran a very intelligent race, reaching to all the likely cover around the open fields. Each cast carried him someplace and yet he fell to the fate of the bird field.

#### OPEN ALL AGE

#### 15 Entries

There certainly was no shortage of entries in this stake and yet it was a lack luster affair. Dogs which ran reasonable races either suffered breaches of manners or could not be shown on birds.

Heldeberg Misty, handled by Herby Marr, easily topped this affair with a likeable forward race and three finds in the bird field. A tendency for Misty to move in on one of these finds detracted but little from her overall superb performance.

Helgramite Tarquinius, handled by W. E. Stevenson, garnered second place honors with a good race and a single find with all age manners.

Jig de Kaymore, handled by Phil Morehouse, ran a fair back course race; coming into his own in heavy covers and moving well in the bird field he came up with one good find. A second bird contact in which Jig volitionally bumped his bird could have removed him from consideration under more ideal circumstances.

Helgramite Shamandre, handled by W. Stevenson, really moves around. This dog displayed plenty of bounce in his moving but could have applied himself more intelligently to the cover. His actions in the bird field were not exemplary having three stops to flush, all into the wind, and one point on which the dog lost character with the approach of the handler.

Kaymore's Conn. Yankee, handled by Phil Morehouse, easily ran the most impressive all age race in the stake. Yankee moves with effortless grace in a hard driving forward pattern that is bound to impress whenever he is put down. Here is a dog that adjusts to his cover and hunts each area as if he knew no other, be it open fields or tight woodcock runs. Yankee, however, had a sticky unproductive on the edge of the bird field on which he was overly insistent.

#### OPEN DERBY STAKE 10 Entries

Although this stake was deficient in the top notch derby bird work there was no shortage of good races; as

Brittchester's Rickrack really won this stake in a big way, for his handler Wynn Wood. Rickrack covered a wealth of ground in an intelligent and forward manner; handling kindly at every turn moving forward into the most likely looking cover Rickrack ran to the limits of the course. In the bird field she pointed her first bird in advanced puppy fashion, moving in to cause the flush. After a lusty chase she was returned to the bird field where she proceeded to bump two more birds.

Kaymore's Joe of Weymouth, handled by Phil Morehouse, garnered second place honors. This Brittany with the setter head, affectionately known as "Bucket Head" showed that he knows where to look for birds. Running the entire edge of the open fields, swinging back to test the pheasant scents, left us no doubt that this brainy dog can find his own birds. Once in the bird field area Joe moved five birds handling only one of them in accepted derby fashion.

Sunnyledge Mike, handled by Cecil Parker, showed less maturity than the first two dogs but ran a good puppy race with two bird field finds to win

Rapid of Richmont, handled by Bob Burbank, won fourth place honors with a fair race, that lacked some in consistency, and two bird field finds.

#### AMATEUR GUN DOG

21 Entries

This stake was the most hotly contested of the entire program with many dogs showing wares that could easily garner honors in many events. Naturally the issue of a gun dog versus an all age dog reared its ugly head. This is always a difficult issue to resolve unless the judges can agree before the event what standards they are going to apply.

Kilroy, handled by Dave Story, running as a bye dog in the first brace set a standard for all other contestants. Starting slowly at the breakaway, Kilroy warmed to his task and ran an acceptable back course race. Although his race was not electrifying, it was an honest effort which led him to a spectacular back course find on a run-

ning pheasant. After a well executed relocation, the find was carried out with aplomb. In the bird field Kilroy, in workman like fashion, racked up finds on quail displaying polished manners.

Britt de la Fontaine Valley, handled by Herb Farnsworth, ran one of the better races of the entire stake. Moving with independence but handling with ease this dog really went bird hunting on the back course; a quest that was rewarded with a well executed back course find on a quail. In the bird field area Britt handled two quail in a classy and intense manner. Her nemesis was a pheasant which she moved in on and bumped, stopping at command. This detracted from an otherwise sterling performance.

Jig de Kaymore won third in this event for his handler, Al Weigel. Jig's placement was primarily won on the basis of his bird field work, as his back course race while acceptable lacked in consistency. His one bird field find was thrilling to all; as he nailed a quail far out on a limb and waited patiently and intensely for his handler's approach.

Belloaks Gunner, handled by Dick Fox ran a good forward and industrious race. Gunner ran wider than most of the dogs placed over him but he handled effortlessly. In the bird field Gunner had a mannerly stop to flush on a loose flying bird and one well executed find.

Many dogs are worthy of mention in this stake but those that were pressing the winners most strongly were Helgramite Tarquinius and Duchess du Juchoir.

#### BELLOAKS GINGER MEMORIAL TROPHY

Ch. Belloaks Ginger, winner of the 1953 National Amateur Stake, was killed by a rattlesnake while hunting quail in Florida with Jim Bell, husband of the owner, Marcelle Bell. Shortly after Ginger's untimely death, Marcelle and Jim Bell announced the establishment of a trophy as a memorial to this little champion.

The Belloaks Ginger Memorial is a trophy for the ladies. It is to be awarded to the best dog handled by a woman in the National Amateur Stake. At least three entries handled by women must participate or the trophy will not be awarded that year, unless a dog handled by a woman amateur places in the stake. With three or more entries handled by women the dog does not have to place in the stake in order to win this trophy, but the judge will be asked to signify which dog handled by a woman did the best job.

#### WEST COAST AMATEUR TROPHY

The West Coast Amateur Trophy is offered on an annual basis. Placements in AKC point trials held by Brittany Clubs in Washington, Oregon, and California are counted. The trophy is a large shield set in a wooden base. On the shield are placques for each winners name. Each winner also receives a small placque that he is allowed to keep.

The trophy was donated by the Bissels of Juchoir Kennels to foster more interest in Amateur Stakes, and to induce more individual owners to attend all the trials in the West Coast Circuit.

Only purebred Brittanies are eligible and only regulation point Amateur Stakes count. Each dog receives one point for every dog he defeats, and points are awarded to all four dogs that place. In the event of a tie the tied dogs are rated 5 points for every first, 3 for seconds, 2 for thirds, and 1 for fourth in order to break the tie.

Dogs do not need to be owner han-

dled, and need not be owned on the West Coast. The handler must be a bona fide amateur (that is having never handled or trained dogs for pay.)

Permanent possession may be retained by winning the trophy three times. Any changes in the conditions of award may be made by a committee of the presidents of the participating clubs.

The trophy was offered for the first time in 1958 and was won by Beau Kiki, owned and handled by L. Phillips of Castro Valley, Calif. with 104 points. The remaining dogs in close contention were Sir Ted (Dr. Johnson) with 48 points, Dual Ch. Ouragan Jerry's Bob (Frank Gilbert) with 40 points, Lancer of Richmont (Jim Gosnell) with 33 points, and F.T. Ch. Mon Ami Michael (Dave Neitzel) with 30 points.

For the first half of 1959 the leading contender is Beau Kiki again with 47 points. Buena Vista Beau (Mac-Whorter) is second with 29.
