



The Annual Dog Writer's Association Awards Dinner was held February 8, 1959, in conjunction with the Madison Square Garden Dog Show. ## TO ALL MEMBERS OF THE AMERICAN BRITTANY CLUB, INC.

At the recent business meeting of the American Brittany Club held at Carbondale, Illinois, there was considerable confusion and apparent misunderstanding of the status of Directors and Delegates.

The Constitution of the American Brittany Club under Article III, Section

1. provides that:

Section 1. The association shall be governed by a Board of Directors consisting of five Directors elected by the membership at large, and one additional Director from each of the Regional Clubs. Number of Directors so elected to be determined entirely by the number of Regional Clubs affiliated with the association at the time of the annual meeting. The Board of Directors shall have the power to approve all regular committee chairmen and the personnel of committees, make regulations and issue instructions and in all other ways conduct the business of the Club. Members of the Board of Directors can recommend changes in the Constitution and By-Laws to be approved by the membership at large.

The Constitution also provides under

Article V, Section 1:

Section 1. This Club shall be governed by a Board of Directors elected by the membership at large, and one additional Director from each of the regional clubs. Each regional club shall elect a Director to represent the club on the Board of Directors, the number of Directors so elected to be determined entirely by the number of regional clubs affiliated with the American Brittany Club at the time of the annual meeting, the elected representatives to take office at the first meeting of the Board of Directors following the annual meeting. All members of regional clubs shall have the privilege of voting for the five Directors at large as well as the individual directors elected by each regional club.

Article II of the By-Laws provides: Section 9. The term of office for the Directors elected at large shall be for three years. Starting with the year 1950, the two receiving the greatest number of votes shall be elected for three years, those receiving the third and fourth greatest number of votes shall be elected for two years, the fifth greatest number of votes shall be elected for one year. As these terms of office expire, the succeeding election shall be for three years.

#### **Election of Regional Directors**

Section 10. The term of office for Directors elected by Regional Clubs shall be for one year. Election shall be by vote of the members of each regional club.

At no time does our Constitution refer to a "Delegate." However, in the By-Laws of the American Brittany Club under Article V, Section 6, reference is made to a Delegate as follows:

Section 6. Delegates may represent this Club at meetings or other places where such representing might prove helpful. Delegates may be one or several persons but no person shall represent the Club officially unless appointed by the President and approved by the Directors or members, nor shall any delegate have the power to make agreements or bind the Association without approval of the Directors.

A simplified interpretation would be that the American Brittany Club is governed by a Board of Directors consisting of five directors elected at large, the balance of the board to be made up of one director from each Regional club. The officers are elected by the board and must come from its entire body.

The delegate, as provided for in the By-Laws, would be a person or persons designated to represent the Parent club wherever necessary.

It seems that the Constitution and By-Laws of most Regional clubs provide for a delegate to represent the individual clubs at the annual business meeting. Somehow, this has been construed to mean that the Regional delegate can act as a director to represent his club on the board of directors if the elected director of his club is not present. This is not the case and can only be rectified by each of the Regional clubs electing a director to the board of directors to the American Brittany Club prior to the annual business meeting each year. The names of the elected director should be sent to the Secretary of the Parent club at least 30 days prior to the busi-

ness meeting, and if a delegate is elected or appointed to represent his Regional club at the meeting, his or her name should be sent the Secretary also.

I sincerely trust this clarifies the matter and that we can look forward to full representation on the board of directors by having a director from each Regional present at the next business meeting.

## IN MEMORIUM TO "JUNIOR" GWENNEC DE PASCEY II

Never heard of the Brittany Spaniel Gwennec's Pascey II? Well, you would have if you had been a Brittany enthusiast back in the days of about '48-'49. At that time, (April 12, 1948 to be exact), he was proclaimed by Brittany judges Rene Joubert and Paul Dawson to be "the greatest Brittany they had ever seen in a field trial."

"Junior" was not campaigned extensively in Brittany trials—just two or three in a season—but still he made his field championship under three years of age and accumulated fifteen wins out of 32 Brittany trials. In Pointer and Setter trials he made the boys sit up and take notice of a Brittany for he had 16 wins out of 31 starts!

Handling of Junior holds some glorious memories for me. One, which I'll never forget, was when we were braced against "Lancrest Farmer's Frank" handled by my husband, John. When we entered the birdfield it was a real Razzle-Dazzle, with total finds being: Lanny 5 finds and 4 backs; Junior 4 finds and 5 backs—all in five minutes and no mistakes! Oh if that Brittany's legs had been a little longer!

He was a great little dog and the smartest Brittany I have ever seen. He was whelped June 9, 1945 and owned by "Tommy" Thompson, Detroit, Michigan. Died November 16, 1958 of dropsy.





#### BADGER BRITTANY CLUB

The Badger Fall trial was held over Necedah Wild Life Refuge grounds, a vast area of flatland with native grasses and lowland brush and trees for cover. Wildlife consists of pheasant, quail, and geese by the hundreds. (Badger Brittanys should do well at Crab Orchard!) Bow and arrow deer season opening the same day of the trial brought a large gallery; enjoyable weather, but hot and dry for the dogs.

Two gruelling days were put in by judges T. D. O'Connor and Carl Lindstrom of the Twin Cities for there were 36 braces to run. Lunch was served by the ladies of Badger Brittany under the guidance of Rand Constalie.

#### OPEN ALL-AGE STAKE

Governor Leo topped twenty-three contenders with one near perfect find. showing great intensity. A second find for Leo required relocation. Skywood's Tantivy had three birds flushed on the back-course, steady to wing and shot, and backed on command. Tiring when he reached the birdfield, he chalked up another bird, again steady and well-mannered. Riviere Valley Suzette ran a tighter course but on her one find was steady to wing and shot. Texann's Sye, named to fourth, ran an excellent course and handled well but lacked finish on bird-work. Rumarel of Aberdeen laid down a good heat but was birdless.

#### OPEN DERBY STAKE

Jip of Siouxland was easily the outstanding dog, running an excellent backcourse, doing a good job of relocating, and chasing lustily. Cork's Copper Brandy showed an intense desire to hunt, was intense on point, and showed an equally intense desire to chase. Pin Oak Guy showed style on point for his three finds but was perhaps overcautious in the birdfield. Pacolet's Pollyann had a fair back-course, two con-

tacts with game, pointing her second bird nicely and chasing merrily.

#### OPEN PUPPY STAKE

Rujohn Rip showed desire and used the wind advantageously, quartering well on the backcourse and had two finds, on one a beautiful point. Judges for all four stakes were Thad Cwik, Flemington, N.J. and Bob Aldinger, Rochester, N. Y. Ernie Facer, Field Trial Secretary expedited the 73-entry trial in his usual capable manner, while much of the success goes to Marshal Perle Trumble.

Weather was good for dogs and handlers alike at the start of the trial; cool with a light breeze and scattered clouds overhead.

#### Puppy Stake

Gladwin's Smokey, running in the second brace out, literally tore the course apart and showed that he knew what he was out for by his birdy manner. Smokey set a standard that a good many all-age dogs would have trouble bettering.

Macc of LaRue had a very good ground heat and added a find in the Birdfield for second-place honors. Brittchester's Calamity Jane had a good race and was very birdy. Pacolet's Mike II had a good ground heat, highlighted by several good casts.

#### Open All Age Stake

Our Michigan guests dominated this stake also, capturing not three, (as in Puppy), but all four places in the Open.

Fld. Ch. Joey of Hunterhaven was the winner on the strength of his excellent race plus a well-handled find on a moving bird.

Fld. Ch. Benjji of LaRue in second place, ran well on the backcourse and had a perfect find in the birdfield.

Third place was earned by Dingo's Dinah for her creditable ground heat and a well-handled find. Fld. Ch. Hero's

Master Spot ran a good race and had a nice point in the birdfield, but chased a few steps at flush.

#### Derby Stake

Four braces of the Derby Stake were run Saturday following completion of the Open; the remaining were run Sunday morning.

Gladwin's Smokey came back to cop the top honors in the Derby Stake. He ran an even bigger, harder driving race in this stake than he did in the Puppy and added five finds, three of which he pointed like an all-age dog. Here was clearly the top performance of the stake.

Passamonte's Slick Chick had a very good back course coupled with two very well handled points in the birdfield. Third place was taken by Ferd's Hobo Jake who ran what was probably the biggest race of the stake. Because of his extreme range he was somewhat hard to handle. He had one find in the bird field.

As the last braces of the Derby were being run, a cold rain began to fall, making for rather less than ideal conditions under which to run the Amateur Gun Dog Stake.

#### Amateur Gun Dog Stake

Winner was the perennial winner of Gun Dog Stakes, Fld. Ch. Belloaks Gunner who ran an excellent gun dog race and had a pair of perfect finds in the birdfield. Brit de Buster annexed second place with a very good back course and two well-handled finds. Dingo's Dinah, third in the Open, repeated in this stake. She ran well, and had one find handled perfectly. Helderberg Misty had a good backcourse and find in tough cover.

#### OREGON BRITTANY TRIALS

The club was fortunate in securing four able and experienced judges. The job was made doubly difficult because of the heavy cover and large number of birds on the grounds. The judges were: Ben L. Furie, Lulu Island, British Columbia; Al Evans, Portland; Bill Edgerton, Vancouver, British Columbia; and Gordon Walker, Independence.

#### OPEN ALL-AGE

Paul's White Flash, owned and handled by Dr. J. M. Sullivan of Berkeley, Calif. Won first with a driving race and five well handled finds on pheasant and one on quail. Flash hit the right spots and gave his handler a busy half hour and several anxious moments.

Second went to Dual Champion Evergray's Tic-Toc Bobby with four nice finds on pheasant, one after an excellent re-location. Bobby's ground pattern was good and he pointed with good intensity and style. A couple of steps on a bird that refused to fly and that ran between his legs probably hurt his chances for first.

Beau Kiki placed third with three solid finds on pheasant and three stops to flush in heavy cover. Beau hit the heavy cover with courage and had his work in the heavy cover been more



#### BRITTS VS. OTHER BREEDS

This column will be devoted to a much neglected field this issue, the competition of Britts with other breeds. The American Field recognizes many of the regular AKC Brittany trials and it also recognizes a good many trials devoted to all pointing breeds. In the first 6 months of 1958 there were 127 or more Britts entered in competition with other breeds in FDSB recognized trials. Of these 21 were in the ribbons.

The 21 wins were divided into 8 firsts, 9 seconds and 4 thirds. The stakes were eleven open stakes, nine amateur stakes and one stake open to members of that particular club only. There were 14 placements in shooting dog stakes, 5 in all age stakes, and only two in puppy and derby competition.

There were no outstanding winners except that Towsey and Dingo's Little Mike each accounted for two places while all the others had a single place-

ment.

As open all age competition is stiffer than any of the other stakes it might be worthy to note that up to this season only 4 Britts had managed to top an open all age breed stake. This spring we had two first place winners, both on the West Coast. Beau Kiki annexed a first in the Pacific German Pointer Club and Gaard's Sweet William won the Washington State Clubs trial. As both these dogs were owner handled the honor is indeed greater.

A new trend seems to be opening in some parts of the country. Some of the AKC trials previously open only to one breed have been opened to all pointing breeds. It makes for interesting competition for those sponsored by the Shorthair people of the shoot-to-kill variety. It gives everyone a chance to meet new people and compete with new dogs and exchange new ideas.

A new record has been established. Buttons II, tho he has never won an all age stake in a Brittany trial is an AKC champion of record. He won two all age stakes in Shorthair trials, and did a fine job for our breed.

This mixing of breeds is proving a fine thing in those parts of the country where trials are scarce. For example in the Northwest where previously there were only two Brittany trials (AKC) each season there are now 6 AKC trials open to Britts. These include two Shorthair trials, an English Setter, a Pointer, and the two mentioned Brittany trials.

There are now two championships recognized by the FDSB in Britts. One is the Nationals, won by Towsey in 1957 and the Michigan Grouse Championship won by Benjji of LaRue. There is no official naming for such a combination of championships but now both dogs are double champions (both AKC and FDSB).

The proof readers have discovered a new field trial term in the Nebraska Regional write up. Such terms as "Steady as a rock," "Staunch" and "Locked up" are familiar ways to indicate the steadiness of a dog on point, however, we are curious about the derivation of "couldnt stand hitched when the bird went out." Does this go back to the horse and buggy?
