The dog is completely owner trained and handled. His finds showed a good deal of style. Second was Pete's Rock and Rye Duval who did a good honest workmanlike job. Third was also an owner trained and handled dog, Chapman's Mandy of Troy. She showed well on birds, but was a bit limited in her race. Fourth went to Jacques Bon Ami whose pheasant way of going always attracts.

# Open Derby Stake

Heavy cover on the back course cut the range of many of the derbys and most were to winded to locate birds. Juchoir's Harpo, handled by Nicky Bis-

# SECOND NATIONAL BRITTANY GROUSE CHAMPIONSHIP

You can truly appreciate the calibre of this stake when we tell you that we could have named any of three dogs champion out of the total of fourteen entered. This was our greatest judging pleasure. We had a Grouse Championship and make no mistakes about it!

#### CHAMPION and RUNNER-UP

Our winners ran in the last brace when the discussion had been that the number one and two courses should be eliminated for having no birds. The champ was Star Boy, owned and handled by Jim Freeman of Ann Arbor, Michigan. Patsy, owned and handled by Ralph Gardner of Pontiac, Michigan won Runner-Up recognition. Completely complimentary to each other, splendid brace sped off at dusk to probe the sides, investigate all likely cover, and to show steady class and determination. They crossed over, streaked when necessary to come front from side casts, and, nearly always in sight, worked diligently. They backed, they had class and determination, but most of all, they required little handling. Star Boy completed a cast down a steep hillside and had a beautiful stand at 28 minuites. He stood there like a king with high head and character. Patsy came in to head-on back. Freeman flushed three birds, one at a time and fired after each. Star Boy required only a small caution on the first bird. Racing away at full speed Patsy had a dandy find at 39 minutes with excellent manners. Star backed well cut to left. Shortly after a big doe ran directly across in front of both dogs, not more than twenty yards out, both dogs stopped instantly at command, were sent on and resumed hunting strongly until pick-up. What more could one ask?

The entire trial was quite a contrast to many grouse trials where big wide dogs are turned loose in the woods accompanied by much hollering and whistling and of course, either no bird work or mere incidents. Take it from us, that "ain't" the way it's done boys! There's grouse in "them thar woods," but you're not going to find them with all-age dogs and "hootin and hollerin".

# THE RUNNING

# Benjii of Larue and Britt:

A two time winner of this event, Benjji started slowly but steadily gained for a good, forward-searching heat; Britt ran a slashing race, perhaps the outstanding effort in the stake for 21 minutes, then opened the deer season.

# Gladjoe's Pride and Chips Beau Brummel:

Although somewhat restricted, Chips still made a good, steady hunting effort; handler flushed a large cock grouse at 33 minutes and a sleeping deer at 51 minutes. Firey Gladjoe's Pride stayed forward and driving, well ahead to 27 minutes. As he slid to a point, bird left and handler was instructed to fire over dog. Neither dog gave concern for deer. Pride's handler was required to hack him considerably the last twenty minutes.

# Smokey and Vickie of LaRue:

Young Smokey ran the extreme outside all the way. Bird flushed in path at 19 minutes, no dogs near. Vickie carrying extra weight searched diligently but lacked class.

# Copain and Dinah:

With fine effort Dinah made game persistently at 26 minutes although nothing developed; Copain, erratic, bolted at 17 minutes, returned at 23 minutes, faded badly at end.

# Joey of Hunterhaven and Pepi:

Both dogs broke fast with Joey running a bit the wider; at 40 minutes Pepi took out bird, stopped under restraint. There was no game contact.

# Jacquet and Holleyhaven Dan:

Jacquet stood at three minutes, no bird; second stand at 12 minutes where handler produced a large handful of feathers. Dispite two absences which indicated involvement with deer, Dan ran impressively.

# Patsy and Star Boy:

A perfect brace action, both dogs ran always forward and high-headed. Star Boy made a find at 28 minutes which produced three birds, showed extreme style and character while Patsy backed. Patsy had a beautiful find at 39 minutes and manners to match. Boy backed; both finished going away.

# **Election of Officers**

Officers for 1959 were elected at our annual dinner held Saturday evening in Gladwin. Our new president is Amos Greer, Gladwin; Vice president, Albert Vogt, Jr., Flint, Michigan; secretary and treasurer, Margaret Vogt, also of Flint. He ranged well, showed a good working knowledge of what his handler wanted in response to each command, and exhibited that much desired enthusiasm that marks a good pup. Second place was nailed down by Queen, with only a slightly less

aggressive show. Bonnie's Handsome Boy showed intelligent object checking, and Penny Channing did well also.

# Open Derby Stake

Ford's Kandy Kane took first with a driving but well controlled race that produced two finds, one a stop to flush on two birds and subsequently a solid point. Butch Dandy showed a real good nose in finding a native pheasant on the backcourse and a quail in the birdfield, chasing both. Tommy's Yankee Tommy took third with a good searching race that produced two bumped quail in one find. Prince of Valley Britt had a stylish race.

# Open All-Age Stake

Duc du la Bretagne supported his reputation with another high voltage exhibition. He ran a good wide backcourse with fine control just before entering the bird field, he slammed into an unusually solid point. Two birds flushed. His handler gave the O.K. to go ahead but Duc held his ground. Before it was finished a dozen birds flew from all around the dog. Major of Valley Forge ran the widest and best backcourse of any dog at the trial. He bumped one bird and had a stop to flush credited to him. Jeffrey D'or,

A second trial ribbon, too, went to Jeffrey's Paris Boy with good performance on one find in the birdfield. Featherbroom Bonnie showed fair range, fair control and one find, while Peter of Cornouaille hunted well, but suffered somewhat from the heat and slowed.

Dingo's Dinah, second, had an excellent forward ground heat, a class find, and she backed on command. Third, Dingo's Little Mike, had four birds in the bird field, one was dead, two stops to flush on running birds and a solid find on the fourth. Riviere Valley Suzette had a fair race with one good find. The classiest run of the stake, but with no bird work, was shown by Toffee Idoc Slamming Sammy.

## Open Derby Stake

The 40 Derby entries were judged by G. L. "Pat" Murphy, Okemos, and Earl Cutler, Otisville. First place was Buck of Marvan, who ran a terrific back-course, a good forward race which was almost big at times. He had two derby finds, one on the backcourse, and one in the bird field which he relocated. Second place, Hels Oklahoma Dream, ran an excellent consistently forward race and had one find with perfect derby manners. Third place, Pacolet's Gallant Lad, ran a fair ground heat

with an erratic pattern and had one find under trying circumstances. Fredan's Interne, ran a fair race, hunting all the way, and had one good derby find.

Open Puppy Stake

Judging the 10 puppy entries were G. L. "Pat" Murphy and Earl Cutler. First place was Pacolet Sam, who ran a good puppy race with more mature bird work than the others. Second place was Brittany's Royal Rogue, followed by Pacolet's Penny and Pio.

# NORTH JERSEY BRITTANY CLUB GUN DOG CHAMPIONSHIP

The North Jersey Brittany Club held their annual Gun Dog Championship on Sunday, November 16, 1958 at the Troy Hills Game Association Grounds in Troy Hills, N. J. Although the Championship had not been run last year due to inclement weather, it again has been renewed this year. It is a shoot to kill stake whereupon your dog does not have to remain steady to wing and shot but must retrieve. It is run on the thought that many members that do not run their dogs in licensed trials but use them strictly for hunting would enter in stakes such as these. Out of a field of ten starters, Cherrystone's Allamuchy Tim emerged the winner to gain the second leg on the trophy which was donated by Dr.

James Weisert a few years ago. Tim had a good find in the birdfield and after the bird was killed made a perfect retrieve to his handler which also is his owner, Bob Fitzgerald. Rusty Boy of Okhio, owned and handled by Ken Griggs earned the runner-up spot by running an ideal gun dog race and also handling his bird well. All dogs that competed had bird work except one, but the lack of retrieving prevented it from being a tight stake. Other starters included Dorallen Andra, Pamalie's El Capitan, Meester's Kim, Pompton Falls Patches, Pompton Falls Meg, Pompton Falls Tammy, and a dog owned and handled by Dr. Cory Walling. This year the club also inaugurated a Puppy Stake to run on the same program with the Gun Dog Championship. Out of a field of three starters Al Meester's little puppy took the honors of Top Puppy. It was not a shoot to kill stake and it was run on Coturnix quail. Officers and members of the club hope that in future shoot to kill trials the members will support them with a large entry.

# 13th FLD. CH. DIES

GEORGES O FLEEWAY, the thirteenth Brittany in the United States to gain the coveted Field Champion title, died of cancer shortly after his thirteenth birthday.

"Spotty" was the pick of the first litter ever raised at Leeway, and sent to Bill Kull for training and campaigning his Derby year. Though he had several placements in Derby stakes, and placed fourth at the A.B.C. Nationals in 1948, he had to gain his championship the hard way: three firsts in Open All-Age stakes at Illinois, Pennsylvania, and Central New England to finish in the Spring of 1950.

# GOLDEN EMPIRE BRITTANY CLUB

# MICHIGAN BRITTANY CLUB

The Michigan Regional Brittany Club conducted its fall trial October 11-12, 1958 on the ample grounds of the Highland Recreation Area. 100 Brits were entered in the four stakes; Open All-Age and Derby Running on multiple courses, while the Puppy and Amateur All-Age used a single course. There were many wild birds in addition to planted pheasant and quail, (average of 8 birds per brace contacted in Open All-Age running). Multiple-course stake judges were Mr. George Wilson, Flint, Michigan and Mr. George Higdon of Royal Oak, Michigan. Mr. Curtis Green of Detroit, Michigan and Mr. C. W. Morse, Euclid, Ohio judged the Puppy and Amateur.

From the temperature standpoint the weather was ideal for the running of all stakes, but heavy gusts on Saturday made the birds wild. Cover on some courses was heavy and deer scent caused trouble, but as Mr. James Hadley remarked "It was worth coming here just to see the landscape in all its glorious colors." The trial chairman, Earl Chappell, and his good committee functioned in exemplary fashion.

#### Open All Age Stake

Rendezvous Elias ran a fair to good race, being a bit short at times; pointed and held while some ten or more boiled out around pheasants Credited in addition with a stop to flushed, his unmatched bird prowess earned the blue ribbon. Holley Haven Lucky laid down a good shooting dog heat. On a good find he was steady to wing and shot and had a stop to flush on a running bird. Ft. Ch. Gagel's Dutchman took home the yellow ribbon for his fair race with one steady find. Dingo's Dinah laid down a good searching heat; seen standing, she moved in when some six to ten birds flushed before her handler reached her. At pickup she shared in a find.

# Open Derby Stake

Pinoak Guy showed a strong race to the front. Handler produced the bird when Guy was found standing out on a limb.

On another find, requiring relocation, the bird flushed wild. Buck of Marvan's ground pattern was near-perfect. He had a good find on the breakaway and two bird contacts later. Cork's Copper Brandy, named third, showed drive all the way; one good find with handler flushing, on the second the bird flushed before Brandy established point. Gladwin Tony had a good quartering race and took in all kinds of cover. On his find, his handler couldn't locate the bird, but Tony did.

# Open Puppy Stake

Sir Sanford, in first place, was a wide and big-ranging puppy, gay and industrious all the way. Pio was forward running with a nice puppy find on the backcourse and a divided one in the birdfield. Pacolet's Sam showed real hard drive and independence and finished very strong. Belle's Proxy was busy and spirited with a find in the birdfield. Pacolet's Penny, Dutch, Rogue and Maggie all sparkled.

# Amateur All-Age

Freckles VII, handled for his owner by Tommy Higgins, laid down a good forward race and was faultless on a find in the birdfield. Dingo's Dinah, owner-handler, ran a level ground heat and on her find in the birdfield, she stood for some time before handler reached her. Governor Leo, ownerhandled, exhibited a god shooting dog race, restricted a bit by his handler. Leo had three birds on his course with a couple flushing wild. Patsy de Bienville, owner-handled, had a good searching race with a find and an unproductive on sourse, finishing with a good fin din the birdfield.



# DUAL CHAMPION TEX OF RICHMONT

Tex was bred by Dr. Busteed of Canyon, Texas, out of Seize MacEochaidh by Allamuchy Valley Warrior. He is a powerfully built liver and white, and has the distinction of being the only dual liver and white to my knowledge. He is also, at this time, the number one stud in the history of the breed in point of producing winning offspring. I do not know how much Dr. Busteed used him as a stud, before I acquired him six years ago, but since then, he has ony been used twice as a stud by anyone other than myself. His stud engagements in the past six years have, for all practical purposes, been with my own bitches, and in view of this limited use, it makes his record all the more remarkable.

Tex completed his Field Championship under the whistle of Lee Holman, and accomplished this in the first year that Lee had him. His championship was completed with all of his points being all-age points. Since completing his Championship, Tex has not been campaigned, but I have used him every year as my personal quail dog. Soon after his field championship was completed, he was entered on the bench. His first win was under the judgement of Bill Averill and he than completed his bench championship in straight shows.

As a stud, I know of 28 of his winning offspring, and since my records are incomplete, suspect that he has about 31 winning offspring to his credit. Tex, therefore, is the No. 1 stud—alive or dead, and this was noted by Nicky Bissell in the August, 1958 issue of THE AMERICAN BRITTANY.

Tex has sired one of the top five youngsters in the country every year for the past 5 years, including such notable youngsters as Pacolet's Genii, Pacolet's Texsun, Pacolet's Cheyenne, Pacolet's Busher Gal, Pacolet's Penny, etc. Tex has sired one Dual Champion

(Pacolet's Cheyenne), one field Champion (Fld. Ch. Sooner Ranger) and three bench champions that I know of. He has sired two Futurity winners in Texas Merry and Du. Ch. Pacolet's Cheyenne. He has two other offspring that are only one point away from their Rivierre Vallee Suzette) and at least Field championships (Texas Merry and fifteen of his offspring have won in all-age competition. Well over 50% of his winning offspring have not only been winners, but have been first place winners. Tex is in excellent health. and still able to keep up with any youngster he is down with. He should have many good years still ahead of him. A study of Tex's bloodlines brings to light the interesting fact that his among the top stud dogs in the country, sire (Allamuchy Valley Warrior) is also and between Warrior, Warrior's offspring and their offspring, I am certain that there is no three generations of Britts that have produced anywhere near the amount of winning dogs that these particular three generations have, nor as many Field Champions. Tex was also on Sports Afield All American Gun Dog Team in 1954.

The great winners of the past, the superior producers, and those that made the history and reputation of the breed. # CHAMPION RUBY OF EDOUGH

Ruby of Edough, out of Iolet of Edough, by Hello Mike, is the number one bitch in this country as brood matron of field pups-again as noted in Trial Talk, AMERICAN BRITTANY, August, 1958. She has at least thirteen, and probably more winning pups to her credit. Ruby is not particularly old, and should have at least three more breeding years left. She was entered in trials as a youngster, and although I used her in my personal hunting, I have never considered her wide enough for a trial dag. She was shown on the bench, and in successive shows accumulated her points in very short order. I do not know of a single pup of hers that went into the hands of a trial minded owner, that did not end up in the winner's circle. I am



sure that the next trial seasons will add to her record for I know of two of her most recent offspring that will be given trial opportunities.
