NATIONAL TRIAL JUDGES

COLONEL EDWARD D. McQUOWN

(Judge of National Specialty Show)

Col. McQuown is perfectly qualified to judge the 17th National Specialty Show at the Crab Orchard Field Trial Clubhouse on Nov. 28th. He has been judging all breeds for 35 years and has judged specialties in many different breeds. His past assignments have taken him throughout the entire United States and Canada. He has judged at many of the larger shows such as, Westminster, The International at Chicago, Harbor Cities and Golden Gate in California, Heart of America at Kansas City, Royal Winter Fair at Toronto, Canada.

The Amercian Brittany Club is particularly fortunate in having Col. McQuown judge our "dual dogs", because he is well versed in the ways of dogs in the field as well as on the bench. His field experience started at the age of 5 years when he was given his first dog, an American Water Spaniel. As a young man he owned pointers and setters and briefly ran a pointer, Wildwood Bob, in field trials. Due to the pressure of many judging assignments, Col. McQuown stopped breeding and exhibiting dogs in 1930, and now is a "full time judge."

Col. McQuown's other avocation is the breeding and racing of Standardbred Horses. He states that his grestest success has been to win all three heats of the Ohio Pacing Derby in 1943 with "The Colonel", establishing a new track record which still stands.

That others think a great deal of Col. Ed McQuown, is well demonstrated in that he was awarded the "Fido" as judge of the year in both 1950 and 1951. "The Fido" in the dog field is roughly equivalent to the "Oscar" in the motion picture field.

AMERICAN BRITTANY CLUB FUTURITY RULES

Section 23: The American Brittany Club Futurity, established for the purpose of encouraging and benefiting owners of Brittany Spaniels is inaugurated by and is conducted under the management of the American Brittany Club.

Conditions and Rules

Each American Brittany Futurity shall be open to every pure-bred Brittany Spaniel bitch bred on or after Oct. 30 of any year, and all her progeny born on or after January 1st of the year following, the dams of which have been duly nominated and whose litters have been enrolled with the American Brittany Club.

All dams nominated and all sires bred to must be registered or eligible for registration.

The trial shall be held on game birds, pheasants or quail, and shall be held at such time and place as may be determined by the American Brittany Club. The time and place of the trial shall be announced at least sixty days before the day set for its commencement.

Nominations and entries must be made on blanks furnished, free of charge, by the American Brittany Club.

Nominations of dams must be made within thirty days after the bitches have been bred, at which time the sum of \$5 must be paid on each dam nominated. When the litter shall have reached the age of thirty days, the second and final nomination payment of \$5.00 must be made. This payment will entitle each puppy of this particular litter to be entered for the American Brittany Futurity Purse after the dog has been properly registered in a recognized stud book such as The American Kennel Club or The Field Dog Stud Book.

Nominations of dams may be made on or after October 30 of any year and shall close positively July 1st of the year following, for the American Brittany Futurity to be run the year subsequent to the closing date. If a bitch fails to whelp or gives birth to a dead litter, her nominator may substitute another, or transfer the nomination to another person in the same or next succeeding stake, subject to the approval of the American Brittany Club, provided said nominator shall give notice within twenty days after the time the bitch should have whelped. If notification is not made in accordance with this requirement, first nomination fee shall be forfeited.

A single substitution may be made under the same condition governing original nomination.

Entering Dogs

Entries for each American Brittany Futurity shall close August 1st (except when that date falls in Sunday, when it shall be August 2nd) for the current year's trial. On or before August 1st those expecting to start dogs must describe their entries on entry blanks furnished free of charge by the American Brittany Club, and pay on each a forfeit fee of \$15.00. A starting fee must be paid, in addition, before the drawing. The drawing shall take place the day before the date announced for the trial to be run. Dogs must be registered. No dog may start until the registration number of that dog has been received by the field trial secretary.

The nominating, forfeit fees will be pooled and after deducting expenses of the stake, including 10% for the American Brittany Club, the balance will constitute the purse. The purse will be divided two-thirds to the owners of the winner and one-third to breeders of winners; both owner's and winner's divisions of the purse to be divided:

- (1) 40-25-20 and 15 if there are four moneys paid. Four moneys shall be paid if there are more than 16 starters.
- (2) 45-30-25 if there are three moneys paid. Three moneys shall be paid if there are 16 or less starters.



WASHINGTON BRITTANY CLUB

The Washington Brittany Club's fall trial ran true to the highest form. Sixty-three (63) entries worked an average of five wild birds per brace on the drawn sequence of ten courses. Cooling air from the mountains rimming the Ellensburg valley softened the bright warmth through most of both days.

The committee worked up the program through a series of three nesting season picnics on planted birds in suburban barn lots. A fourth rally explored the courses in a new type free-for-all event. This culminating test of hunting ability under actual field conditions produced all varieties of excellence—no quarter asked or given.

In the very first brace of the Open stake, Dr. Sullivan, of Berkeley, California, longest traveler and honored national Brittany Club officer, handled Dual Champion Paul's White Flash to a perfect find on a pheasant rooster. Watching every angle of this open work, Judges Ernie Code and Dave Gordon entered notes in their scores and ultimately pronounced it third place. Second brace found trainer Stan Aeck's front companion on many a trek here and in Canada scooting boldly out to pinpoint a young hen for second placement. Watching this taut little bitch quiver proudly, tail and nose high, is an unforgettable lesson in true Brittany style by Helmer's GiGi.

The only possible way to top these performances would be to tick off—say about six, real intent, accurate finds plus a back or two and a thorough, driving, bird-wise race, etc. etc. . . . So it was with the winner, Jagger de Ferncrest in the third brace. This is the third staunch Brittany handled for hunting and competition by this owner starting with their well-known sire, Jacques de Ferncroft, now deceased. The tremendous efforts of the succeeding braces added up to a fourth for Bert Heinz' bitch, Suzanne, handled by Stan Aeck. Elmer Flack's entries ran well

as always but proved too young for seasoned work in new terrain. Other strong entries starting under the well known trainer Tom Cox, now of Portland from back east, were not yet mannerly on birds at this first stop on the West Coast Circuit. Ed Keefe's Sputnight orbited out real big into an overwhelming galaxy of birds. So bounced Tigger Too.

President Art Stavik enjoyed the banquet menu of steaks, smiles all around, and no speeches. Doubling as judge with Bert Heinz, he handed first and fourth Open Puppy ribbons to expectant Don Frederickson. Herron's Smokey was crowded at second place by Jack Little's brilliant young bird-finder, a close third. He than called the Open Derby for six next morning and adjourned for early bed.

Again the first brace proved tough

All of us watching the finished manners and consistent pace of John Taylor's Tammy, up from Eugene, Oregon, agreed that is was the outstanding Derby entry.

First Amateur brace found Paul's White Flash and Jagger de Ferncrest at it hammer and tongs again with birds in the air to place second and third respectively. It was the lot of Fred Hutchinson to follow Lady Jane Puggins through a wind squall on the last course late that evening for fourth place. But this day was claimed far and away by Glen and Betty Helmer's GiGi who piled not less than five flawless and exciting finds onto several perfect backs to sweep the field including the hugh, rotating Metzger Nancy trophy!

Walking alertly and courageously through both the open and amateur gun dog stakes, Judges Ernie Code and Dave Gordon again endeared themselves to the Brittany crowd. Such an overwhelming turn-out once more proved the owner's preference for gun dog type contests run on multiple courses with wild birds vs. the contrasts of either hacked-up wonders paraded on single course areas into planted birds or the big-going horizonsplitters chased on horses at all-age field trials.

Club Secretary-Treasurer, Paul Whalen, a licensed accountant by tradition not only works cheerfully and efficiently, but shows a neat profit as well. Next event in a similar pattern is promised at Moses Lake in the spring with a gesture toward all of our Brittany friends at Spokane and the Richland area. Shall we all try to make it?

BENCH SHOWS? BRITTANIES? AND JUDGES?

by Morris C. Smith (Susquehanna Club)

At the very considerable risk of being identified as a sorehead, I would like to voice my personal views on the combination of subjects that form the title, with the hope that Brittany owners will re-read their breed standards and that, perhaps, those in an influential position can do their bit to see that the judges assigned to Britts do the same.

My observation of persons who have just obtained their first Britt leads me to believe that most people buy their first Britt as a direct result of association with another of the pointing breeds; as such their first interest after some familiarity with the dog and club activities is Field Trials. This is a normal and healthy approach, and if the Brttt is to avoid the degeneration that has occured in so many other of the sporting breeds the place of the Britt in the field must always come first.

But Bench Shows, if the Britt is to be a true Dual Dog, have a definite place in the scheme of things. There should be no better way to prove the bodily conformtaion of a dog, with the ideal of finding whether a given dog has the genetic traits that we hope to see developed and expanded in future generations, than Bench Shows. There isn't much use fighting it: great dogs are created, they don't just happen, and conformation is hereditary. This in no way belittles the importance of Field Trials; this is the opposite side of the Dual Dog make-up, and does not concern this discussion.

The various regional clubs, in their never-ending search for better judges of the Britt in Field Trials, spare no effort, and an incompetent judge is soon black-balled by the simple expedient of not placing his name on the list of approved judges. And yet we meekly submit to the assigned judge when we

place a Britt in a Bench Show. This, obviously, doesn't make much sense.

I hasten to add that there is a pretty obvious way to overcome this deficiency: go thru the process of becoming a licensed Bench-Show Sponsoring club, in the same manner that a license is obtained for Field Trials, and hold your own Bench Shows, in conjunction with Field Trials, and pick your own judge. This is the plan suggested by the National Organization. There is only one flaw in it: the same organization reluctantly admits that the plan is nearly, if not entirely, unworkable, because all of the time available on a given weekend Field Trial is necessary for that trial. What is the option? Apparently the only one is to work within the framework of the local Bench Show sponsoring organization.

But the Brittany, cursed with the Spaniel appendage, is all too often identified with and grouped with the true spaniels, all too many of which long ago forgot what a bird or a birdfield looked like, and became "pretty" show dogs.

This word association often leads to the Britt being judged, in the conformation classes, by the same judge who has just finished looking at the "pretty" spaniels—and is, more often than not, a fancier of one or more of these breeds. Here lies one of the greatest evils of present-day Brittany judging.

The Brittany is not and so far as I find out was never intended to be a "pretty" spaniel. He can't be: he is meant to be a truly functional field dog, and that is not compatible with "prettiness." All that a Brittany enthusiast should want, or ask, from a judge is whether that dog fulfills the well-written standards. For his part, the enthusiast has every right to expect competent, impartial judging.

The weak link in the chain, in one

person's humble opinion, is the judges.

It would be a fine thing if a regional club, operating within the framework of a show-sponsoring organization, was able to guarantee a large enough entry to force the sponsoring club to select a special judge for Britts; it is even possible that this is now happening in a few cases. But in almost all cases, I'm sure, the entry is too small to allow dictation. What then? I would surely recommend that the regional club insist on being judged by the same judge who is working the pointers and setters. This is not a cure-all: most of the pointers and setters being shown today are also far-removed from the birdfield, but it is the lesser of the two evils. And, above all, if there is any way possible that the judge can be furnished a copy of the breed standards prior to the show-do it; always in an official manner, in behalf of the regional

Essentially, what should a competent breed judge be looking for? Well, height

limits are becoming increasingly important. The Britt must be big enough and strong enough to stand an all-day hunt, but not so big as to become a setter. The limitations on weight dictate pretty much the same thing: an overweight Britt can't run all day. The emphasis on running gear is very important: if he can't run he can't hunt.

Color, and/or ticking, is influencing present-day judges to too great a degree. Two different colors are permitted, ticking is desirable, and no limitations are put on roan factors. With a truly competent judge color, so long as not spelled out as illegal, should be the very last thing viewed. Indeed, it should require two dogs finishing in a dead heat in all other factors before a judge even sees color.

I do not propose to argue with the standards. I like them just as they are. I do propose that all of us look at them, and learn them. When was the last time you read them?




