

TO ALL MEMBERS OF THE AMERICAN BRITTANY CLUB, INC.:

Once again it is my privilege, on behalf of the Officers and Directors of the American Brittany Club, to invite each of you to attend the Seventeenth Annual National Field Trial and Specialty Show and the Twelfth Brittany Spaniel Futurity, all to be held at Carbondale, Illinois, starting November 28, 1959.

The National Specialty Show will be held in the clubhouse of the Crab Orchard Field Trial Club located in the Crab Orchard Wildlife Refuge. The show will get under way promptly at 7:00 p.m., C.S.T., and will be judged by Col. Ed McQuown, Xenia, Ohio. Entries for the show, Amateur stake and Championship stake, will close at noon November 17, at 2060 John Hix Road, Wayne, Michigan. Entries for the Futurity will close at the time of the drawing, 5:00 p.m., at the Crab Orchard clubhouse November 28.

The drawing for the field events will be held at the clubhouse, prior to the Specialty Show, at 5:00 p.m., C.S.T.

The National Amateur stake will start Sunday, November 29, with Mr. Lloyd Teas of Murphysboro, Illinois, and Mr. Tom Lunsford of Ewing, Illinois, in the judicial saddles.

The Futurity stake will immediately follow the Amateur stake, and the National Championship stake will start immediately following the Futurity. These two stakes will be judged by the very capable Mr. W. Bryden McMurtie of Sparata, Illinois. All stakes will be marshalled by the more than capable Mr. Tom Lunsford.

Food will be available at the clubhouse at the time of the drawing and Specialty Show, also at noon during the field trial.

Monday evening will be an evening of fun at the annual banquet and calcutta at the Elks Club in Carbondale. Don't miss it!

The annual business and Directors' meeting will be held at Engel's Restaurant on Route 13 at the eastern limits of Carbondale. These meetings are of extreme importance, and we strongly urge each Regional club to have their Director and Delegate in attendance.

Reservation for accommodations are available at the Plaza Motor Court, Marion Motel, Pinoak Motel and other local motels. We suggest you make your reservations early.

Once again we are in need of additional money for the trophies for the Specialty Show and Field Trial. Any contribution, regardless of size, is sorely needed and will be greatly appreciated. NATIONAL TRIAL JUDGES

W. BRYDEN McMURTRIE (Futurity and National Championship Stakes)

Mr. McMurtrie of Sparta, Illinois, comes to judge the trials at Carbondale, well recommended by all that know him personally as well as those who know him as an excellent judge of bird dogs.

Familiarly known as "Mac", Mr. Mc-Murtrie lives near Crab Orchard, and

in the midst of some of the finest quail country in America. The current grounds are very familiar to him in his role there as judge, participant and spectator.

His services as a judge have been used many times. His background of bird dogs and field trialing, the vast knowledge he has accumulated, and his reputation as a stickler for the class bird dog, have earned him deserved popularity and respect. A fine horseman, he is so constituted as to give full measure to the assignment at hand.

His unquestioned ability to analyze and weigh the performances of the dogs

put down in front of him has been demonstrated many times in some of the largest trials held in the country such as the Quail Futurity and the All-American Club events.

Although primarily a judge of pointers and setters which he also owns and runs, Mr. McMurtrie has judged the Brittanies on many occasions.

ALBERT E. RULE

(Futurity and National Championship Stakes)

Mr. Rule resides in Pinkneyville, Illinois, deep in the Southern Illinois quail country. He has owned pointers and setters but has a preference for pointers. However, "I like a good dog, no matter what the breed is." Mr. Rule does not actively campaign his dogs because he finds that his time is so filled with judging assignments, that none is left to get his own dogs in trial shape.

Mr. Rule will also be on familiar ground at Crab Orchard. He is a mem-

ber and trustee of the Crab Orchard* Field Trial Club, and has judged there many times. He has watched Brittanies over these same grounds having judged the Illinois Regional Trial at Crab Orchard two years ago. The first judging assignment accepted by Albert Rule was in 1937. Since then he has judged many Amateur stakes and some All-Age Stakes at Weldon Springs, Missouri, Crab Orchard, and other places in southern Illinois, Indiana and Missouri.

As a matter of interest, Mr. Rule and Mr. McMurtrie have served many clubs as an excellent judging team, and we are indeed fortunate to have them as judges for our all important Futurity and Championship stakes.

LLOYD TEAS

(National Amateur Stake)

The American Brittany Club is honored to count Mr. Teas as one of the judges for the National Trials. Besides being an excellent judge of dogs, Mr. Teas is now serving his second term as president of the Crab Orchard Field Trial Club, the organization that in a sense is our host for the "Nationals."

Mr. Teas serves as recorder for the Crab Orchard Club Trials, and has marshalled and judged Brittany trials on these grounds.

His personal interest leans towards setters and he has owned and trained some good ones for amateur trials and shooting dogs.

The American Brittany Club is grateful to have judges of this caliber for our National Trials. The National trial committee is also grateful to the Crab Orchard Field Trial Club and to their members that are assuming our judicial duties. Theirs is indeed devotion to the field trial cause "above and beyond the call of duty."

THOMAS M. LUNSFORD

(National Amateur Stake)

Mr. Tom is well known to those that attended the last two "Nationals". In his capacity as marshall in 1957 and 1958 he did an excellent job of ad lib course planning. His knowledge of the grounds at Crab Orchard and the loca-



tion of coveys never ceased to amaze the regulars in the gallery.

Mr. Tom well knows what to expect of a bird dog, since he has been training for thirty-five years, and has finished fifteen champions. A few years ago he had a few Brittanies and "some of them did some winning." Since he does not believe that a trainer should judge open stakes, Mr. Tom has limited himself to Amateur stakes. His experience includes two consecutive years judging the Memphis Amateur; Amateur stakes at Weldon Springs, Missouri and many other comparable trials. We all look forward warmly to renewing our acquaintance with Tom Lunsford at the Nationals this fall.





I desire with this writing, to converse on the subject of judges—as is



said in the trial reports "the men who ride the judicial saddles". This phrase always causes to arise, the mental picture of a black robed saddle with a white wig on the saddle horn and a gavel held in the right stirrup. But I digress—the function of the judge is

to set the field standard for the breed, which in our case is the Brittany Spaniel. To use the ridiculous extreme; if all judges decided that the best dog was one who pointed with the head cocked to the left, then eventually all Brittanies would point with the head cocked to the left. To be more realistic,

if the judges thought that the best dog was one who could outrun the Whippet, then the Brittany would eventually assume the abilities and then the form of the Whippet—and this thought is not so ridiculous.

The judge, then, must have a good understanding of the "Field Standards" of the Brittany, just as the show judge should know the bench standards of the breed. It is unfortunately not possible to precisely define these field standards, because a large part of the judgment in the field is done on an intangible thing known as "class" or "style". Mon Pere often compared a good bird dog to la Femme, both being close to his heart, and would say, "Son, la Femme can be beautiful posing, but it is only with motion that one can tell class."

So when judges are chosen for your Brittany trials, the understanding should be made that they are to judge

Brittanies and not short range pointers or wide running German dogs. should be familiar with the basic utility of the Brittany as the walking hunter's dog par excellance. This correct choice of judges in the field will prevent changes in the utility of the dog, and as important, it will prevent the eventual change in the appearances of the breed. Now, since all dissertations such as this should have a moral I offer the following. What can be done to assure the Brittany clubs of judges that will judge with the betterment of the breed in their minds? Many judges are chosen on reputation or reference and without personal knowledge. This cannot be helped. Then the judges must have AKC approval, which is a formality. However, if after the trial the field trial committee would send an evaluation of the judges to the National Trial Committee of the ABC, then a file would be made up by the parent club. In due time, a good list of approved judges would follow. Then, when a club picked judges new to them, they could be first approved by the ABC committee, or if the choice was not the best, it could be discouraged at this level, before approval was sought from the AKC. This would not operate as a blacklist, but merely as an aid to the regional field trial committees, and would certainly be a definite value in protecting the breed. Should this basically, not be the purpose of the parent club and its committees?

QUALIFYING FOR THE NATIONAL TRIALS

The rules for qualifying a dog for the National Trials were revised in 1957 in order to improve the quality of the Stakes and to limit the entry in these stakes so that they could be conducted within the period of one week or less. To qualify for the National Championship Stake, a dog must be 6 months of age or over and must have placed 1st or 2nd in an Open All-Age Stake in an A.K.C. licensed Point Trial. To qualify for the National Amateur Stake, a dog must be 6 months of age or over and must have placed 1st, 2nd, 3rd or 4th in an Open All-Age Stake or an Amateur All-Age Stake in an A.K.C. licensed Point Trial.

Any dog that has qualified once for a National Championship or National Amateur Stake, may participate in succeeding appropriate National Stakes without further requalification.
