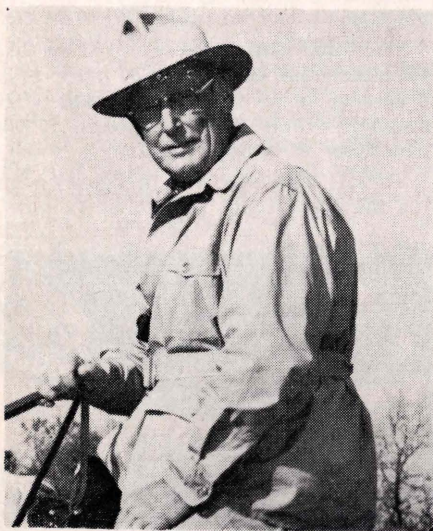


## A. B. C. QUAIL CLASSIC

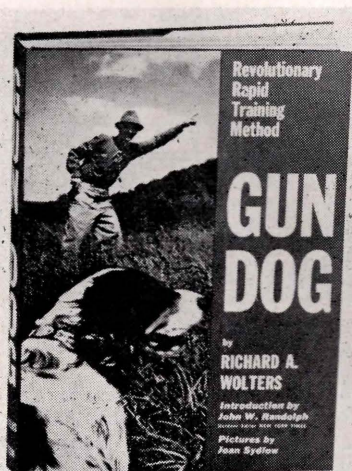

## GUN DOG

By Richard A. Wolters



A revolutionary rapid-training method. Written for the sportsman with limited time and facilities who wants a gun dog quickly and who wants to train it himself. A departure from the accepted training program, it teaches hunting commands with the use of training tools, with picture sequences (more than 200 photos in all) illustrating the step-by-step routine. The author uses his own case history of taking an eight-weeks-old puppy and training him into a finished hunter at six months of age.

The book is brief and to the point. Its principal thesis is that of minimizing the training required for each step and the avoidance thereby of the acquisition of bad habits which must be unlearned. Much emphasis is placed on the mental development of the dog and the value of human contacts during the pre-training weeks as well as in the schooling period.

October 13-14, 1962

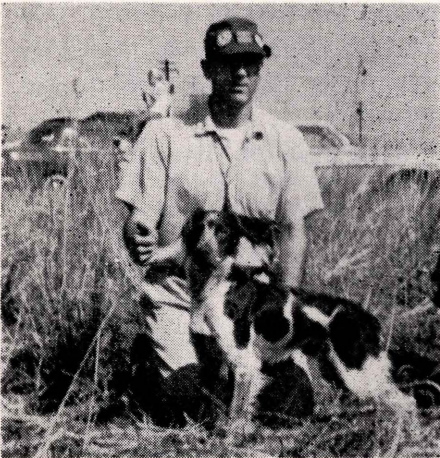

# Trainer's Panel

Dear Sir:

I have a big problem with my two year old Britt.

My dog is out of top blood lines, he will retrieve, answer the whistle, and many other fine things. But he will not point.

I have lost a trial because of this one problem. What can I do?

Dear Sir,

Probably you can tell me 'why' if you think back. Did you put your pup on planted birds very young nad let him catch his first ones? Did you ever try to encourage him to point in the beginning? Did you start him retrieving birds before you did anything about helping him point? Any of these things could be the answer to the non-pointing Britt.

When Brittanies were first introduced into this country the non-pointer was common but field trials soon eliminated this type of dog from most breeders breeding programs. Your pup is of excellent bloodlines and should have some pointing instinct.

It is fairly common for a dog to point quite well as a puppy and forget to

stop on birds when he gets at derby age. If your pup has pointed at any time in his life he can be trained to point again. If he will not do it with a little encouragement from you I suggest you try a professional trainer as your problem is a bit difficult for an amateur to handle.

If he has never shown any indication of wanting to point, even to flash point, I suggest you get rid of him and try another dog. Perhaps you can interest someone in him who will keep him at springer range and use him as a springer.

If he has pointed previously perhaps you can teach him to point. Teach him the command 'Whoa' and then stop him with it when you see him wind a planted bird. After much repetition he should start to stop on planted birds and then you can take him on wild ones and repeat the same routine.

If you started his retrieving before you worked on his pointing he may have gotten the idea that a bird is for picking up! A dog that gets that association early in life is sometimes very difficult to train to point but constant repetition of making him point, then shooting, and then letting him retrieve will get the point across to him.

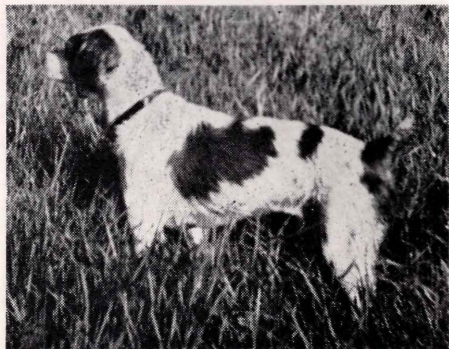
