

EDITORIAL

Wanted: The Proper Tools!

Have any of you other 'Do-it-yourselfer's ever found yourself in that nook in the basement, ready and willing to tear into that project; and then find that your pen-knife just isn't tool enough to build that kitchen cabinet?

We surely all realize that without proper tools a good job cannot be done, and the product becomes second rate.

This, it would seem to me, is and has been the case with the American Brittany Club. And, with the National Meeting approaching, some thought should be given to the proper tools needed for this organization to do a first rate job.

The basic working tool of any organization is its Constitution. In the case of the American Brittany Club, the constitution is a pen-knife that was adequate for the whittling necessary for A.B.C. when it had five or six member clubs. With more than 30 member clubs on a truly national scale it is woefully archaic!

Some changes should be made as soon as possible, and the most important of these are in respect to officers and directors

The Board of Directors is made up of one from each member club and five directors at large All decisions are made by this board—all business is conducted by this board. Each should be fully conversant with the national problems—each should act only in the best interests of A.B.C., not in the best interests of his own club.

Officers of A.B.C. must be chosen from among the directors.

This sounds simple but in reality is frightening.

First, how are individual directors chosen by the member clubs? Often, it would seem, the only point of decision is, "Who will be going to the Nationals this year?" It may be the same one year after year, or it may be someone entirely new to the National scene.

If the director is unable to attend, a proxy is issued to someone who will be present. Often the member club 'pro-

tects its interests by specifying how the proxy should be used, or that a Yes vote may be given only with this provision.

What then does the final conclave of directors represent?

Some are new comers, good people certainly, but not yet ready to hold office on a National level.

Some are the old timers, well aware of national problems, but having previously held office, are reluctant to do so again.

One has a proxy to vote Yes only if something, and one a Yes proxy, only if something else. An impossible situation in the event of a compromise or a last minute better approach.

Some are there to represent their club, and will only act in the best interest of that club, without proper regard for A.B.C

This could be improved by a Board of Governors or an Executive Council made up of five or six members, elected by the present Board of Directors. This body to make the final decisions and conduct the business of the club. In a discussion on any matter with 30 people there are bound to be at least 30 opinions—and often all different.

In a discussion with five people, a final answer might be reached.

Officers should be selected from the membership, but not necessarily from either board. This would give the nominating committee greater freedom to choose well qualified people.

There should be more continuity in the club, and a one year term of office barely allows the officer to learn what to do. In the second year, he could do it.

Lastly, an Executive Secretary is a 'must'!

Perhaps some of these matters will find their way to the Agenda this year.

It is time that we realized that the American Brittany club is a big business, representing about \$20,000.00 a year in 'Capital' each year. It should be run with the best tools available!

TROPHIES

21st National Specialty Show and Field Trials

Beautiful-but useful-will again be the theme of trophies at Brittany Nationals. There may be those who prefer another "dust-catcher" for the trophy case, when their Brit gets a nod at the Nationals. But the overmajority have expressed whelming their satisfaction with selections in recent years, and the committee is proceeding accordingly. Working with a professional buyer in Cleveland, Ohio are Mima Millar and Ellyn Lee. They will cater to the discriminating taste of wives, knowing that if the wife is happy with the trophy their Britt brings back, we've won over another family to become National contenders.

And that, after all, is the object of the Nationals: to entice proud owners to come with their Brits - the best from north, south, east and west; to see those top-notch Brits judged in a Bench Show, and then judged in Field Trials. Ideally, proud owners should be entering their Brits in both events. But, as Ed Borger pointed out in his fine article, THE AMERICAN BRITTANY, May, 1963, this has not been the case in recent years.

Everyone who has anything to do with staging this 1963 National feels the trend will be reversed. There are at least two good reasons why the 1963 National should be "dual-minded as never before.

First, there will be a W. E. Steven-Memorial Trophy awarded the "Dual Winner." The donors, Mr. and Mrs. James B. Bell, Jr. feel no one in Brittany history has contributed more to the high standards of keeping the Brittany a dual dog, than "Steve." He could be counted on at Nationals to groom his dogs for the Specialty Show and work his heart out in the ring, showing them at their best. Then Steve would run those same fine Brits (most of them Duals), later in the week in field trials. (More often than not, his entry would be drawn the very next morning, and Steve would get only about 4 hours sleep!) Steve was looked up to, he was envied, by every other amateur owner at Brittany Nationals. So it is going to give someone a real thrill to be the very first owner to gain a year's possession of the W. E. Stevenson Memorial Trophy—a sterling silver water pitcher, with replica. The donors have indicated the trophy can be retired: a) if won by the same dog twice; or b) if won by the same owner three times.

A second boost to the dual-minded Brittany owner, (and every Brittany owner should be), is the inaugural Dual Futurity. Remember, to be eligible for that cash award, a young Brit must place in both the Bench and in the Field Futurities. That's hitting it high, but high must be the standards of a National Club that strives to "keep the Brittany forever a dual dog."

So now, with your eyes alight, and hopes high, how about a donation to the Trophy Fund for 1963 Nationals?

one of the Regional Clubs has already sent in a sizeable check, and we're anticipating all other regional clubs will want to do likewise, as well as a number of individual donors. It isn't necessary to point out that regional clubs would not get the entries at their trials, were it not for the fact that these earlier trials are preliminary to the big one just around the corner—BRITT-ANY NATIONALS.

There is a certain glory in having a dog that does well locally, but often this merely whets the appetite. The owner lifts his sights, starts to dream of more and harder competition. He may take in a few more regional trials than he originally planned, and if he collects hardware and ribbons along the way, he's almost committed—he just must get that dog to the Nationals! For National competition is the only way to determine whether he has "just a good Brittany" or a real topnotch dog-one that can stand up to the best in the country. It's like climbing a mountain; anyone can get to the first plateau, but to aspire to the rarefied atmosphere of the peak—takes planning, determination, and quite a bit of daring . . . "Hard, but O the glory of the winning, were she won!"

TRIAL TALK

The number of winners this past spring does not seem to diminish much in spite of the fact that several clubs did not elect to hold their AKC trial. The following results are from AKC point trials only and each dog that receives 4 or more ribbons is mentioned as well as all dogs that complete their field championships.

The winningest youngster belongs to one of my favorite people from one of my favorite states (if you haven't been to one of those Kentucky trials try it some time, they are fabulous). The dog is LEBONABE and the owner Dr. Bolton. Abe had 8 places and half of them were firsts. He managed to get in the ribbons in one derby and the rest of the placements were puppy ones. Wonder if he is a Futurity? Pushing him all the way down the line with 7 is ALLEGHENY VALLEY DINGO, who comes from that successful Albedo Valley Dingo-Pacolet Cheyenne mating. Dingo is also a puppy and also had 4 firsts. Owned by Gerry Robinson, of Illinois, he is piloted by Lee Holman while Abe was shown by Jack Plyler. Also with 7 ribbons to tie for second is another Kentucky BELLEWOOD'S POLLYANN, owned by Perry Mobley and in the string of the Thompson's. This is the second time

this bitch has made this column for she was a winner last fall also. Tied with 6 places are CHAMPAIGN TONY BOY and RUSTY DE LARUE. Tony is the top winning derby dog as all his placements were derby ones. Rusty was a consistent placer.

A look at those with 5 places, and there were quite a few of them. Probably the outstanding was BOOMER DE JOY who won a 4 point derby. The two top youngsters in the Midwest circuit (they were also run some in the border Central trials) were JANE DE CARLO and DUSTY'S CASEY BOY. These are the first two winners sired by the 1962 National champion Miller's Desert Dust. The remainder of the dogs are from the eastern circuit. FAIRCREST POLY-JET, with two firsts is the best of this group in record. KAYMORE'S SKEET OF BIRCHWOOD will probably be one of the last winning pups sired by the great Tex of Richmont. LADY MARIE OF COLEBROOK placed both puppy and derby. She is of the Ponkapoag lines. And last is SHAMANDRE'S JEB DE BECQUE owned by the Becks. This ones placements now total 7 including a placement in the Weimaraner Club of Washington, D.C. These Brittanies sure get around.

Now for the four ribbon wonders. By far the best in this group is SUNNY BRITT with three derby firsts. This one looks like a great dog and would probably have made a tremendous record if he had been in any circuit but the limited Midwest one. JUCHOIR'S TERMISAN TANIST (whoever named that one!) was a young pup with both puppy and derby firsts and the first West Coast representative on this list. In the East HELDERBERG BUSY ABBIE duplicated the above record piloted by his genial owner, Dr. Crandall. This list would not be complete without Gerald Price's latest youngster and she is WAY KAN MANDY who made all hers in derby including one

first. The same record in the derby to MISTER CHIPPEWA MIKE, a Sweet handled dog. CRAB ORCHARD LEE-WAY got one blue in the puppy. Looks like George Wilson might have another good Little Mike son in DE LITTLE FRENCHMAN LADY SEARCHER is a classy liver and white also representing the West circuit.

The older dogs are represented by many familiar names. But the greatest this season was PINOAK GUY. Now seven years old, he pulled 12 places to give him a total of 48 places which plummets him right up in the middle of the list of the top ten all age winners in the alltime records. Mabel and Dave Olund may be justly proud of this one. In second slot is the Western TROOPER with 9 ribbons. LUNDS Troopers total placements are now 49 and he is only a five year old so we will expect to hear much more from this one. He is a home trained and handled dog and the pride and joy of Einer and Gilda Lund. Following closely is RUSTY OF HIGHBROW, a new

field trial champion, with 8 places, including a Quail Classic place. This looks like the first of a good group of champions that the Facers will soon have.

The 5 ribbon dogs are led off by the well known litter brothers RENDEZ-VOUS ELIAS and RENDEZVOUS EX-CEL. Both are field champions of record and Elias has a total of 42 places. MIKE DE KLEMANOR picked up two big five point firsts this season. He is another of those Kentucky dogs. LA-MONTE'S REBEL has 14 points but needs that Open all age to complete his title. According to my figuring he can't be much more than 21 months old so his four all age places look pretty big. Editors Fred and Ann White are to be congratulated on their FREDAN'S BUDDY who made a five point open win, plus three other places. HEIDIE'S SCAMP is now a field trial champion with points to spare. Dr. Heap is her owner and handler. I can hear the cheers now from the southern California contingent for here is the first one of their group to make the all age win-

Here is a truely good bench type who is also a fine field dog. GARY'S BEAU KIKI can always be counted on to impress. TIGGER TOO fulfilled the prophecies of his many supporters. We have heard for some time what a good one this one was.

The following dogs have recently completed their field championships. KAYMORES JOE OF WEYMOUTH picked up his final points by winning the Quail Classic. SUTTER BASIN HAPPY is another worthy champion with three big open all age wins. LADYS HASTY NELL joins the very small list of female champions. TEX'S LITTLE LUKE picked up his second five point open to finish. Another real good one is TOM'S ZIPPER KING. And a HoHo to you, owner Tom Atchinson. KICKAPOO SOO LARUE is another female and well deserves her title. In an area of few trials she made it with the help of a puppy win in a Weimar trial. MEG'S BUNKO BELLE is one of the truly great Eastern dogs and another female. Hope this is establishing a trend as we have bemoaned the fact for many years that the females were being neglected and that the quality of the female was just as important to the breed as the quality of the male.

CORRECTION

Mr. Stifel of the American Kennel Club kindly called our attention to an error in the August issue, page 11 "Official A.K.C. Classes-Bench Shows".

The conditions of the Novice Class and the Bred by Exhibitor Class were changed, the new conditions being effective at all shows starting on or after June 12, 1963.

The correct conditions are as follows:

The Novice Class shall be for dogs six months of age and over, whelped in the United States of America or Canada, which have not, prior to the date of closing of entries, won three first prizes in the Novice Class, a first prize in Bred-by-Exhibitor, American-bred, or Open Classes, nor one or more points toward their championships.

The entry form of a dog entered in this class shall state the place and date of birth of the dog, the name of the breeder, and the names of its sire and dam.

The Bred-by-Exhibitor Class shall be for AKC registered dogs, whelped in the United States of America or Canada, that are six months of age and over, that are not champions and which are owned wholly or in part by the person or by the spouse of the person who was the breeder or one of the breeders of record.

Dogs entered in this class must be handled in the class by an owner, or by a member of the immediate family of an owner.

For purposes of this section, the members of an immediate family are: husband, wife, father, mother, son, daughter, brother, sister.

The entry form of a dog entered in this class shall state the dog's registered name and AKC number, the name(s) of the breeder(s), the place and date of birth of the dog, and the names of its sire and dam.

Perhaps your question in the May issue was retorical but I would suggest a partial reply, as I reflect upon it, and in doing so I would entitle my remarks:

"Who Believes In A Dual Dog?"

It is obvious that the Editor, and Mr. Chet Hall (On Target, May '63) believe in a Dual Dog and have combined their thinking to produce a step in the right direction, and I might add, in line with the thinking of many of us.

But who else? Owners? Breeders? or Handlers?

Some owners believe this motto because they both show and run their dogs themselves or have a Handler to assist them in one endeavor or the other. Another alternative is, of course, Three kennels, and Three Massers—Owner, Field Handler, and Show Handler—and one confused dog. However, if we total this group of Dual Dog People it seems small indeed.

of the Breeders, I am not qualified speak, but my one observation would be centered around the fact that many field dogs" would be disqualified in show. These dogs, therefore, were probably improperly bred relative to the Breed Standards as a whole (ref. Ruth Hussin, "A Breed Divided", May 63) or relative to the show placements of the parents.

We owners cannot hide behind an inadequacy among our professionals, for we are the ones who support them. Within the scope of the "Law of Supply and Demand" we, the owners, are at fault. It is probably equally true that more dogs are bred by owners and we are lax in testing the prospective parents for Standard Characteristics, when as we generally breed solely for hunters.

It appears that the Dual Dog, and the owners who believe in the concept enough to demand it, — are vanishing breeds. Perhaps we need a Conservation Program for these vanishing breeds! And a certain amount of Protective Legislation! We should scream HELP! and DEMAND IT, from ourselves, our Breeders, our Professionals, our Club and our Parent Club.

WE NEED TO TAKE THREE GIANT STEPTS! MAY WE?

- 1. A.B.C. approval only to those kennels offering certified Dual Dog training and handling.
- 2. A.K.C. Championships dependant on reasonable placement in the opposite endeavor.
- 3. Historical, up to date records and carefully analysed accounts of the genetic faults of breeding pairs.

Conserve and Protect the Dual Dog NOW or enshrine him among the other vanished breeds.

ED. Generally speaking, your thoughts are much in line with those of the American Brittany Breeder's Association, still being discussed, and still very much in the embryonic stage.

The thought of A.B.C. approval to

only those kennels offering certified dual dog training and handling was once approached in a little different manner; a Breeder's Code of Ethics, to which all kennels must subscribe before they could advertise in THE AMERICAN BRITTANY.

In an oversimplified way this would be a written agreement with the breeder quaranteeing soundness in his dogs and concurrence with the dual dog concept.



There was a beautiful Ch. poodle in Utility class who as of this time cared little for scent discrimination and didn't mind proving it. He lifted his leg on the articles, faithfully, each time he was sent out to find the article! Perseverence and patience on the part of the handler brought this dog around and when I last saw him work he earned a leg in Utility with a 2nd place!

Once there was a Dalmation who was so eager to please that when he jumped the pole jump, he cleared the ring side as well, only to come right back over and finish correctly!

I remember my own rascal who worked quite well in Open "B" in the hot sun. But when he came to the long sits and downs he thought "phooey" and promptly backed up and lay down in the bit of shade the solid ringside afforded, when he saw I was out of sight. Perhaps dogs are smarter than we give them credit for.

A tiny Pomeranian was one of the most determindely good working dogs I ever watched. This particular time it was an outdoor show and was raining hard most of the day. Tents didn't protect anywhere near enough and he was drenched in no time, as were many other handler and dogs. But "Butchie" not only did all the open work well but stayed firmly, in an inch of water during the 3 min. sit and 5 min. down. He was 1st in his class and 2nd highest

scoring dog and thrilled all who watched him that day!

The most vivid incident in our own show career could have discouraged us from ever showing again, but it only served to strengthen our interest, in the end.





Anent Bell Oaks Gunner Requiem For A Champion

The death of F.T. Ch. Bell Oaks Gunner on August 4, 1963 was reported by its owner Martin Jarcho, Maine agent for Kaymore Kennels.

Mr. Jarcho, after owning Brittany Spaniels for many years, recently completed the construction of the Flying Dutchman Kennels in Oakland, Maine. Gunner's presence provided the inspiration for these kennels.

Mr. Jarcho in tracing the life of the Gunner advises that he was whelped on October 15, 1950 and bred by James Bell Jr., owner of the Bell Oaks Kennels.

The dog was subsequently owned and campaigned by Richard B. Fox, now deceased, and in the course of his entries in various field trials as late as 1960 (See the Brittany In America 1961) was rated fifth of the Top Ten All Time Winners with 40 places, including the most amateur wins with 15 first places.

This great champion was also selected as a member of the Sports Afield All American team of Brittany Spaniels for 1956.

A true champion to the last, Gunner expired while attempting to satisfy his master's last command. Apparently possessed of a heart seizure though repeatedly falling his final effort placed him in his master's arms. His last command fulfilled, he expired, a champion to the end.

He was put to rest adjacent to the kennels built as a result of his inspiration.
