Show Case is the place to display your top winner, either field or bench. Cost is \$10 if we do not have a cut of your dog on file, \$6 if we do. All dogs completing their Dual Championships will be featured free of charge.

### Change of Address:

Notice of change of address must be received one month before date of issue giving both old and new address. Otherwise delivery cannot be guaranteed.

### Material:

Specially written articles (as contributions) are desired as well as photos suitable for covers. No articles or photos will be returned unless accompanied by return postage. Material and format controlled by the Editor, subject to approval of the Magazine Committee, John W. Lee, Dr. Walker Heap and Nolen Cathey.

# YOU BE THE JUDGE

One of the great fascinations of owning and training Britts is that it affords one the opportunity of observing them doing some very interesting things. To the truly observant person this can be illuminating indeed.

Take for instance the time we were training a pup behind a well-broke All-age dog.

We had planted a pigeon on a grassy hillside bordering a pasture. Our plan was to release both dogs, and knowing the All-age dog was much faster, were confident it would find the bird first, point it, and then we could bring the pup in to work on the bird.

We released both dogs, and as we had anticipated, the older dog was faster and had left the pup well behind and was soon pointing the planted bird about 400 yards ahead.

The mature dog stood on point until it saw the pup coming full tilt; thereupon it backed off point, raced to meet the pup and carried it along on a big cast into the almost barren pasture, then looped back to meet us with the pup following. When we got close to the area where the bird was planted the older dog dashed ahead and again pointed the bird and we worked the pup on the bird and the rest went as planned.

Had that old dog figured out that there was a good possibility the pup was going to scoop that bird and that there might be "what for" to pay if that should happen, perhaps even to being blamed for the bird being flushed? Is it possible a dog could figure all this out?

You be the judge.

Then there was this daughter of Mandy of Edough, a name that may call to mind a number of good ones for some of the old timers among our readers.

This female was owned by a good friend of ours and the time we are telling about is when she had whelped a litter of 13 pups.

My friend was properly concerned

about the bitch's ability to care for such a large litter and consequently was watching things very closely. Sure enough. It appeared that his fears were well founded because he noted that the bitch had pushed six of the pups aside and was nursing the balance of the litter. He surmised she was rejecting the six and was pondering what to do. When he went back to the whelping box he now noted there were seven pups pushed aside.

He became suspicious of what was going on and paid particular attention to identifying the individuals in each group. The two groups were comprised of the same individuals which the bitch was permitting to nurse in shifts.

Now: Could that bitch count and divide odd numbers to the nearest whole number?

You be the judge.

How about this one:

We had a pup, a lone survivor, delivered by Caesarian section. The bitch required a massive dose of anesthetic and consequently was very ill. We had our kennel boxes in our basement at the time so I set up a cot there so I could care for the bitch and could watch the pup so it wouldn't be injured when it nursed. When not being nursed the pup was kept in a box under a heat lamp on a chair next to my wife's bed.

At that time we also had a young bitch which had not had pups of her own. She immediately began to care for the pup as if it were her own. But the amazing thing was that if we were in the basement with the very ill bitch and said to the young one: "How is the puppy?" She would run upstairs, jump up on the bed and look down into the box at the puppy. If the puppy was sleeping she would return to us immediately. But if the pup was awake she would stay with it washing it and watching over it like a mother hen.

Can dogs understand what is said?

You be the judge.

Years ago we had an old Britt and a pup which at times had the run of the



house. Sometimes, to keep the pup occupied we would give it a bone. The old dog had worked out a clever system for getting the bone away from the pup. She would run to the door barking and faking great excitement. The pup would leave its bone to join the old dog in creating a din; in the meantime the old dog would sneak around back of the pup and make off with the bone.

Can dogs think?

You be the judge.

Here is one that will really make you ponder:

The same old dog mentioned above was accustomed to accompanying us when we visited my elderly parents who lived in the same town as we did. They liked the dog very much and the feeling was mutual; one reason being, perhaps, that they lavished goodies upon her, something she was not so accustomed to at home.

This dog could tell when we were going to visit my parents, a rather frequent occurrence because as previously stated they were getting on in years.

The dog had some means of knowing

we were going to visit my parents because she would become wildly excited, bark, whine and in general act in a manner that she did only at these times. It became a challenge to us to try to devise some means whereby the dog would not know we were going to make one of these visits. We could find no way to do so. We tried acting the same as if we were staying home, even to not changing clothes. Of course we were particularly careful to utter no word that would give the dog a clue of our intentions. No matter we were unable to fool her.

How did she know? Extra sensory perception (ESP)?

You be the judge.

Is it possible that we as dog owners and trainers do not credit dogs in general and Britts in particular with the proper amount of intelligence? Is it possible that we could do a far better job of training and developing our dogs if we could find some means of tapping this high degree of intelligence so it would serve our ends?

You be the judge!

# THE *Official* BOOK OF THE BRITTANY SPANIEL



Yes, it's finally here, and titled **The Official Book of the Brittany Spaniel**. The text has 365 pages of which the first portion is devoted to a "How To" section that we hope will answer many of the principal questions asked by new owners, how to register a dog, how to train a gun dog, how to get a dog ready for trials, etc., etc. The second part of the book begins with the breed's origin, followed by a complete history of the breed in America through 1970. Included is also a chapter on the modern Brittany in France and other European countries.

The book is liberally sprinkled with illustrations, many of them photos of dogs that are being published for the first time.

If you own a Dual Champion, a Field Champion, a dog that has placed in show groups or a Bench Champion who has placed in field trials you will find your dog mentioned somewhere in the book. It should be noted, however, that the records for the book are compiled up to a cutoff date of January 1, 1971. It is unfortunate that the records could not be more up to date but the amount of time required to prepare the book made this cutoff date necessary.

One of the most useful portions of the book will probably be the Appendix. This lists all winners of American Brittany Club events such as the Nationals, the Classics, the Futurity and the Specialty Shows. It also lists the all-time record winners, the honorary members, Hall of Fame dogs and dual champions in the order in which their titles were attained.

Pedigree buffs will flip over the Index. It not only gives the names and correct titles of all the dogs in the book but it also gives their sires, dams, and their owners, plus home state.

Our front cover of *The American Brittany* this month features the color page that will serve as the book's frontispiece. The two dogs are pictured to illustrate the two color phases of the breed, a point that causes much confusion in the mind of the uninformed.

We know the head type will not please everyone, but these two photos were the best that were submitted.

The book is planned to be ready for shipping about the third week in April and will be priced at \$7.50 per copy. If you order and do not receive prompt shipment please **do not write** the ABC office. Publishing a book is something of a problem. We expected it to be ready early in 1971. Each month pushed the publication date back a little further until now we expect to send it to the binders about April 7th. They have promised to have it finished and back to us in ten days. We do not foresee any more delays but, if there are, you can be assured your orders will be filled the day the completed books reach our hands.

The book will be copyrighted in the name of the American Brittany Club whose Board has sponsored and financed it. The bulk of the text has been prepared by the Executive Secretary. In a work of this size it is expected that there will be errors. Each state section was submitted to various people in that state who had been with the breed for some time for corrections and additions. In most cases the response was good and quite a few errors were uncovered. In some cases there was no response at all. It is expected that there will be mistakes in those sections. We would much appreciate it if, when you find an error, you contact the ABC office so that the next edition may be corrected. We've done the best we could and no dogs have intentionally been omitted. We have tried to include, in addition to the Champion dogs, the pioneer dogs of importance in each club, and some with minor records that appear frequently in pedigrees of more prominent dogs. Dogs were not chosen for mention because the editor "liked them" or left out because she "disliked them." Those non-titled individuals were selected because of their number of field wins or for their influence on the present Brittany. Many personal favorites had to be left out because they just didn't have influence or enough of a record.

# Training Tips

Dear Hal Hunter:

The theory of working my pup on pigeons sounds great—except she won't pay any attention to them. What can I do?

Frustrated.

Dear Frustrated:

As you haven't given any background on the pup several different things could be the matter. If your dog has never been started in birds and you plant a pigeon tightly in the grass about 95% of the pups will, if given plenty of time, wind the bird, go up and smell it. First they give it a good going-over and satisfy themselves that this smell is interesting. When they have thoroughly investigated it they will leave the bird and go looking for something more exciting. It is the same routine they will follow with any new sharp odor. Don't come to the conclusion that the pup is not interested if he pays no further heed to the bird. He HAS looked it over, investigated it and knows what the smell is so he has no reason to check it further. But let the bird move and that's somethin' else again!

The ideal situation on the first bird is to have the pup wind it out far enough so that you have time to push the bird with your foot, waking it up and have it walk a bit. The pup will be interested in this because of the action involved. He may stalk the bird for a bit before the bird flies. We have to be very careful here. You did not say how old the pup was or what his disposition is. If the pup is very young or at all shy you want to be sure that the bird does not fly up directly in his face. He may be terrified and never want to look at a pigeon again. If you suspect the pup's first experience with a bird may unnerve him get him thoroughly used to a rope so that he is not disturbed by being led around. Then pull the wing feathers on one wing of the bird and plant it lightly. Have someone lead the pup up to the plant. As soon as he smells the bird wake it up carefully with your foot so that it gets up and walks. Do not push the bird so

that it attempts to fly. The noisy wing beat is NOT what you want. Let the pup stalk the bird but don't let him get too near. He'll get interested and as his interest increases let the bird get further away until you finally pick up the bird and toss it as far as it will go.

If you have a bold pup who is indifferent to the bird use the same technique except that you will rush the bird and make it flop noisily. In either case this procedure takes two people, one to hold the rope and the other to maneuver the bird. Do NOT let the pup get close enough to grab the bird or don't let him approach so swiftly the bird scares him with a sudden flop of the wings. Don't jerk the pup around roughly.

If you have a pup that isn't interested in a walking or flying pigeon you can be sure your pup either doesn't have much bird desire, that he is too young yet to be interested in birds or that you have done something to curb his interest.

It is possible for your pup to become disinterested in a planted pigeon (or any other type of planted bird) if you work him too long at a time or if you get too serious and firm in your training methods. Bird finding has to be fun for a puppy and he shouldn't be severely corrected on any bird until he is mature.

I think the prime reason a pup or a grown dog does not point a pigeon is the immobility of the planted bird. In the wild the bird moves out on the dog or flushes when the dog presses it too closely. The dog is then excited by the flush. As all this pointing jazz goes back to the dog's primeval instinct to catch birds for food, if the bird gets away several times the dog soon starts to hesitate and set the game so that he can spring in and catch it. You can simulate this condition to some extent with the planted bird by stationing someone near the plant and having them put the bird in the air when the dog approaches. Certainly once a dog gets the idea that he can run in and pick up a planted bird there is no reason for him to want to point it. If the



bird goes before he can get to it he is going to start to try and spring his game after a hesitation (point).

Older pups can have a great deal of their interest stirred by another method not previously mentioned. If your pup does not care particularly for pigeons but does love to retrieve sometimes just shooting a few pigeons and letting him bring them back will convince him that pigeons are great.

If you have fouled your dog up so he hates pigeons don't blame the bird. The fault is probably your own and be thankful that these errors were made on a pigeon and not a pheasant or quail because his reaction would have been the same. You would really have a problem if your dog lost interest in one of the game birds that you intended to hunt!

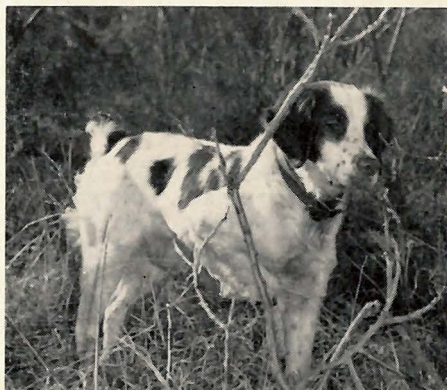

## TO THE *Breeder*

So you are planning a litter. Let us take a look at some of the things that are involved in a successful mating. Before you breed your favorite bitch, you must ask yourself two basic questions: (1) Is my female breeding material? and (2) How do I select a stud dog?

Assuming your bitch is OFA Certified; which should be a MUST, let's attempt to answer the first question. The ONLY way to answer it is by taking a good look at your bitch. Study her characteristics such as "type," disposition, endurance, bidability, staunchness on point, and trainability. All of our dogs have faults, and undoubtedly your bitch is lacking in at least one of these areas. The seriousness of her faults should determine whether you breed her or not.

In order for you to recognize any fault, you must first know what to look for. The only way to learn is by studying the breed standards and asking a lot of questions. Know what good "type" is and be able to recognize a good disposition. If you don't really know the breed, study it first before you plan that litter.

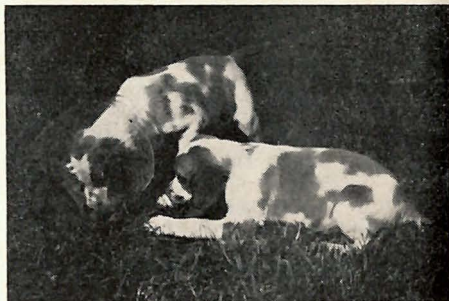
Then, if you can recognize a serious type fault in your bitch, such as over-shot or under-shot or poor running gear; don't even consider it. If she is an "untrainable," don't breed in hopes of getting a pup that is. The saying, "the bitch is 60%" is probably very close to the truth. Many feel the percentage is even higher.

In other words, "take off those rose colored glasses and look for your bitch's faults." They are there. If her faults are minor, and you decide to use her, keep them in mind when selecting your stud and breed away from them.

Now; the selection of the stud. First, you must consider your bitch's shortcomings, and look for an OFA Certified stud that will counteract them. If she is exceptionally "soft," don't breed to a dog with a similar characteristic. You will only compound the problem. If she is short on endurance, breed to a dog that is noted for endurance. Simply do the very best you can to find a stud

dog that will best compliment your bitch.

Second: Select a proven stud, preferably a Dual Champion or Field Champion from good lineage; one that has consistently produced winners and honest bird-dogs. Some studs seem, for some unknown reason, more dominant



than others, and thus really "stamp" their progeny. It is too bad, but there are also many titled dogs that stamp "mediocre" on their pups and seldom sire a winner.

Third: It is fortunate that we have so many titled dogs in our breed, and thus a large selection of studs to choose from. But, among this elite group are a few that finished their championships at an early age. These are the kind to breed to; dogs that have been consistent throughout their trial years; dogs that are always contenders.

Our breed is popular largely because of their trainability and consistency. We should strive to maintain these desirable traits. We can help the breed by breeding to these "early finishers;" dogs that demonstrate that "I'm the one to beat" attitude, day after day.

Lastly, and the most important to remember when planning that mating is, "Betterment Of The Breed." The only way that we can do this is by knowing the breed and by being honest with ourselves. If you really study your planned mating, and take it seriously, it is amazing how gratifying it is knowing you did the best you could.

Once you honestly feel you've done your best—that is all you can hope for.

## Trial Talk

The results for the fall of 1971 are in and the top winning young dog in the country emerges in **Hello Dolly Miss Kaer**. She is owned by her breeder, Nate Butchard, from his field champion, **Fisty Miss Kaer**, sired by **Char-Lee O'Dee**. Dolly capped a very good season of 8 placements with a Futurity ribbon. Pretty nice for a "pretty" dog.

Dolly was closely pressed by three contenders who each accounted for seven places. There was **Charger's Beau Teak of Duchess**, owned by a couple of new enthusiasts, Jean and Fred Williams. All Teak's placements were in the Puppy stake. **Solo's Pepperdust**, a fancy liver and white, owned by Mrs. Bill Hoffman had a mixed bag, both puppy and derby placements. This is one that will bear watching! **Fluke de Britt**, from the Gringo-Julia Tyler mating, did himself up proud for his owner, D. W. Dawson. Fluke's seven placements were all firsts except for two which were seconds, one of those being his Futurity placement.

A large group of youngsters won 6 places, nine in all. **Copper Creek Bobb** added placements to an already abundant record of a previous season. Bobb is a Holman-Olund product. Another Holman dog, **Albion's Black Magic**, this one owned by Jim White, made his placements all in the derby. He is pressing Bobb in total number of placements. Down Texas way we find **Royal Heide**, owned by Amos Armstrong. She placed in both her own area and in the northern segment of her region. **Don Juan de Britt**, from the same litter as Fluke, was owner handled and congratulations are due that owner, Frank Chesky, for such a fine record. This was the season for **Pacolet Cheyenne Sam** pups, the following three making the grade. **Wintertown's Jocko**, owned by the Ray Swensons from Virginia, in Holman's string, won four puppy firsts. **Windy Hill's Pacolet Ranger**, owned by Allen Wolkey, placed consistently in the Chicago area. **Wild Honey Anne Belle**, owned and handled by her breeder, Bob Wooldrik, made most of her places in

other breed trials. From the same dam as Anne Belle with a different sire was **Wyotana Buzzer** who placed in the Futurity. Buzzer did his major winning on the west coast, handled by Warren Butler who co-owns him with John Madia of Wyoming. The final dog with 6 ribbons was **Windy Knoll's Tinker's Pistol**, the first son of Hi-Spirit Bazooka's Pistol to show in the winner's column. He is owned by Bob Gibson.

There were only two juvenile's with 5 placements. **Holliday Chimbucktoo**, another Wooldrik owned dog, this one a purchase from the Oklahoma area, brags one Brittany trial placement on the record. **Penny's Two Rivers Bravo**, owned by Dick Knoch, had three blues among her five puppy places.

A look at the adult dogs shows that there were 23 dogs who had five or more placements. A count demonstrates the dual concept is still with us—11 duals in the group!

Topping the bunch, with nine placements was Dual Ch. **Faulkner's Reddy**. Owned and handled by Ejner Lund, Reddy is making a big impression in Gun Dog competition, both the non-shooting and the shoot-to-kill type. As with all the Lund dogs he almost always has impeccable manners and finds birds readily.



With eight places we find the following. **Tondee's Sandy Valley Duke**, a relatively new dual, is touted to be the best dog seen in the New England area for some years. His record of six firsts shows his quality. As he is completely owner-trained we give a special salute to Steve Tardy for that accomplishment. **Pacolet Cheyenne Sam** made appearances in the winner's circle all the way from Oregon to Upper New York, climaxing the season with the biggest win that can be made, the National Open Championship. Sam is, of course, a dual. **Allison's Rusty Rascal**, at eight years of age, is no newcomer to the winner's circle. He and owner George Allison

were clicking on all eight this past fall. Rusty won both Open and Amateur places in a lot of Texas trials.

The group with seven placements contains two dogs that placed in the Nationals, **Char-Lee O'Dee** and **LeCar's White Smoke**. Winning is no novelty to either of these dogs. Charlie has a total record of 73 places through the Nationals. Smokey, a bit younger and amateur-handled mostly by his owner Rosco Staton, has 40 placements. **Joel's Copper Jaques** also had seven placements. Jaques, now nearing ten years of age, has the phenomenal record of 17 first places in Open All-age stakes among his 35 adult placements. **Shamus**, in his first all-age season, performed well for Lyle Johnson. Pat O-Shaughnessy has reason to be proud of his dog!

Ejner Lund's other dog, **Black Butte Ricochet Trooper**, won six places. **Suzabob's Frisco Frannie**, who has been

a-knockin' at the door, made her field title, entirely owner-handled by Gerald Supplee. **Jacque of Connie**, another owner-handled dog (Kent Lipsey), did his thing—which was to complete a dual title at less than three years of age, one of the youngest duals. **Tyone de Malibeu**, Ben Sim's protegee, is a very fine dog and this season served to prove it again. **Sequani's Dana O'Teed**, owned by Maidza Van Deusen and in Rick Smith's string, is getting nearer that dual title all the time. All the above dogs had six places.

There was a large group who took home five ribbons. We will complete this column with them. **Killey** won three firsts and completed his title. **Suzabob's Hedgerow Happy** added to an already fine record. **Robbie's Robin** made it in several amateur stakes. **Skipper of Siouxlend** is a threat every time he is put down. **S'No Fun Mack** performed like his many admirers expected him to. **Rupe's Susie Que** won two firsts for owner Jerry Watkins from Texas. **Mar-ko Valkerie** wound up the season with a Nationals placement. **Nick of Columbia** is within a gnat's eyebrow of completing his title. **Bobby Day's Friar Turk** is almost there and **Marmalade Sara** made hers, the newest west coast dual.

## ARE OUR BRITTANIES SHY AND WHAT CAN WE DO ABOUT IT?

Author's name available on request

What is shyness? The dictionary defines it as bashful, easily frightened, or to start back or aside suddenly. A much more apt description is given by one disgusted owner, "They're sewer dogs, they could creep through a 10-inch sewer pipe and not touch any side just because you looked their way."

Nothing is more sickening to the owner than to reach down to pet a dog and have it either shy away from his hand or hit the ground as though it were about to be punished. Those who hit the ground usually have the disgusting habit of voiding at the same time. Owners of these dogs will attest to the fact that they receive especially soft treatment (one can't afford not to).

The owner of one of the dogs might bring it along and break it only to have it cringe when the handler approaches to flush the bird. This may be acceptable in a hunting dog, but the field trier can think of a lot of things he'd rather see.

How many winning puppies and derbies disappear after their derby season? One might ask if their dispositions aren't strong enough to stand the breaking process. If you don't believe this try standing around the puppy and derby stakes for a while and see how many bounce out of their crates ready to take on all comers. You will see few with the necessary disposition. How much pleasure can one get from handling a dog in either in the show ring or the field when it looks like the owner has just finished working it over.

As noted, the show people have the same trouble, how many dogs look like they'd rather be skinned alive than be in that ring. The minute the handler takes his hands off them the dogs hit the ground or at the very least look like a balloon slowly deflating. The handler has to be on his toes when the judge approaches as they shy from any contact with strangers. This same holds true when the dogs are measured. One wonders how many true size readings are had in the show ring as they cringe from the strange hands and measure

much shorter than they are in reality. This is not to say that every dog measured is shy, but it leaves one wide open for speculation after witnessing measurement after measurement.

How can we combat this fault? Mainly by using a little positive thinking and integrity.

The owner of the bitch has the greatest responsibility toward the breed, as they control what the breed will become. The owner of the bitch seeks out the stud and visa versa. Remember the greatest looking, best moving, strongest pointing bitch in the world is not worth the powder to blow her to kingdom come as a brood bitch if she is shy.

Given all the other things one looks for in a good Brittany, when it is coupled with shyness breeding is never justified. Should you own one with good qualities combined with shyness no one can prevent one from exhibiting it only please don't breed it.

The owner of the stud dog is not absolved from their share of the blame. Stud dog owners have been known to state that they didn't care what the bitch was like as long as they received their stud fee. It would be a pleasure to hear a few more stud owners state that they do not breed to shy bitches.

Perhaps it might be well for the stud owner to remember that they will be the sufferers if the breed deteriorates. One can always compare it to the Irish Setters and how they have been laughed out of trials because they are big glumping fools who can't point. This is because the breeders were too blind to what they were doing to their breed. Let's not let this happen to our Britts.

Should you raise a litter only to find that some of them show signs of shyness, the ideal course is immediate disposal. Barring this they should be sold without papers as pets or sterilized. Some of our more progressive breeders are now giving a money back guarantee against HD. Perhaps they might also institute a guarantee against excessive shyness.

It is sad to state that it has reached



the point where the exhibitor should consider finding a good brood bitch and raising a litter from a shy free stud. Let's hope this will not always be the case.

Those exhibitors who are not in the position to raise a litter regardless of the circumstances might do well to insist that they be given an honest evaluation of the disposition of the parents. Remember the Brittany grapevine works quite well and if you listen carefully you will hear more than the speaker means to convey. Should you purchase a pup that must be shipped and you would not have an opportunity to see the bitch, ask the breeder to ship on approval. Any breeder of integrity will do so. If that pup doesn't come out of that crate like a tiger send it back. This is experience talking, as disposition doesn't get better, it gets worse. Should you have a pup develop into a shy one don't be afraid to let the breeder know. In fact holler loud and long. Any conscientious breeder wants to

know these things before breeding again. Should you as an exhibitor find yourself with an outstanding field or show dog and you find that you are less than pleased with its disposition, refuse to let anyone breed him.

At one time this writer felt that this was an inherited trait with Britts and nothing could be done about it. Fortunately over the years it has been made very evident that, while this may be a major fault it is not a universal one. If those of you who own a good tough bitch would consider breeding to an equally tough male and advertise in the magazine as such, it might stimulate others to do the same. Only when we band together to eliminate shyness will we be successful.

Reply: Your good cut was tied up in the book. We knew you wanted the best picture in the book and so used the old cut in the magazine. It's better than no picture, isn't it! We could have removed the cut from the book but I am sure you would have been more unhappy at that.

Dear Nicky:

How come no pictures with our trial writeup?

Bob Secretary.

Reply: Same as above. All your winners are to be pictured in the book. We haven't been able to put much but cuts of very young dogs with writeups in the recent months. All the Champions are in the book.

Dear Nicky:

How come you put my dog's picture in when he won fourth and not when he won that big 54-dog stake?

Ron Winner.

Reply: I didn't know he won the 54-dog stake until after we had gone to press with the fourth place win. I can't use his picture twice in one season. It wouldn't be fair to all the others who own winners and want to see THEIR pictures.

Dear Nicky:

Why did you cut our writeup down?  
Ralph Reporter.

Reply: Each club is allotted two pages

for its trial report. We try to get in all the copy you send in plus several pictures of the winners. If it runs over a page we have to cut it. We have a budget that governs the magazine's size.

Dear Nicky:

Why don't you let each club have more space for their trial reports?

John Chairman.

Reply: We have 3000 members. About 200 of them are avid field trialers. Another 200 participate occasionally in trials. That leaves 2600 members who are just hunters. Many of these people join the club just to get the magazine. If we devote most of the magazine to trials there is nothing for this large segment of the membership. We try to put out a balanced magazine. Each issue contains the report of 8 trials. That number is necessary to get in all the year's writeups. There is one page devoted to dog shows for our show people. Then we try to have something on health, training, breeding and genetics. We strive to have one article in each magazine of interest to each member. If we gave in to the constant pressure from field trialers for more space for trial news we would be short-changing the bulk of our membership.

Dear Nicky:

I notice you never run a picture of \_\_\_\_\_? After all, he's one of our top winners. I hear you don't like him.

Adam Britfan.

Reply: I would gladly run \_\_\_\_\_'s picture except for one thing. I don't have a picture of him. I have asked his handler to send me a picture but, to date, he hasn't. You will note I also do not run a picture of \_\_\_\_\_ (just as prominent a winner). In his case his owner sent me a nice picture but no fee was included for a cut. I usually just file any pictures that arrive without the proper fee but, in this case, the dog was winning so often, I wrote and asked the owner for the \$4 fee. No fee has been received. I would be playing



favorites if I had a cut made of this dog without that fee. And despite what you hear I try very, very hard not to show favoritism!

Dear Nicky:

I called you about my dog being OFA certified now and you still haven't put a \* before his name in the Stud Listings.

Jim Goodbreeder.

Reply: The policy on OFA certification is that we must receive either the notification which comes once a month from the OFA direct to us or you must send us a photocopy of your certificate for our files before we recognize certification. It is not advisable to phone in **any** important information. Notes taken from phone conversations may get lost or be unintelligible. That very often happens.

Dear Nicky:

That was a horrible cover picture. Who wants a donkey on a dog magazine?

Dear Nicky:

That cover was great! Did someone really ride a donkey at a trial. I thought it was a riot!

Dear Nicky:

That was a real dumb article last month about the history of field trial rules. Who cares about what the rules used to be?

Dear Nicky:

That article on field trial rules was great. It gave a good insight into why some of our rules are the way they are. How about some more articles on what used to happen in the club because we have so many of the same problems now as we did then. It would be nice to know how they were solved years ago.

Comment: If you don't like a feature you can be sure someone else does. We can't present just one side of things, you know.

Dear Nicky:

I think we ought to have color covers every month. I am enclosing a snapshot you could use.

Reply: It's a pretty snap but much too small to blow up to cover size. A cover photo should be nearly actual size to be of any use to us. We are

planning to discontinue the color covers because of the costs involved. We cannot justify an increase of about \$500 per issue just to give us a color cover. We feel the money can be better spent for additional pages of material.

Dear Nicky:

Did you write that unsigned article in last month's magazine about "Buy, Breed or Trade to Get a Good Dog." I don't think that unsigned articles should be published.

Arthur Asking.

Reply: The article was submitted by a member who requested that it be printed without the writer's name. Of course the name of the writer of any article in the magazine is available from the Editor upon request. We will not print an article unless we know who wrote it and have their permission to reveal their name to interested parties. Several of our best contributors prefer NOT to have their name on their articles. Some of the unsigned articles are written by the Editor, too many in fact. When we have blank pages to be filled and no material submitted we have to write something to fill. We do not feel it a good policy to sign everything we write, objecting to having our name spread all through the magazine. If you don't approve of unsigned articles and articles written by the editor you should make an effort to contribute articles yourself. We use almost all the material that is sent to us. A recent trend seems to be towards members sending in more contributions. This we welcome as it is not right for the editor to have to contribute so much to these pages. The editor should be just that, an editor, not a feature writer.

Dear Nicky: Who wrote the letter in the last Speakout?

Reply: A good many of our features are composites of material sent by several people. We frequently get several letters along the same line and combine the best features of each rather than publish repetitious material.

## BLUE RIBBON *Breeders*

As a Blue Ribbon Breeder for 1972 I promise to:

1. keep accurate and complete records of all stock, their matings and their pedigrees.
2. maintain and pass on to purchasers factual health, breeding and registration records. I promise to furnish a signed registration application or transfer with each puppy sold unless a written agreement is made with the purchaser at time of sale that papers will be withheld. I will withhold registrations (by written agreement) on all dogs with hereditary faults of such nature as to make its use for breeding detrimental to the breed.
3. breed scientifically and selectively by mating only sound dogs of good type and field ability to reduce faults to a minimum and to secure puppies of type, ability and temperament that will be a credit to the breed. I will never breed dogs with known physical defects.
4. breed a bitch no oftener than two heats out of three nor prior to one year of age.
5. humanely destroy all crippled and deformed individuals unless unable to do so for moral (never pecuniary) reasons, in which case such dogs will be neutered before being placed in new homes.
6. maintain the best possible standards of health and care in all my dogs. I will sell only pups that are healthy, free of parasites, never before they are 45 days old.
7. refuse to deal knowingly with unethical breeders, pet shops or wholesalers and will try to place each individual in a home where adequate facilities are available for the dog and where it will receive proper care.
8. seek the advice of other more experienced breeders when necessary.
9. show good sportsmanship in field trials, in the show ring and during the hunting season. I will not speak ill of other breeders or of their dogs.

10. keep in mind that the good of the breed comes before any personal benefits.

A master list of persons who subscribe to the Blue Ribbon Breeders has been prepared and will be sent to all who inquire of the ABC office where they can get a pup. We don't expect many of the Blue Ribbon Breeders to have pups available at all times but we do hope that they may answer inquiries by referring the possible puppy buyer to a source where he may obtain a good specimen of the breed. It is also hoped that any inquiries about stud service will result in a thorough investigation of the reasons the person wants to breed, his facilities for raising pups, the quality of his bitch before putting him in touch with a suitable stud owner.

## NEW BREEDS?

Many hunters are more convinced than ever that years of shooting have bred new traits into quail and pheasants.

The reasoning goes like this:

Birds that tend to flush and fly in the open are good targets, and are the first to be shot. Therefore, quail that fly into timber and pheasants that sprint down the corn rows and never fly at all are the most likely to survive and breed—and their behavior traits are hereditary. Results: strains of pheasants that are more likely to run than fly, and quail that always flush to the timber.

We can't disprove it. But we doubt that basic instincts are so quickly and

neatly developed. It reminds us of that catfish farmer who clipped spines off his breeder catfish for several generations, hoping to develop a hornless catfish. It didn't work.

What's happening to quail and pheasants probably isn't hereditary, but environment. Quail may fly to timber because that's where the only real escape cover is, and they find it out. Maybe ringnecks seem to run more because so many fields are getting bigger and cleaner. What else can they do? Where's the cover to hold them until they flush?

It seems to us that pheasants in heavy grass or weedy cover hold just as tight as ever, and quail jumped in good fields don't always head for timber if there's a better place to go.

All in all, ringnecks and bobwhites seem to behave about the same as the birds we knew in 1939—when we're hunting in 1939ish country. But when we're hunting in 1970ish farmland, tilled clean and with all non-economic cover shaved away, the birds seem to know the best ways to get out of there. You can't much blame 'em.

## The Protester Asks

I have asked this question of many judges and friends, but never seem to get a positive answer. I would appreciate having you speak-out with an opinion or perhaps the result of some survey that I have missed. - - - Is the bird field used in a trial to compensate for the lack of native birds or to prove that a dog can be contained in a five acre field for eight minutes? - - -

If the latter is true, I feel we are teaching our young dogs a dangerous lesson, that being, that birds are not connected with objectives but more related to a lot of hollering and possibly the presence of people, cars and much human scent.

I feel the birdfield should be used as an equal opportunity for all dogs to find game. Once a dog has proven his ability on game (particularly a derby dog) and decides that logical objectives lie beyond or outside the four flags I feel he should be allowed to reach for that objective without feeling he is being reprimanded by his handler and being scolded back into the birdfield.

I have been told that, if a dog leaves the birdfield, he is off the course and disqualifies himself.

## The Establishment Replies

In theory the field trial is supposed to simulate as near as possible the conditions in an average hunt giving as equal an opportunity to each contestant as can be arranged.

In practice results may depend on the experience of the handler and the judges. An experienced handler can maneuver his dog on the backcourse and handle him in the birdfield to take more advantage of the situation than a green handler. An experienced judge is going to give a handler as much latitude as possible in presenting his dog's abilities. The inexperienced judge is the one who is going to insist that the dog stay within the bird field flags and show great "control."

The older (in terms of experience) judge is going to be aware that any

puppy or derby worth his salt is not going to stay in a birdfield where grass is like a lawn when there are brush and trees within easy reach. Oh yes, he will make a pass or two through the bare cover. Then if he finds nothing to interest him he is going to look for better cover. Frequently the birds have been as smart as the dog and have left the doubtful sanctuary of the grass for the better cover in the brush. Field trial committees should be aware of this situation in laying out the courses. Perhaps that is where the blame for any problems can be paid—on the heads of the people who plan the courses.

Puppies can be allowed more latitude than derbies. It certainly makes a big-going pup look bad to try and hack him and keep him within the confines of a 5-acre field for 5 minutes when he wants to go to better cover. I see nothing wrong with letting him go wider after he has thoroughly checked the birdfield. It is smart to check with the timekeeper, let the pup reach and run until a minute before pickup and then try and lean on him a bit so that you have him coming into the birdfield area at pickup time. Most experienced judges will be satisfied with this performance. Derbies should, of course, be showing some sign of starting to handle. You are not going to win without a good find, so if the birdfield yields nothing after a reasonable search you have got to let the dog work wider to try and have game contact.

There are judges who will ask you to keep your dog within the confines of the birdfield. If they do you must make a decision whether to let the dog do what is best for him or whether to heed the judge, hack the dog in and try to win a placement.

My pet gripe is the marshal that tells you where to put your dog on the backcourse, directs you to pass to the right or left of a certain bush or tree, informs you that your dog is off course when he makes a good cast and then expects you to work the dog under foot



in the birdfield. The marshal has no business doing more than telling you which way the course goes and when it turns. It is the handler's prerogative to work the dog the way he sees fit and to produce the results. Now if the judge directs you that is another thing. If he wants the dog kept within certain bounds that's up to him, but I wouldn't bother putting dogs down under that kind again.

In my estimation there's no such thing as a dog being off the course or out of contention unless he is gone for more than the time prescribed in the Orange Book. Of course I don't condone a dog running wild and never checking to his handler—but if a dog runs forward, checks from in front occasionally he's doing it right. The adult dog should hunt the birdfield thoroughly, going to the places birds might be. The adult dog should also take direction in the birdfield for the simple reason that some bird planters don't know where to plant and pick unlikely places where a smart dog would know no bird should be. In that kind of a situation the handler should take over and direct the

dog to search the places the bird planter had been using. A find that the dog makes on his own, completely without direction, is so much better than one he is directed to but sometimes you gotta lead him to the bird.

Part of the trouble is too small birdfields. If the area is large enough and the cover good there shouldn't be much trouble keeping a dog working in the birdfield. It's only when the area is too small and the cover beyond too beguiling that troubles emerge. Some clubs lay out their birdfields with the average derby in mind. You get in one of them with a big-going derby and you've got trouble. You are not going to keep him in the area without hurting him. The right kind of judge is going to see that and give you some latitude.

If you want definite answers to your questions there really aren't any because each individual course and each dog require a different solution. Because a dog steps outside the flags that mark the birdfield edge does not mean that he is disqualified. At least I can't find THAT rule in the Orange Book!

Oklahoma State University will host the first National Bobwhite Quail Symposium at Stillwater, Okla. on April 23 through 26, 1972. Experts from all over the country will gather to discuss the bobwhite, with the emphasis on management and ecology. "Trends in Principal Management Themes." "Current Problems and Methods in Bobwhite Management." "Current Research on Bobwhite Life History" and "Landholder-Sportsmen Relations" will be some of the subject areas under discussion.

The program will begin on Sunday, the 21st at 1 p.m. with a field dog demonstration in which a selected group of various breeds will be shown in a field trial type situation. Experts will comment on the dog's performances. This demonstration is open to the public at no admission charge. The committee will select two shooting dogs, typical of their breed. Every effort will be made to allow anyone in attendance to record the commentator's comments or to photograph the dogs.

There were 25 entries in the Heart of America GSP trial. First place winner was **Gringo's Butterscotch Taffy**, owned and handled by Jim Woltering, Woltering's first blue ribbon!

**Beaupere**, owned by Keenan and Bierer, placed second in the Amateur Gun Dog at the spring trial of the Greensburg Pointer and Setter Club. Beau was also awarded the Dog of the Year pin for the dog amassing the highest number of points in licensed trials for 1971. He was runner-up in the Fun Trial award category being defeated there by his son, **Beaupere's Handlebar Hank**. Not bad for two short-tails in a long-tailed world!

Ike Zamrzla made headlines in the Oklahoma City paper when he scored a double by winning the Open Gun Dog and the Open All-age with **Boy's Little Rex** in the Irish Setter Club of Oklahoma's trial. The only other Britt placing was **Charlie Bob** (Melot) who was second in the Puppy.

## FALL TRIAL

The North Jersey Brittany Club held its fall 1971 field trial at the Assunpink Field Trial Grounds, Monmouth County, New Jersey on October 16 and 17, 1971. This trial marked a dramatic departure from conditions prevailing in the past in that a fifth stake, an Open Gun Dog stake, open to all pointing breeds, was included in the program.

Saturday morning presented a sky filled with a pea soup fog and the breakaway for the first brace in the Open Puppy, Open All-age and Open Gun Dog was delayed until about 9:15 a.m. Even then, visibility was poor and some of the dark German Shorthairs in the early braces of the Open Gun Dog were difficult to observe. The club was gratified to receive and accept 127 entries and this fact attests to the very high caliber of the Assunpink grounds. Three stakes of one-half hour duration can be run simultaneously without any problem and, particularly in the fall, native pheasant are abundant.

The Open Puppy, run under the judgment of Bob McKowen and Herm Levee, was captured by Suzabob's Hey You Willie. Right on his heels was another Suzabob pup, Spike Hamilton. Both dogs exhibited all the snap and desire one likes to see in a puppy with Willie going just a bit wider than Spike.

The Open All-age is a graphic illustration of a winning habit. Dual Ch.

Tondee's Sandy Valley Duke, owned and handled by Steve Tardy, was just about unbeatable in the Northeast this season. He just does it all everytime down. Duke also won first place in the Amateur Gun Dog on Sunday, thereby capturing a second leg on the Alan Stuyvesant Memorial Trophy presented by the club to the winner of the Amateur Gun Dog Stake at each trial. Fld. Ch. Jamie's We Go Jill took the red in the Open All-age and Ch. Ja-Dor's Little Dee Dee followed suit in the Amateur Gun Dog stake.

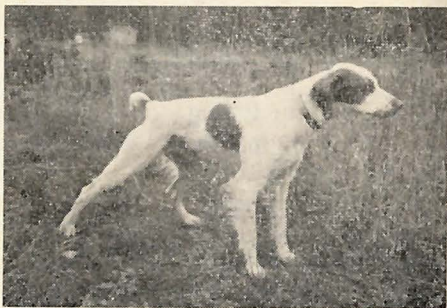

#### **FOR THE GAL'S**

1. Boil one pheasant until tender, with medium-size onion, two leafstalks of celery, salt and pepper. When pheasant is tender, remove from broth, strip meat from bones and dice in large pieces. Strain, and retain three cups of broth.
2. Dice fine one medium-size onion and some celery. Saute this in one tablespoonful of butter until tender, but not brown.
3. Melt half stick of butter in saucepan and add three heaping tablespoonsful of flour. Stir until well blended, without browning. While mixture is hot, add to strained pheasant broth brought to a boil. Stir well until thick and smooth.
4. Remove thickened broth from heat and add a little Worcestershire sauce and a few drops of yellow food coloring.
5. Add sauted onion and celery. Mushrooms may be added if desired.
6. Place diced pheasant in a pan or casserole dish, pour in thickened broth and cover with a rich pie crust. Bake at about 450 degrees until pie crust is brown and done. Serves four.

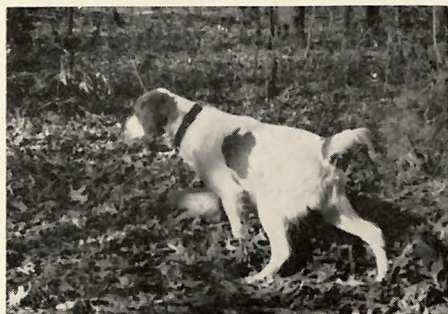

## SPRING TRIAL

### A FIELD TRIAL CHAIRMAN'S NIGHTMARE

The Alamo Brittany Club spring trial turned into a field trial chairman's nightmare. On Thursday evening, January 27, the field trial chairman and his committee had felt that the upcoming trial was going to be very exciting. The grounds were very good, there were plenty of birds available, and friends had been calling all week, making reservations.

On Friday, the weather north of San Antonio turned very bad and a front began moving on the city. This was coupled with a near epidemic outbreak of Asian flu.

The first indication that it was going to be a hectic week-end came early Friday morning when one of the judges called to say that he had been stricken with the flu and would not be able to judge. This call was the first in a series.

Just prior to the drawing on Friday evening, the committee was aware that the trial as very best would be small in number. Professional handler, J. D. Fountain, sent a message through saying that he had started for San Antonio, but was really too sick to continue. Ed Wild finally arrived from Oklahoma saying that weather conditions were so bad north of Dallas that IH 35 had been closed.

Nevertheless, the drawing proceeded with 33 dogs entered. Before the commencing of running, other dogs were scratched.

The weather on Saturday, while chilly with a slight rain in the air, was what local hunters and field trialers consider good dog weather. If anything, there were too many birds and too much scent on the course. All-age dog after all-age dog would cut its throat, some dogs having as many as ten finds, nine of them clean and then just not being able to stand as covies broke around them. The results of the All-age stake were disappointing to judges, committee, and handlers alike. The judges felt that no dog met the qualifications for first place, and it was withheld.

The Derby stake, however, was much more exciting and Lester Mays' dog, Repeat, ran wide, making beautiful casts and had that wonderful characteristic of when he got separated from his handler he would run up the course, only to appear a couple of hundred yards ahead, cutting across in fine style. The judges felt this dog was the number one derby dog and field trial marshal and committee were very much in agreement.

The Puppy stake followed the Derby,



and there were some very flashy puppies shown. There were a good deal of birds on the puppy course, not any particular design, but just because the field ground contained so many birds. The first brace spent most of its time running the birds off the course. Amos Armstrong's dog, Tammy, showed a strong characteristic to negotiate cover as well as birdiness when she would make bird contacts. She showed enough run for the judge to place her third. There were birds on the course almost every brace. Royal Armis de Dumas showed a good race, had several bird contacts, and negotiated cover well. The judges felt this was good enough for second place.

Leon Milligan's liver-colored puppy handled the cover very well and showed good puppy tendencies, giving promise to a real future field trial dog. Mr. Milligan elected to handle his dog on foot, and this may have put an additional burden on an otherwise fine puppy. The judges placed it fourth. The gallery was somewhat surprised, however, when the judges put Cheyenne Sam's Repeat in first place as the puppy seemed to tire badly at the end of the race.

While the problems on Saturday had been difficult, most of them had been solved. However, the dog wagon was still stuck axle-deep in the mud and the course was deteriorating rapidly. Saturday's cool and windy weather was now replaced by Sunday's high winds and heavy rain. Several dogs were not run and other handlers called to say that they had taken ill either with the flu or with bad colds and the entry deteriorated to seven dogs. It was finally won by Athos, more by default than anything else.

In short, anything that you've ever feared could go wrong with a field trial either went wrong or could have gone wrong in this one. However, it is to the club's credit that they arose to the occasion, that marshals and people with responsibility stuck to their jobs through cold weather, miserable conditions, and a general lack of enthusiasm by handlers. I am sure that a club that can weather this kind of storm is a club with strong promise for the future, and field trials beset by less problems should run like clockwork.

The next stake to run was the Open Gun Dog. The only Brittany to place was Nojo's Suzi with Jack Brooks handling.

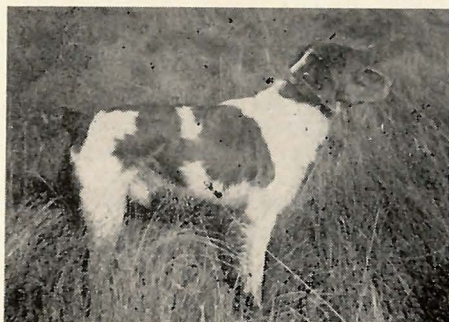

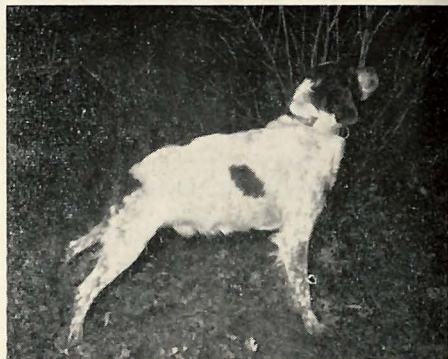
