

### Hall of Jame

The ballot for the Hall of Fame for 1972 is enclosed in this magazine. Please note that you may vote for as many as two dogs and one bitch if you so desire. The deadline for voting is September 15. Dogs must be dead in order to be eligible for election.

Your ballot will be found on the inside of the front cover of the mailing wrapper of this issue of the magazine. The official ballot must be used in reg-

istering your vote.

Questions have arisen as to why only certain dogs were reviewed in last month's magazine. Last month's list was compiled from the records of the voting of the previous year. All those who had a substantial number of votes were listed. Also listed were a handful of dogs that had died during this past year and whose owners or friends had suggested them for the Hall of Fame. A request was made in the June issue for nominations for this year's election. If your favorite is not included it is because you, or someone, must nominate the dog.

We have the following letters of nomination.

Dear Editor:

I heard that Amer. & Can. Dual Ch. Way Kan Jeff made a very strong showing in last year's Hall of Fame balloting. I would like to bring him to the members' attention again this year. Jeff was an exceptional dog, rated by one of his pro handlers as the best chuckar dog he had ever hunted over, by another as a potential National's winner and by still a third as one of the best dogs he had got his hands on. Jeff placed 56 times in AKC trials and had quite a few American Field places too. His placements ranged from amateur shootto-kill stakes to two Pheasant Classic places and one in the Quail Classic, He was strongly in contention in the two National in which he participated. The list of the winners he produced is going to be longer but it is now at about 20. Three of his progeny have already got

their field championships, and one of them (Fritts) won the Nationals. My vote goes to Jeff again this year. He deserves a niche in the Hall of Fame. B. E.

Dear Nicky:

It gives me a great amount of personal satisfaction and honor to place the name of Fld. Ch. Towsey's Bub in nom-

ination for the Hall of Fame.

Bub began his long string of wins by placing in some Open Derby stakes in the spring of 1958 and had a total of 63 placements in his career. In 1962 he placed 4th in the National Championship and that same year received the Dual Dog award. At Nationals in 1963 he placed 4th in both the Amateur and National Championship. In 1966 Bub won the first American National Amateur Championship. He was on the Sports Afield All American Team in 1967. Bub was campaigned largely in the Midwest where he regularly competed against some of the best Brittanies in the United States.

Towsey's Bub has sired one Dual Champion and four Show Champions.

Several things made Bub an outstanding dog. He was handled almost entirely by his owner Marvin Nelson, who is an Amateur. He was a great bird dog seldom going birdless in a field trial stake. He was used extensively as a hunting dog and was a family pet, as every Brittany Spaniel should be.

### SIMPLIFIED Breeding

Any serious-minded breeder who intends to breed a litter of Brittaines should have at least a superficial knowledge of genetics. An in-depth study is to be preferred if one intends to start a lengthy breeding program. May we suggest the study of "Genetics of the Dog," by Burns and Fraser that is published by J. B. Lippincott. It is a good reference book for the dog breeder.

The science of breeding is based on the Mendelian Theory, from the discoveries of a monk named Gregory Mendel. He found that crosses of two different types of peas resulted in predictable patterns of inheritance. Basically it works like this in dogs.

Pups receive "genes" from each parent. These genes are arranged in strings, like beads, called chromosomes. These chromosomes are present in each body cell and the number is determined by the species. Man, for instance, has 46. The dog is said to have 78. Now these chromosomes come in pairs and, in breeding, the pairs separate so that the newly formed pup will have 39 pairs, with one portion of each pair coming from each parent. So a pup's inheritance will come equally from both parents.

Different genes affect different characteristics. The color gene is one of the simplest so we will use it for an example. We will let "B" stand for the liver color and 'b" for the orange. B is dominant (or stronger) than b so that any dog who has B in its makeup will be liver. Thus a dog could be BB or Bb and be liver in appearance. An orange dog could only be bb.

Let's breed the BB to the bb and see what happens. The pup will inherit one gene from each parent so all the pups will be Bb. This means that ALL the progeny from a dog that is pure for the liver characteristics will be liver.

Now let's breed one of those Bb liver dogs to another Bb dog. Take one letter from each parent and combine them as nature does. Some of the pups will be BB, others Bb and still others bb. Practically this means that some of the liver pups from this mating, being BB's, will produce only livers. Some of the

Now let's breed orange, bb, to orange, bb. There's nothing but b involved so the pups can only be b (orange). It is therefore genetically impossible to breed orange to orange and get anything but orange.

ATTE TITE CT. ...

The B is called a "dominant." It overrides the less potent orange b and is apparent to the eye whenever it is present. Dominants are easily retained or rejectd in a breeding program and

cause no particular problem.

The b is called a "recessive." It can be present and yet not be visible. This is the little devil that causes the breeder so many headaches. A line can carry a trait recessively for many generations and it will never appear until it meets with a similar recessive gene and then up it pops. It is possible that the tricolor gene works in this manner as well as the gene for chryptorchidism.

Two other terms found frequently in literature about breeding are homozygous and heterozygous. Simply, again using the B and b symbols, a dog is homozygous (or pure) for a characteristic when he is BB. He is considered heterozygous (mixed) when he is Bb in

character.

Breeding would be simple if this is all that there were to it, the inheritance of single characteristics. But we have 36 pairs of chromosomes made up of numerous genes and all these genes are not as simple of the above example that controls color. The color itself is more complicated. There is a factor controlling the shade of the color which, in the orange, may vary from deep mahogany to a light lemon yellow. There is a factor for ticking, one for spotting (the small spots on the muzzle and legs), another for the area of color on the body. A breeder may breed for years before being sure which characteristics dominant and which recessive. which simple in inheritance and which influenced by multiple factors.

To further complicate breeding not only are there characteristics that are inherited (called the dog's genotype) but there are also characteristics that are formed by environment and experiences (called the dog's phenotype). A knowledgable breeder must be able to

Entries closed for this fall's Futurity on August 1. All entries have been acknowledged. If your acknowledgement has not been received you MUST contact the ABC office before September 1.

It looks like a record stake will be run at Paducah as well as a large show. Plans are well under way for the two events. Larry Wallace is heading up the committee in charge.

Every year we receive questions about the type of performance that is going to be expected in this stake. All tield trialers are aware that individual judges have different ideas about placing derby dogs. Some put more accent on birdwork, others on range and pattern. Therefore it is difficult to say exactly what will be expected.

Basically the Futurity is judged as a Derby Stake. There are differences, however, because this is a breeder's stake and more accent is put on the potential of the participants to become a good influence in breeding. Style and class are more important in this stake than in an ordinary Derby Stake.

The ideal performance would be a big race that carried the dog to all the proper objectives. The dog's running style would be attractive with high head and tail. The dog would find birds. He would point with intensity and hold his point while the handler flushed and fired. He would finish as strong as he started. This is the ideal.

In actuality the winning performance will probably never reach the above pinnacle. In most previous Futurities there have only been a handful of dogs (four to eight) who have pointed and held birds long enough for the handler to show the dog to the judge. In many stakes the quality of the second, third or fourth place dogs has left much to be desired in range and style. The first place dog usually met the requirements for the stake. Perhaps this is because almost every year, the outstanding ranging dogs have been called back to try for birds.

Different people have different theories as to why the performances of

our outstanding derby winners are not impressive in the Futurity. One of the most interesting theories advanced is that the Derbies are run in too many one course trials. They become indoctrinated into a routine of running hard for 20 minutes and then looking for birds. They expect to work up close to a planted bird and point as closely as possible. That this theory has basis can be seen when the dogs are oberved to run well for the first half of their race and then pull in and work closer and more slowly for the last part. It can be seen in the fact that many of the Futurity hopefuls will scent their wild birds and work directly in on them, flushing them without the slightest hesitation. As any hunter knows the wild birds won't hold for the dog to point right over them the way a planted bird will. Perhaps our overall quality of Futurity performance would be improved by training the young hopefuls almost exclusively on wild birds. Perhaps the greater number of amateur handlers being successful in this stake is accounted for in that amateurs have the time to get their dogs on a lot more wild birds than the professional.

If you have a dog that will hunt well, will find and handle wild birds, even if he will only point long enough for you to flush his birds, you will have the type of dog that has placed in previous Futurities.

determine if a dog's shyness, for instance, is due to heredity or to some experience the dog has been subjected to.

There seem to be numerous facets to a dog that could be caused by heredity, environment or both, skin problems, temperament differences, size, length of coat, etc. It would certainly be extremely helpful to future breeders if some of the breeders of the past and present would keep records on various traits that they have been able to breed strongly into or out of a line. Then tomorrow's breeder would not have to start from scratch as we do today.

A bird dog will run for two reasons; because he feels good and because he wants to.

Feeling good depends on physical fitness. This relates to three basic fundamentals, food, rest and exercise. They are all important. Like a three-legged stool, one depends on the other.

Food is probably the easiest of all to acquire for our dogs. The dog food companies have done a good deal of research and have produced foods that are excellent in providing the dog with all nutritional elements like vitamins, minerals, protein, carbohydrates, and all the other essentials of a balanced diet. Maybe a little meat added for taste might help but not too much as it spoils the balanced diet the dog food company has so scientifically prepared. If the dog is working hard enough to get thin some fat, like bacon drippings or suet or cracklings, can help keep the weight up.

Overfeeding is probably the biggest single fault of most dog owners. A fat overweight dog can't possibly run or hunt too long. Even a wolf won't hunt with a full belly. The hunting instinct is always keener with the dog that is a little hungry. On the other extreme a half-starved dog will be too weak to run much. So the amount of food that would be just right is the amount that would keep the dog just a little hungry all the time. This amount may vary up and down according to the amount of work and activity of the dog. Most dogs can eat about four times as much food while being hunted full time, compared to the same dog in the off season.

Probably one of the best guides in determining the right amount of food would be the firmness of the stools and how fat or thin the dog is. How fast he gobbles his food down has nothing to do with the degree of hunger. Some dogs eat in a big hurry and others pick at their food—merely individual eating habits.

Most dogs that are full grown will do their best on one feeding a day. Because people get hungry three times a day has no bearing whatsoever on how often a dog gets hungry. Wild dogs of yesterday usually ate every four or five days—just whenever he could find food. Then he would eat enough to last for a long time. Some books on canine nutrition recommend skipping one day's feeding at least every two weeks.

So the conclusion is feed good quality food and just barely enough to keep the dog slightly hungry for maximum performance.

Rest sounds simple for a dog because all of us have watched dogs sleep peacefully sprawled on a rock pile or maybe curled up in the snow. This physical rest is easy. It's the mental rest that presents a problem. Boredom, loneliness, jealousy, other dogs barking and many other factors can cause a dog to be miserably unhappy so that he gets little mental rest. Peace of mind is needed in both man and beast.

Some things can help some, like a bone or toy, a pleasant kennel mate or a little playtime once or twice a day. A dog needs reassurance. By all means do not leave the dog overnight after disciplining him. Leave him happy.

Now exercise is probably where most dog owners fall short. It takes a lot of time to give a dog all the exercise he needs. Again, like feeding, too little exercise is bad and so is too much. The secret is to give the right amount and that gradually increases as the dog becomes more and more fit.

At first the dog needs a very short run, maybe five minutes. Then ten twenty—thirty and more. Gradually increase the amount.

Heavy exercise, like pulling in a roading harness, can give a dog more exercise in less time. Running conditions at a more rapid pace than walking. If the dog is working hard enough to huff and puff, he might stay in fair condition with thirty minutes workout three times a week. However, to really build up his lungs, heart and blood vessels (what you might call real physical fitness) he needs longer and harder work. Long easy workouts build muscles and

strength. The competing dog needs both strength for speed and drive and stamina for endurance. So just the right balance of both kinds of exercise is ideal. Yet who can come close with such interferences as weather, lack of time and many other circumstances forced upon us in the rush of present day living?

To start with good running ancestors is a must. Too often we see offspring of five generations of running dogs fall flat. The question is why. Many factors add together. The natural hunting instinct creates what is called desire in the rule book. The desire to search for and find game probably stems from ancient times when a dog hunted for his food or starved to death.

Certainly most dogs run a little more just to please a proud owner or handler. They like our praise.

Numerous other small things enter into the total man-dog relationship that can either help or hinder the dog in his running. Holding the dog back by the collar or command at breakaway, even in training, seems to accumulate a little bigger head of steam, so when he is released he has built up a little extra supply of go for his first cast.

Timing of signals is probably the most important of all factors in encouraging a dog to go at first. The handler should time his signals to fit exactly what the dog is going to do anyway. For example, toot the "go" signal the instant a dog is released. When he stops for any reason, be ready to toot "go" the instant he starts to go. Responding to the whistle soon becomes a habit. When the dog approaches a fence and will positively have to turn is the instant to toot the turn signal. As soon as go and turn signals are a habit extra care should be used to be ready with one or the other the instant the dog looks back for a signal. A few seconds too late will destroy the dog's confidence in his handler in a very short time.

A good tight fence is an aid in getting the young dog to come when called. Set your foot on a fence and call the dogs. When the young dog ignores your call, help the others over the fence and walk right off and leave the disobedient dog behind. He will bark and cry awhile

but if you are real patient he will find his way through sometime later. It doesn't take many of these lessons to get the dog to come in promptly even from a great distance.

The art of being obnoxious helps a dog to run better. Some puppies are so happy right near the handler's feet that it's necessary to be obnoxious to the pup. Try throwing a handful of shelled corn in his face when he comes in close. Use a grouchy voice every time he comes in. The tone of the voice is very important. That tone can change from sounding like sandpaper on the vocal chords to a sound like honey. sweet tone is used when the dog is doing right and the mean, grouchy tone when he is doing wrong. Overdoing this obnoxious idea will cause the dog to run off and bolt completely, so you need to find just exactly the right delicate balance between being obnoxious and sweet.

It takes work to get a dog to run but most dogs will run some if you plan it right. To repeat, the dog runs because he FEELS fit and WANTS TO. It's up to you to create those conditions.

## HEALTH HINTS

The dog has two anal sacs, one on each side of the anus. They can become clogged and even infected if not properly cared for. A sign to watch for is scooting the hindquarters across the floor or biting and chewing the rear end. This biting and chewing is most frequent during hot weather. The sacs should be checked for impactation at regular intervals. The thumb and first finger are placed on opposite sides of the anal gland and the area gently squeezed. A paper towel or Kleenex is held in the other hand to catch the material ejected. This material may dribble out as a thick paste or shoot out in a more liquid stream. It is very foul smelling so that, if some gets on the dog's coat, you will probably want to bathe the area immediately. If the sacs become infected and bleeding it is a problem for your veterinarian. Abscesses may form. If the condition continues to occur it may be necessary to have one or both removed by your veterinarian. The operation, a minor one, is similar to the procedure used to remove the scent glands from skunks.

Hexachlorophene, an ingredient commonly used in deodorant soaps, has been found to be poisonous to animals. It causes brain damage and paralysis in dogs. Keep your soap out of reach of your dog to prevent such a happening to him.

A new drug that can be added to the dog's food daily for continuous protection against hookworm has been discovered. It can be used on pregnant bitches. The drug is a combination of styrylpyridinium chloride and diethylcarbamazine was developed by a group of workers at Princeton. Experiments showed that it was 96% efficient when used for seven days. Better results were obtained from longer term treatments.

The mortality rate among pups from birth to weaning time is about 30%. Some recommendations to be followed that may help decrease the rate are: Diet should not be changed during the heat period or directly prior to it. The

amount of food given and the type of food should not be changed immediately after breeding. Additional food or supplementary food should not be given until about the fifth week of gestation.

There were more rabies cases reported in 1971 in the United States than in 1970. The increase in rabies in skunks accounted for the difference.

Glazed pottery dishes for dog food or water are a no-no. Certain types of pottery from Italy and Mexico are found to release enough lead under ordinary use to cause lead poisoning.

Recently in Britain a study was made of the estrus cycles in bitches. It was found that more bitches came in heat during February to May and October to January than did during the summer months. The average interval between heat periods was 29 weeks. If the bitch became pregnant the average interval between heats became longer, 32 weeks. Animals living in northern areas had a higher percent of cycles beginning during the first part of the year.

Dr. John Craige of Monterey, Cal. has reported that there have been outbreaks of influenza in dogs in California. He claims that it has been established that Influenza B virus can be transmitted to dogs.

A panel of veterinarians were of the opinion that, if a dog's testicles were not descended by the time he was ready for his first distemper shots that the dog was quite apt to be a chryptorchid. Some were of the opinion that testicles descended slower in the larger breeds, that testicles in fat puppies were less palpable at an early age, that the smaller breeds seem more prone to lack of testicles properly descended. The majority of the veterinarians recommended that the dog be castrated as soon as he reached maturity because of the danger of cancer in the retained testicle.

## THE PRESIDENT SPEAKS

Even though the spring trial season is over the past month went by in a hurry. Now we are well into the heart of the summer show season in this part of the country and this can be just as time consuming as trialing. One thing about shows, however. When your dog has been judged you know how it made out right then and there. None of this waiting for hours or even days to see if you got a placement or points.

Correspondence between officers, directors and committee chairman has been thick and fast. There is so much to do and with all of us spread out all over the country, there seems to be so little time to do it in. But I think we have good people working at all these jobs and they will be well done. The biggest task is getting ready for the Nationals which is complicated this year by the earlier date and the split in sites. Last year's Nationals were, I thought, one of the best organized and smoothest running I have ever attended. It makes a tough act to follow, but generally the same people are handling this one, and I think they may even be ahead of their pace for last year, complications not withstanding.

The year's events opened with the Quail Classic hosted by the Kentucky Club at the Central Kentucky Wildlife Management Area south of Lexington. This is the area managed by Dewey Mullins and any trial there is always enjoyable. It was my pleasure to report the trial for the Magazine and I won't go into the details again except to repeat that I wasn't alone in feeling this was as high a quality a stake as I have seen in a long time.

As I mentioned last month, I was in New York in February and I had lunch with Jack LaFore, Ham Rowan and Bill Stifel of AKC. Jack is the new President of AKC and a great guy. We met him on the New England summer show circuit in 1968 when we were showing Char-Lee O'Dee to his bench championship. He just might show up at Paducah this fall and if he does, be sure to meet

him. If you have a bad image of AKC, he'll do a lot to change it. Anyway, we had quite a talk about the three judges bit. Nicky and Dr. Utzinger had laid the groundwork for the change but I believe you can express your reasons more thoroughly face to tace. It gave me the opportunity to fill them in as to why we felt this change was desirable. About ten days ago we received a letter from Ham Rowan telling us that the procedure has been changed and that three judges now may be used in the National Championship and National Amateur Championship Stakes. So one of the major items of the ABC program for 1972 has been accomplished.

Those of you who subscribe to the American Kennel Gazette may have noticed that a couple of months ago the ABC had a column in the report from member clubs section. You should be seeing more of them in the very near future on a fairly regular basis. Be sure to read closely the article on the Amateur Championship in the June issue of the American Brittany magazine. Also, it's nearing election for directors. These are the people who represent you and manage ABC so give some thought to whom you want and by all means VOTE. The percentage of returns is distressingly low so don't be a non-voter and then complain about the director. Also, let your directors know how you feel about things, preferably through your regional club. ABC is no stronger than its member clubs so participate in yours. One thing I'd ask you to remember—when you are unhappy with things on a National level, bear in mind that most regional clubs have their problems, also. ABC is no different except its gets them from all over the country and from 59 clubs. But we try to solve them and given your patience, understanding and cooperation, we will. But what may seem great for one region may not be so good for other regions or the club as a whole and your directors have to, and do, keep this in mind.



### FROM THE Secretary's DESK

### CHAMPIONSHIP PINS

A new shipment of plus has been received at the ABC office and all those who are entitled to a pin have been sent one. If you have not received yours please read the following and if you are entitled to a pin and have not received it please notify the ABC, Sherwood, Ore. 97140. If you received a pin from the first order and do not like the color (it being more liverish than orange) the pin may be returned and one from the second order will be sent to you. The second order is closer to the proper color.

The pins for Dual Champions have a yellow background. The bench pins have a red background while those for field championships are blue. If your dog's championship was confirmed in the January 1972 AKC Purebred Dogs or later you will get a free pin. Dual and field pins are sent automatically but bench pins must be requested. Pins are available only to ABC members and are sent to the person who owned the dog at the time it completed its championship.

Those of you who own champions finished in prior years may purchase a pin. The price is \$5.00. If at all possible give the approximate date your dog completed his title so that it may be more easily checked in our records.

#### AMATEUR CHAMPIONSHIP

We had hoped to have a group of letters from members to print here at this time in preparation for the final balloting on this new championship. However, there seems to be a good deal of apathy on the part of the membership and only two expressions of opinion have been received at the ABC office in the past couple of months.

The first answer is as follows—"I have not been in the Brittany Club very long, but I have worked field trials and dog shows. My idea on the new Amateur Championship is, if we are going to have it, have it for the Amateur. Let's set up rules where any dogs

trained or handled by pros are ineligible. The idea behind the championship is to attract more people to field trials. I, for one, am an amateur and it is very discouraging to work with my dog and then go to face dogs kept in shape, and trained by pros in what is supposed to be an amateur contest. I think it would be nicer to make it an amateur gun dog and keep it separate from the present amateur stakes."

There are undoubtedly many new people who feel the way this man does. The Amateur Championship that is being offered to us by the AKC does not allow any variance from the rules as stated in the present book of Field Trial Rules. It is suggested that each of you carefully read the requirements as listed before deciding to vote for acceptance or rejection. Please review the article on Page 8 of the June American Brittany magazine. Then contact your regional club secretary and register your opinion either for or against this championship. At the same time be sure your club secretary knows whether you are a regular field trialer or just an interested member.

All club secretaries are being contacted and requested to poll the entire membership of their club. Results will be sent to the ABC office and your Board will use them as a basis of judgment at this fall's Board meeting at Paducah. The Board wants every member to have a chance to express an opinion on this matter.



### Central New England

SPRING TRIAL

The annual spring trial of CNEBC was held at Westboro, Mass. on april 22 and 23. In addition to the 66 dog trial, the club offered an excellent happy hour, an exciting Calcutta for the Amateur Gun Dog, and a Saturday evening steak fry. Prior to the trial, plans were formulated for grounds improvement including an appropriation of funds from the proceeds of field trials to support the effort. Plans were also made to run most of the stakes at the fall trial, as single course events with birds released on the course.

The trial opened Saturday with the Derby stake. The blue and red ribbons were won by two young 12-month old puppies. Sky Bluette DeBecque captured first place. Bluette had an extremely consistent back course. She ran hard, was very busy and appeared not to miss an objective or an inch of ground cover where birds might likely be found. Her bird work was excellent and she showed considerable experience for a young dog. The second place dog, Sandy Valley Duke's Daisy had, as described by the judges, the biggest break-away of the stake. Daisy was close in every respect to the winner but not quite as consistent. Her running style and headhigh, staunch points characterized the class of her sire. Suzabob's Hey You Willie showed good style and class on his bird work. His ground race, however, was not as mature and forward as those placed above him. Fourth place was awarded to Bayou's Creole Warrior, who had an excellent back-course and hunted well. His bird work, however, was spotty.

The 22 dog Open All-age stake was won by Tondee's Sandy Valley Duke. This was Duke's fifth straight win. He started the spring with a first place in a 22 dog pointer stake and then captured four consecutive All-age events in the Brittany trials. Duke, as described by the judges, was, ". . . fantastic and in a class by himself. No other dog in the stake approached his excellence." He handled very well for such a wide ranging dog and had a perfect backcourse find on a running pheasant. In a difficult bird field of feathers and scent from previously "gobbled" birds, a stopto-flush did not detract from his two class finds. Nick of Columbia had a good gun dog race with a busy and hard driving back-course. He had an excellent back-course find with a solid head-high point on a quail. Third place was captured by Dolly's Hi Maggie. Dolly started slowly but finished nicely with a good hunting race. Fourth place was awarded to Dusty of Lakeview. Dusty

had a slow start with a fair back-course. However, he finished well and had a nice bird field find.

Judges Ron Stevenson and Jim Dilliplane considered the quality of the Puppy stake as very high and one of the best they had presided over. The margin separating the first, second and third placed dogs was very narrow. The stake was run on a single course without a bird field and with enough room and cover for a puppy to show well. The blue ribbon was awarded to Beaver Dam's Rusty Nail. The young bitch handled well and showed good range and hunting pattern. She had excellent stamina and class and exhibited good potential as a Derby dog. The red ribbon went to Timberlane's Jeff. The judges complimented Mrs. Randall on

her handling and felt that Jeff would develop into a fine Derby dog. He had excellent range with stamina and class. He handled well, showing good bird work. Sandy Valley Duke's Daisy could be described in essentially the same terms as the first two placed puppies. She finished stronger and larger but was nosed out of first on the basis of a somewhat slower beak-away. Daisy also demonstrated fine bird work in good derby style. Fourth place was won by Brittchester's Centerfire and handler Lewis Sprague, both competing in their first field trial. The puppy, with two bird finds, did everything well. The judges felt that a little more experience for both dog and handler would lead to many more placements.

The week-end was completed with the running of the Amateur Gun Dog stake. A sizeable Calcutta added excitement to the small event. Timberlane's Tex won the stake. Tex had a good ground race with wide to medium range. He hunted the cover hard and had a stop-to-flush on a pheasant on the back-course. His bird field find was executed with excellent manners. Quoddy's Little Duffer had the best race and application of the day. He had one good find in the birdfield showing good manners. However, one stop-to-flush and two nonproductives were enough to edge Duffer out of the top spot. Chantilly DeBecque earned the third place ribbon. Her application was not as consistent as the two top winners and her range was limited. Of two bird field finds, one was handled with good manners.

The contributions of the judges to these stake descriptions are appreciated since CNE has no appointed field trial reporter. CNE would also like to offer its thanks to those working members of neighboring clubs who so enthusiastically support the CNE field trials and the activity at those trials.

### Susquehanna

SPRING TRIAL

Ten pre-drawing scratches brought the entry down to 167-a tight fit for a two-day field trial. This was the case for the Susquehanna Brittany Club's 1972 spring trial held the 25th and 26th of March over the grounds of the Circle "S" Farm in Wellsville, Pa.

The load was staggering but once again the tried and true field trial master, Del Still, literally worried this one through to what has to be this club's smoothest run operation to date. Although Del was the mastermind and truly the man in charge, once more he inspired the entire Susquehanna membership to make it everyone's proud accomplishment.

Every detail was covered, to the point that every possible tie-up had an anticipated pre-planned solution. It all meshed Even the weather was flawlessbrisk but sunny both days. The weekend was as silk.

The Open Puppy stake was huge, boasting 39 starters. Passing judgment over these youngsters were Dr. Bill Heil and Jack Zerener who commented on this stake's richness in quality as much as its wealth of quantity. Gaining the nod for top spot was Sky Bluette de Becque by virtue of her busy, animated, and distant way of going for ownerhandler Edie Beck. As the judges put it, "She never let up that hustling pace or made one mistake her entire running."

The entry of Open Gun Dogs showed their talents to Dr. Ron Harling and Anton Tinnesz but on this day none could combine a searching class gun dog race with acceptable game contact. Many had one or the other but none put both together—thus first place was withheld. Closest to the set standard was Nehl's Little Bits under the whistle of Fred Nehls. Bitsy's ground race was of his usual all-inclusive driving style, but one lesser piece of bird work—sandwiched between two good finds-was not of first place quality and was just fuzzy enough to knock him from blue to red.

The results of a stake such as this are the toughest to pass judgment upon More times than not the dogs actually place themselves and little arbitration is needed, but not so in this running Fortunately, two of the finest men sat in the judicial saddles and practiced the highest level of standards, fortitude and common sense in their choices. A difficult job well done.

Kipp Trooper Rochambeau, under the direction of owner Tom Tivnan, blasted a group of true All-agers with an extended race and class bird work to cop the top spot in that stake. He flew around the U-shaped course in much the same manner he ran this same terrain a few seasons ago for his Derby points. Just on the edge of being out of control he mastered all margins, showing way to the front, following every cast but one. The exception was on the southwest corner which was sharp and Roch's cast naturally brought him in from the rear. He quickly corrected. One crisp quail find in the bird field was all that was necessary for judges Joe Stankewicz and Ken Marden to pin Roch as the class dog of the stake.

Under more bright skies on Sunday. the Open Derbies literally tore the allagers' course apart. Seldom does one see so many outstanding derbies in one stake. Both judges told this writer that they had no less than eight dogs that could have won most Derby stakes, but

the one that swept the honors was a real good looking Brittany that can also "eat up geography"—Sequani Des Collines, with owner-handler John lvester at the controls. He joined a beautifully executed ground race with two derby mannered tinds—one in the back course—to just edge the blue from his pressuring peers.

The Amateur Gun Dog winner is certainly no stranger—Suzabob's Frisco Frannie. Gerry Supplee's entry did it again, and again she did it in super manner. Her pattern was near perfect and complete. Matching this with the same kind of bird work always spells a win, and this it did.

Congratulations to the Susquehanna Brittany Club, the judges, handlers, owners, the gals responsible for all the good food, and any one else connected for one beautiful week-end of trialing.



Competitively he knew that Fluke de Britt (Johnson) had run an excellent race with three finds. Dan de Milles Gus did his new owner R. W. Trogen of Waycross, Georgia proud. Gus decided he could win on birdwork and had one find on the backcourse and two in the birdfield but he didn't pull out the stops on his range like the others did. Running last was Jacolet Blue. He knew it would take race, range and maybe backcourse birds and went for broke on two finds on the backcourse and three staunch finds in the birdfield combined with an excellent race. A fitting first in a 42 dog Allage stake with 14 placeworthy dogs. Wonder what kind of "birdseed" Jim feeds those dogs?

If he feeds it to his winning dogs like Walt Chapman of Iowa does he'll soon run out. Walt's special touch is seconds to those who do it right! De Madison King ran his puppy brace hard, wide and handsome through sloughs and away. Walt assisted with an artistic flourish on the whistle then asking as the dog turned, "Is that the way you do it, judge?" The West Coast may have their Ejner Lund but we've got Walt Chapman and he's a tough one to compete against. Walt's Durango de Madison looked especially impressive taking the entire tree line and hanging out there. Kickapoo Billy Bimbo got out and hunted in the right places with style for Wisconsonite Rand Constalie. Lyle took one look at the wet ground cover (it was a walking stake) and the tightness of the course and whispered in Roman Nose Scout's ear to go fast, wide and snappy and he could ride home in the cab with Marge. Lyle knew the woman's touch was what the other fellows couldn't offer and with that incentive Scout ran away with first place in a 26 dog puppy stake. The judges felt the Britts showed range and maturity and had much potential.

Ladie ran at gun dog range running a nice pattern but with his bracemate off on deer he came in second.
