

Do not notify us that your dog has finished unless his name is not published at the end of five months. It takes this long for official confirmation to reach the pages of the American Brittany. Show results are sent in by owners. Only major wins will be published and BB, BOS, BW, WD and WB must be given. given.

Show Case:

Show Case is the place to display your top winner, either field or bench. Cost is \$10 if we do not have a cut of your dog on file, \$6 if we do. All dogs completing their Dual Championships will be featured free of charge.

Change of Address:

Notice of change of address must be received one month before date of issue giving both old and new address. Otherwise delivery cannot be guaranteed.

Material:

Specially written articles (as contributions) are desired as well as photos suitable for covers. No articles or photos will be returned unless accompanied by return postage. Material and format controlled by the Editor, subject to approval of the Magazine Committee, John W. Lee, Nolen Cathey and Dan Buster.

1972 SUMMER SPECIALTY 1972

Within sight of the waves of the blue Pacific on the picturesque Monterey peninsula the American Brittany Club's Summer Specialty Show saw judge Howard Tyler of Connecticut choose as Best of Breed Ch. Kipo Tam's Little Guy, owned and handled by Dom Luiz. Guy went on to place third in a strong

group.

The event was held in conjunction with the Del Monte Show with the West Coast Regional Clubs acting as hosts. The committee in charge was ably headed by Ottilie Ewer. Dan Buster acted as trophy chairman and official photographer. Dr. Will and Mrs. Light were in charge of hospitality, opening their lovely home to the attending Britfans for a pot-luck and get-together immediately following the judging.

Regrettably the entry fell short of the 100-dog goal but the 88 officially shown in the regular classes made this event the largest ABC Specialty in history, topped only in size by the Michigan Specialty in 1955 when there were 96 participants. As would be expected all the California clubs were represented in the entry. Other western states that had entries were Wyoming, Nevada, Washington and Oregon. The eastern sector of the country had its participants in the Pericas from Michigan, the ABC president and treasurer, Lloyd and Ella Conable from New York state, and Maidza Van Deusen and Dicie Speck from Connecticut who brought, in addition to their own entries, a dog from Ohio for Jim Cohen.

Little Guy was a dark horse. He had gone Best of Winners in 1968 at the Summer Specialty to complete his championship. Campaigned sparingly since, his record shows only one breed win since that time, Best of Breed at Del Monte in 1971. He is sired by Dual Ch. Lewis's Ringo and was bred by Warren Butler. Little Guy is a field winner with points won in both puppy and derby stakes. In the lineup for final consideration were the following; (see photo where order is from left to right) Ch. Barry The Fierce, shown by young

Sandy Perica who was defending his crown as last year's Summer Show winner; Little Guy; Ch. Fieldmark's Tres, a liver and white, owned by Dr. Will Light and handled by Frank Houskey; Dual Ch. Suzabob's Hedgerow Happy, shown by his owner, Dan Buster, a former winner of the ABC Winter Specialty; Ch. Hot Shot Reno, owned by Bill Swonger of Oregon and handled by his brother, Bob.

Winner's dog and Best of Winners was a repeat of the 1971 Winter ABC Specialty in Lil Brother Easy, owned and handled by Kathy Owen. He was the victor in a large 13-dog Open class. This win completed his title and he becomes the second dog in the history of the breed to make two 5-point wins in the National Specialty. It is possible that he is the only Brittany to have completed a championship with three 5-point wins in Specialty shows as he also won the points at the California Club's event.

The Winner's Bitch was also awarded Best of Opposite Sex over three bitch specials. She was Dahlheim's Christy, owned by Joe and Diane Dahlheim and handled by Joe. She won the large 20-dog Open Bitch Class.

Reserve dog was second in Open Dogs, Teed's Farm's Callback, owned and shown by Maidza Van Deusen. Callback also won the Field Trial Dog and Bitch Class. Reserve Bitch was also second in the Open, the Mackenzie's Highland Bonnie, shown by Frank Houskey. Both are extremely nice specimens which should complete their titles easily.

The Junior Puppy Dog winner was the hit of the day as he broke stance to chase a small bird that chanced to land in the ring. We are sure Denny and Cindy DeMarais have a bird dog in Le Marquis D'Marais. Bob and Joan Reimer's Tierra Buena's Desort Trooper was the winner of the Senior Puppy Dog Class while Novice Dog first went to Leyton Smith's Taughre Aggie. Best American-Bred Dog was Elinor's Kipper, owned by Elinor Lynch.

In bitches the Junior Puppy Class was topped by Antoinette's High Hopes, owned by Arthur and Barbara Wedell. Senior Puppy Bitch winner was James and Clifton's Sequani Guinevere des Collines. In the Novice Bitch Class John

* THE LIVER AND WHITE BRITTANY'S HISTORY

A recent upsurge in popularity of the liver Brittany has brought forth several requests for background material on that color phase. The livers are a minority group, comprising, it is estimated, about 10% of the breed. In the field they are judged without partiality against their orange competitors. In bench shows judges are not familiar with the color and a certain amount of prejudice can be seen, mostly from lack of knowledge.

Livers have not always held the secondary status that now is theirs. The original Brittany was a liver and white dog and it was probably not until the turn of the century when matings took place with setters from England that other color phases were introduced. It could be expected that the setter would introduce several color factors, the orange, the lemon and white with a black nose and the black and white as well as the tricolor.

The first formal registration of a Brittany was an orange and white, named Boy, this being the first mention of the color in any written records. The color gradually found favor and became firmly established after the first World War. Today in France most Brittanies are orange and white.

Fanciers feel strongly one way or the other about the livers. They are either "liver nuts" or they can't abide the color. Alan Stuyvesant, the most influential importer of Brittanies, did not like livers, feeling they were inferior in both field ability and in conformation. Dr. Keough of Chicago was sold on them. It was he who was responsible for the livers gaining a foothold in this country. He imported Lettic de Pradalan, a smallish bitch who was quite prolific. She was bred to his imported French Champion Idoc de Cornouaille and the winners produced were numerous, making Lettic one of the top producing bitches in the all-time records for many years. Whether the quality of the progeny was due to Idoc's prepotency (he having sired the outstanding Kaer de Cornouaille, Fiachrach MacEochaidh

and Sorcha MacEochaidh from other bitches) or to Lettic cannot be determined. Lettic's field ability was a question mark for she had never been hunted. Stuyvesant considered her a poor representative of the breed and the basis for the bad livers in this country. As he judged mainly physical appearance his comments were factual for the first livers were poor in type, ranging in size from tiny bitches to large coarse males who resembled springers more than Brittanies.

Lettic did not live out a normal life span because after a kennel fight in which another bitch was killed Keough had her destroyed. She had put a strong mark on the livers and whites of her day. Typical of the progeny from the Idoc-Lettic line were Fld. Ch. Roger of Edough and Fld. Ch. Benjji of LaRue. They were predominately white with some liver spots. They were excellent bird dogs, outbirding most of their contemporaries. They were not noted as big running dogs, but were simply extremely good hunting dogs who wasted no motion in their assiduous search for game. Their color was medium in shade.

Dr. Keough, not satisfied with having established the only liver line in this country, carried his love of the color further by importing Follette IV de Pradalan, whose granddam Follette III de Pradalan was Lettic's dam. He later brought in Ratouss de Basse Bretagne. The two were mated and produced one field winner. The mating might have passed almost unnoticed except that Dr. R. C. Busteed acquired Soize Mac Eochaidh that he proceeded to breed to Allamuchy Valley Warrior, an orange and white. This breeding produced six field winners, the most notable being Tex of Richmont.

Tex established himself as the fountainhead of a second liver strain. Most of today's winning livers derive their color directly from him. Tex was a lanky individual with a solid blanket of very dark liver and a coat with a tendency to curl. He had highly angulated rear quarters that gave him much drive.

Many of his descendants closely resemble him physically. As a youngster he was a very wide runner. Jess Hayslip, who was responsible 10r his training claimed Tex to be about the best running Brit he had worked, it being a tossup with Jeffery of Argard. As an adult his range was cut considerably, which can happen to dogs in the breaking process.

Tex had a small field record, only 7 placements. In the completion of his show championship he was campaigned in the deep south. As there were never any entries in the area his owner, Nels Nielsen, made major shows by showing several of his own bitches with Tex us-

ually the sole male entered.

Tex had the potential as a stud and luckily was situated where he had excellent stud opportunities, first with Busteed and later with Nielsen. Busteed's family breeding plan was based mainly on Tex. The Richmont livers that resulted were widely accepted as excellent running dogs and made good field records in trials over the whole country. Nielsen bred Tex mainly to Ruby of Edough with whom he produced 14 field winners, to Follette de Jacques and to Busher de Klemanor. The remainder of Tex's 42 winners were from miscellaneous dams. Tex progeny won from coast to coast and caught people's fancy. They were spectacular in puppy and derby competition.

Still the livers did not attain a solid reputation among serious field trialers. The first liver and white to win the National Championship, for instance, was as good a bird dog and as nice a running dog as one could ask for. Crab Orchard Duke went almost unused as a stud compared to Miller's Desert Dust, an orange and white, who won the National Championship during the same era and was owned in the same city. Only his owner had confidence enough in Duke's progeny to campaign his pups and finished two of them quite easily. What a waste of good potential this was as breeders turned away from the dog strictly on a color basis! Only one other liver has won the Open Championship.

One liver, Elcon's Shotgun Smoke, has won the National Specialty, making that win from the classes under breederjudge L. D. Lafleur. It is believed that no livers have ever won group placements. If anyone knows of any they should notify the National office so records may be corrected.

Tex was the first dual of his color. Kaymore's Megs the first bitch dual among the livers. There was only one other liver dual bitch, Bill Brown's Shady Scamp. Other male duals were Detective Neal of Kaymore and Elcon's Shotgun Smoke and, more recently the two Stevenson dogs, Way Kan Fritts and Rufus Rastus Johnson Brown. There have been several liver field champions.

The future looks brighter for the livers in the field. Some juvenile stakes in recent years have had a majority of that color among the entrants. In the adult stakes they are in the minority. Whether this is due to their lack of willingness to take training or just plain lack of opportunity to be run cannot be guessed.

On the bench a few livers are making it. Some owners are becoming discouraged because of lack of recognition of the color by show judges. It is hoped that the greater number being entered will make judges aware that the color is as acceptable as the orange. Liver bench breeders have an uphill battle on their hands as soundness and type in that color can stand much improvement on the whole.

Training Tips by Hal Hunter

Dear Hal:

I like a mannerly gun dog but I am in doubt as to the wisdom of breaking a dog to be steady to wing and shot. Won't he bring back more wounded birds if he breaks the minute the bird goes, so that he is almost under the bird when it comes down? How about just training him to be staunch on point and letting him break at shot? When is the best age for me to give him this kind of training if you consider it necessary?

Dear Bob;

Many hunters prefer their dogs to break when the bird goes. I do not because I let my first dog do it, and she got shot by my hunting companion as she took off up over a stone wall after a low flying bird. I had already become irked with her because she had spoiled several necessary second shots by chas-

ing closely at flush.

I do not think the claim that a dog will find more downed birds if he breaks with the bird is valid. The waste of a second or two while you determine if the bird will be a runner or not before giving the command to fetch is not going to affect the retrieve materially. The second or two lost is more than over-balanced by the fact that the dog is standing looking after the bird and carefully marking the point of impact. A dog that is madly rushing after a downed bird cannot accurately mark its landing position. Watch and see how a young dog may become so excited by the flush that he races off in the opposite direction of the flight or misses entirely a change of direction.

If you hunt birds that travel in coveys you will want your dog to be steady until commanded to go for two reasons. Sometimes the whole covey does not flush at the same time and the dog may get in the way of your shooting a second bird. Sometimes you will empty your gun as the first wave of birds gets up. If your dog is steady you can reload and then try for the balance of the covey.

It is the pheasant hunter who is most concerned about the running wounded bird. It is well for him to practice with the dog working tracks. Teach your dog words like "Dead" or "Seek." This will mean the dog must come in and work carefully and closely probably with nose almost on the ground, looking for the dead bird or the scent of the wounded runner. You can practice this by taking a freshly killed bird and dragging it through the grass, then hiding it in heavy cover. Make the track longer each time. Most dogs will naturally work such a trail but many will have to be taught to do it carefully and persistently. Don't let the dog give up before he finds the bird. You may have to lead him along the track at first if he quits before he reaches the end.

It's almost mandatory to have a dog staunch on point. If he points and holds only as long as HE wants you will be faced with his flushing birds out of gun range. I once had a dog that would hold only until you got into the outstide edge of gun range. He had the distance figured out almost to the inch. He was no good with a party of two or three gunners because the first one getting into gun range would trigger his leap towards the bird. There was no time with him to maneuver the other members of the party into good shooting position. As time passed he got more eager and the shooting range was extended until there was no chance of the gunner getting the bird!

If your dog is going to be under two years this fall it is possible you should put up with his chasing everything that flies with the premise that you will have a better dog in the long run if you don't hurry up his training too fast. Most under-two-years dogs are not ready to be steadied to wing and shot. On the average you shouldn't expect a dog under a year to be staunch on point. From one to two years of age he should be

staunching up on point but he will not be steady to wing and shot. The three year old should be staunch all of the time and steady under average circumstances.

The above ages are average for the breed but what dog meets the average prfectly? You can work with your dog from the time he is very small teaching him to be staunch on point. You can hold him back on a rope, stroking him gently and praising him as he points the bird. You can get him into the habit of standing while YOU flush the bird. As he gets older, if he insists on flushing his own, you may have to do some sharp jerking on the rope to teach him to "stay hitched." Be careful that he is old enough and interested enough in birds to stand this treatment. It is easy to get too rough too soon. Then the dog will associate the rough handling with bird smell and become a "blinker," a dog that avoids noticing the bird because he is afraid of what goes with it.

The point at which a dog is ready for steadying to wing and shot varies a great deal. There are a few exceptional souls that never have much desire to break and chase. Keep them this way. You have a treasure. There are others that exhibit this steadiness as a young pup, perhaps because they are a little afraid of the big strange creature! This kind will eventually start chasing fervidly. Others will chase from the very first. The simplest method is to let them chase until they get chasing out of their system. At some point, if they are smart, they are going to get the idea that they can't catch a flying bird. You can help the smart dog by killing birds for him. He will quickly learn that he cannot catch the unshot bird. He will staunch himself as he realizes that, by giving the gunner a chance for a shot, he will get a chance to retrieve.

At the point when his desire to chase diminishes is the time to start breaking him. Try putting a rope on him. If he hits it hard at flush several times, barks or becomes quite excited trying to get the bird he is not ready for breaking. If he hits the rope hard a couple of times and then just runs to the end of it, or if he will stay at flush when you lay a hand on his shoulders he is ready for breaking.

The size of the bird you hunt is going to have some effect on the age at which you break him. The larger and slower the bird the more likely the dog is to think he can catch it. A dog will steady faster to a covey than to a single large bird—probably because he can't decide which bird of the covey to chase!

You are going to have to make your own decision about the correct age at which to start breaking your dog. Remember some are born broke and some will never reach the point where they will be dependable. Breaking is an easy job, accomplished quite quickly IF the dog is in the right point in his development. If you have a hard time with him it is either because he is too young or because you have waited too long and he has got into the habit of chasing and is not about to break this ingrained habit.

* TIPS ON SHOWMANSHIP *

We will assume that you have conditioned, trained, bathed, trimmed, and done all the things necessary to get your dog ready for the show. You and your dog are about to enter the ring.

Upon entering the ring, you and your dog should be alert and ready to move out briskly. Different breeds are displayed in different degrees of animation, but all breeds should be displayed as if they were athletes. Most judges start a class with the traditional circle with the dog gaiting on the left side of his handler and the movement is anticlockwise. First impressions are important, consequently the handler should allow room between the dog in front of him and his dog, so that he may move the dog out with a straight and true determined stride. Preferably the dog should be on a loose lead with his head up.

Some handlers prefer to follow dogs into the ring that they consider weaker individuals so that their dog will appear stronger, while others would rather be in the midst of the quality of the class. Good judge_S will locate the best dog, no matter where he may be.

Individual dogs have a speed at which they gait their best. A handler should spend time observing his dog move at various speeds to discover the gait that present his dog to its prime advantage. Each dog also has a characteristic carriage of the head and neck, which compliments its physical makeup. The handler who shows his dog on a loose lead that allows his dog to carry his head high in a natural position and to move freely has the advantage over the handler who must string his dog up on a tight lead that almost chokes him and almost pulls his front feet off the floor.

Ring generalship is most important. A good handler never will allow his dog to be hidden. This does not mean or imply that it is necessary to stand in front of the dogs on either side in the line up. Just don't get into position where your dog is covered up or otherwise out of sight of the judge.

A handler always should be looking

for that level spot or the spot with the slight incline when showing out of doors. A dog with his front feet on a level lower than his rear feet is apt to present a bad back line and look to be higher in the rear than in the front. Situations will arise when the handler is forced to set his dog up on unfavorable terrain. When this happens the dog may be positioned at a slight angle in an attempt to place the dog on level ground. This may require a slight bend in the line which must be accomplished as the line is developing. An experienced judge, who has been in similar situations, will understand your predicament and accept your position. Optical illusions are possible when the front or rear of your dog is placed closer or further away from the judge. This will cause a dog to look out of proportion when compared with others in the line, so it should be avoided.

A good handler is one who knows his dog and how to stack him to advantage. Front legs, when viewed from the front, should be perpendicular, but not set too wide or too close together. Elbows and front feet should turn neither in or out. Viewed from the side the front legs should be practically perpendicular to the pastern. The pastern should be slightly bent.

The back legs should be placed to accentuate the bend of the stifle. However, the stifle should not be bent as far as to throw the hock joint far out behind the dog. The stifle joint should not be positioned in a manner making a "cow hock." The hocks should be placed so that the pasterns point neither in nor out; and perpendicular when viewed from the side. A dog that can be set up quickly and has been trained to stay in position has a distinct advantage over one that is continually shifting his feet and moving his head and body.

Following instructions will aid the judge in his attempt to view the dogs in an orderly and efficient manner. Gait your dog on the line indicated by the judge. When going away from him go in a straight line. If he asks you to gait your dog across the end of the ring so that he can get a side view, do so in a straight line. Coming back towards the judge always travel in a straight line. And always, above all things, keep your dog between you and the judge. He is judging the dog not you, so don't hide the dog.

An intelligent exhibitor will observe other handlers in the classes, or prior classes for other breeds, being shown under their judge for the day, thus forming a plan of action developed upon advantages and problems incurred by these individuals. When the judge approaches your dog for examination be ready to give him your complete cooperation and remember to keep your dog between you and the judge.

Many dogs are schooled to walk or gait on a tight lead. A tight lead in the hands of a professional and in the hands of most amateurs are two different things. Too tight a lead often causes a dog to walk or gait at an angle to or from the judge. When this occurs, the near front leg always appears to dish or wing in. When the lead is strung too tightly the angled movement is exaggerated, and the off front foot may even paddle. This angled movement is often called "fish tailing" or "side winding." Therefore, it is important to practice walking or gaiting your dog with emphasis on controlled and straight movement. To correct or control diagonal movement practice moving your dog alongside and close up to a building wall or fence where he has to move in a straight line and keep him on a loose lead. When thoroughly trained on a loose lead your dog will almost never strain or pull against his handler and almost always will keep his head up naturally. Some dogs seem to love to pull against a tight lead, especially one that has been field conditioned with a roading harness. If the judge is not able to accurately analyze the dog's movement, he will not be able to place the dog.

Never turn a dog too sharply when gaiting to or away from the judge. Sharp turns tend to distort the appearance of the dog's legs, especially the rear ones. A slight step to the left prior to making a right turn and a

slight step to the right prior to making a left turn will help to make a round turn.

A good judge will not be misled by zig-zagging a dog to disguise faulty action. When asked to gait a dog away from the judge, the handler should move in a straight line all the way to the end of the ring or to the spot designated by the judge. Traveling in an arc to the end of the ring and back is a common fault, which does not afford an opportunity for the judge to adequately view the individual legs of the dog in movement. Another fault in showing a dog is not gaiting the dog directly to the judge; many handlers appear to be unaware that the dog is not moving toward the judge. There is no need to run over the judge to impress him. Stop your dog five or six feet in front of the judge and give him an opportunity to observe your dog as he stands naturally. However, make sure that your dog is not twisted or standing awkwardly in any way and that he looks alert.

We have pointed out that dog and handler should be alert at all times. The judge may indicate by gesture or by word who should line up for further evaluation and/or for placing. Never let it be said that the judge had to request more than once for you to move into final placing. Be alert and when the judge gestures, move promptly to the designated spot. Move to the new location in a manner that enhances the judge's opinion of your dog. Some crafty showmen attempt to move up a place or two in the shuffle, don't allow this to happen. Capable judges will note the deviation and correct it immediately. Never hesitate to ask the judge to clarify a request, if there is a question.

Exhibitors should show their dogs the entire time they are in the ring. There may be times when the dogs can be allowed to relax, but do this in such a manner that your dog is not out of position or out of balance.

If a dog is placed, the handler should not let down and thereby allow the dog to relax and appear to be undeserving of his award. Exhibitors whose dogs do not place should continue to present their dogs in a respectable manner until they are dismissed by the judge from the ring.

YOUR DOG'S HEALTH

ROUNDWORM STUDIED IN DOGS

Scientists at Iowa State University, directed by Dr. J. H. Greve, have found some evidence to indicate many pups may be infected with roundworms before birth.

The Iowans are studying the movements of Toxocara canis (roundworm), one of the most common parasites in dogs.

The scientists report the parasite usually migrates from the wall of the body of the dog into the intestines.

In the bitch, however, they have found it may stay in the body tissues for extended periods of time and during pregnancy move into the womb, where the unborn puppy may become

The scientists hope to learn why the parasite's larvae migrate into the body tissues in the bitch and why it migrates into the womb during pregnancy.

If the researchers can achieve a fuller understanding of the larvae's movements in the bitch they may be able to find a means of controlling the spread of infection to unborn pups.

FLEA DISCS

A recently introduced product is the flea disc. It is a round disc just over an inch in diameter and about onequarter of an inch thick. It is impregnated with dichlorvos which escapes as a vapor to kill fleas on the dog. Similar to the plastic flea collar that has been popular the past few years the disc has the advantage of not coming directly in contact with the skin. Therefore the disc should not cause outbreaks of skin rash or other side effects suffered by some dogs that were allergic to the collars. In recent experiments at the end of 120 hours all dogs who had the disc attached to their collars were found to be completely free of fleas. Care should be taken in attaching the disc to the collar to be sure that it is firmly in place. If the disc is attached to a loose collar the dog may pull it off and chew it. This is to be avoided at all costs.

DEATH OF YOUNG PUPS

Did you know-that from 30% to 40% of the embryos in animals die before birth? Most of these deaths occur within the first week after conception. For instance in pigs it has been found that as many as 40 embryos will be found in the reproductive tract soon after mating but seldom do pigs have more than 12 to 14 little ones.

These findings, along with many other ones of interest will be found in Science of Better Living, by Thomas Byrd. The book is the 1968 Yearbook of Agriculture put out by the U.S. Dept. of Agriculture and gives findings made by Dr. L. C. Ulberg, one of today's most fascinating researchers.

MANGE

A theory has been advanced on demodetic or "red" mange. It was thought that this disease was caused by a mite and the fact that it attacks mostly young dogs who outgrow the disease was attributed to the fact that the mite decreased in action after being on the dog for some time. It has been proved that a good many dogs carry the mite and seem to have no indication of the

The new theory is that the skin disease is caused by an allergy to the source of protein represented by the dead mites in the skin.

If this is so the dog owner would not have to be greatly concerned over the contagious quality of the mange.

The Pennsylvania Game News bulletin relates the story of a family that frequently take in injured animals and birds and nurse them back to health. This they did with a small brown sparrow with a broken wing. The children named the bird - yes, you guessed -Sparrow T. Agnew.

Then there's the one that's too good to keep. A prospective field trial horse named "Judge." We'll keep you posted

further on this one.

Traveling with the PITTMANS

I doubt you are ready for this, but here goes—there ain't nobody, absolutely nobody that gets in the situations we Pittmans can get into. We drove 2770 miles on a vacation trip, 1950 of them in Texas, hauling five dogs to field trials proud as punch of all of them and expecting big things from each one.

We arrive in Decatur, Texas after a beautiful day's driving through Kansas, Oklahoma and Texas. Just getting settled and feeding the dogs when our good friends, Eva and Marvin, pull in from Dallas. They just drove over to say, "Welcome" and wanted to show us the way to the grounds. It was pretty near dusk when we got out there but we thought we had it in our minds where the turns were. After dinner we turned in so we would be bright and shining next day to get out and give the dogs a chance for a good run to get the travelkinks out of their legs.

We awake to a coolish morning with a little wind blowing. Just right, we say, let's go dogs! First turn, we're doing fine. We drive and drive. Mr. P. says you went too far, you missed the turn. Mrs. P. says, no, we haven't gone far enough yet. So-o-o-o we turn around and go back to point where map said seven miles from this point. Mrs. P. won that one-we hadn't gone far enough the first time. We get that turn right but then the next one really threw us. After driving around for over three hours and getting back to a triangle of three roads the third time (well it was an easy place to turn around with that trailer) we knew we were helplessly lost. We passed a dump, saw a man roaming around leisurely, stopped and asked if he had any idea where we were. He looked at our map and turned it around and sideways a few times, mumbled to himself a bit and finally decided he knew the place. He started pointing and telling us to turn at such and such and then decided he better take us there. We found that we had only been ten miles off course. Hallelujah!!! We got to the windmill, the right one, and the grounds. By now it was very warm so doggies just got a five minute run, each, and a promise of better things to-morrow.

Saturday dawned on the chilly side and a bit windy. Mr. P. had the 4th brace so the dog went on the wagon and the "leader" says we have transportation for the dogs but you handlers will have to find your own.

One nice Dallas man told Mr. P. he would get him out on the course. There was no way for anything but a truck or jeep to get around the courses other than horses, of course, Soon after Mr. Goodguy and Mr. P. got out there they sent Mr. G. back to headquarters so Mr. P. was hanging on to the outside edge of the dog wagon. Then they had to wait about an hour and a half on a handler and there was no inside "waiting room," not even a tree for shelter. Mr. P. thought they might have to bend him a bit so he could get out of the shape he was in to get on the horse to follow his brace.

To top it all off none of the 200 birds they planted on Friday seemed to be showing their pretty feathers. Perhaps the marshal forgot which way they went the day before. Brace was over and no birds but a good performance otherwise and Mr. P. could smile when he got back to headquarters. Same song was heard each time someone came in from "outer space." "NO BIRDS." This ain't any different from most all other continuous courses where we all been. We thought THEY said it was different in Texas.

Our next brace was the 16th so we lounge around the rest of that day waiting for word from outer space as to how the stake was coming, not daring to leave for fear of being called to run. We had a puppy, too, but he was drawn as a bye. Not really looking for a chance to run him today.

Long late in the afternoon here comes the dog wagon yelling for the 16th brace. It has warmed up this afternoon so IF dark doesn't catch them it should

be more comfortable. What do you know??? Mr. P. has been gone about five minutes when they call for the pup. There has been a scratch and they are moving up the bye dog. If only they had called a little sooner, Mr. P. would have had ample time to run the pup and still get to the outer spaces in time. Mr. P. had another good performance with good race but no birds. Dog was acting pretty birdie at pick up time but couldn't seem to get on top of them so time was called. Next brace down dog just gets started when he slams on the brakes and "there's the birds!" That dog got first place, too!

Sunday A.M. out to the grounds bright and early. Gonna be warmer this day. The birdfield was a first for us-they were actually planting birds down in the trees. It is nice to get around other areas. It is a constant source of differnet happenings. Being different and being individuals is what makes up this wonderful, crazy world of ours. Our two that did well in this stake were both outstanding, or so we thought, BUT only one placed and Mr. P. won his second Texas "Best Amateur Handler" trophy. He hasn't let up about the one he won a year ago at Texas Coastal. We'll never hear the end of this.

Monday morning dawns bright and clear and we head for Alvin, down south of Houston to see "our kids" and the best grandson in the country. The fourth day we start north and west again. Stayed off the freeways to really enjoy the Texas country.

Early afternoon we stopped at a rest area to give the dogs a drink and a walk. We start on down the road and Mr. P. says this car is sure acting up. Seems to be missing. Mrs. P. suggests it may be the hot weather and summer type gasoline we get in Texas. THEN a glance into the rear view mirror and a groan from Mr. P. Yep, there was nothing left of the tire on the trailer except fringe. Luckily we are in Flat, Texas, population half dozen, and we had just passed a service station. Not a speck of shade in sight and it was very warm so Mr. P. says I'll walk back and get that man to come change the wheel. Service man says he is too busy. So we start pulling out all the "junk" in the back of the station wagon and getting to the storage department of the jack, tire tool, etc. I went and got a cold drink and didn't stand too close because the sun was already hot enough without the added heat Mr. P. was putting into the changing of that tire. Just as he was about finished a nice young Texan came driving up in a truck and offered to help. He said he had seen us go by back aways and knew we didn't know we had a flat so thought he better come along and see if we were in trouble. There are still some considerate people in this world.

Spare on and we have 12 miles to go on to Gatesville where we think we better try to locate another tire for a spare. Service seation sends us to Goodyear store. They don't have a 12 inch tire but they think a sport center might have. They did. The tire was a used one but tread looked good. He sold it to us for \$10.00. We thought we got a bargain considering they knew we were strangers. Went to service station to have it put on rim. Got it on and discovered a three inch cut in it. Now what???? Man started calling for us and at last located one just a block from where we went the first time. Took tire back to sport center to get our money back and that man was really embarrassed about what had happened.

Arrived Colorado City just as the sun was going down. We and the dogs were weary and hot and ready for some food. While we were getting settled Trainer Roach drove in to camp. We enjoyed the evening talking dogs, trials and sharing tales of rattlesnakes, etc. We had been praying all week for cooler weather since we had been told the snakes came out in hot weather.

Friday was still hot. Friend R. took us to the grounds with him to feed the horses and stake out his string for awhile. Believe it or not they do know what field trial arrows are in this part of Texas. They were old ones but at least you get some assistance in finding the grounds at West Texas. Winn Ranch is 40,000 acres, I believe they said and it say we could see and in these parts you can see a long ways. It is mostly reddish dust, a sprinkling of Mesquite, dry grass and cactus everywhere. There are hills and rocks, big rocks, little rocks,

boulders and fine gravel mixed with the dust. The big rocks and mesquite are pretty apt to have a snake close by. All very interesting but how on earth do they make a living in these parts. Even cattle would starve to death.

Friday evening about 9:30 some of us were sitting around the pool visiting and enjoying the warm moonlight night. We were in shirt sleeves. I mentioned the fact that people at home would never believe this on the 25th of February. Then in about ten minutes all of a sudden a gust of wind came up from the north and it turned darn cold real fast. The temp dropped 20 degrees in an hour and half. Yep, it was one of those Northers that blew in. We went to bed saying a little prayer for the weather to stay cool so all those rattlers would stay in their dens the next day.

About noon next day we hear a horse coming and look up to see Ray Roberts coming holding a long snake out. That snake was true to Texas legend—everythig is bigger in Texas—it measured 59 inches long with its head shot off. Mr. P. wanted his picture holding it so tried to steady miyself long enough to snap

a photo.

In the evening there was a knock on the door and in came a contingent from the Ft. Worth Club. They stated they had had a time getting Mrs. P. to stay still long enough for something they wanted to do. The President of the club (Harold Brown) made the nicest speech thanking Mrs. P. for her help with their club and then presented her with a framed certificate proclaiming her an Honorary Citizen of Ft. Worth all duly signed by the Mayor and eight Council members. It is Beautiful!!! There was also a little box with a gold key to the city on a red, white and blue ribbon.

Sunday was very warm again and the snakes started crawling out of their dens. Three were killed in about a half hour or so and one got away. Better get some new glasses, Jerry. The Amateur was over by noon and we THINK we are going to get a good start toward home before nightfall. All goodbyes were said and we started down the ranch road. At the last ditch to bump across the dog trailer bumped once too many. Yep, we looked back and the trailer was sitting sideways. We stopped

to get out to look thinking it was another flat tire. But, no, it couldn't be anything that simple. It had to be a broken spring. We were in the ranch yard where the barn was with not a speck of shade in sight, the sun blazing and there we are standing looking and wondering what on earth we would do now.

After a few minutes a Top O' Texas friend came along and stopped. He got out and rolled under the trailer in the three inches of red dust and came out saying we gotta find a piece of iron to brace it up so we can get you to town. After almost an hour he found enough iron and the ranchers welding outfit and got it fixed. We got to the motel and intended to stay over and get to a garage the next day but our Mr. Fix-it Friend (Wayne Porter) said he knew where he could get a spring on his way home and we should follow him straight north. We asked how far and he said about 150 miles and you will be that far on your way home. It sounded good to us so we headed north. We drove and drove and drove and once when we stopped I asked how much farther. Just a ways, he said, it isn't far. In Texas to a Texan anyplace is just a little farther or just up the road. About half way we stopped at a junk yard. The owner and his family had picked that Sunday to be away but Mr. Fix-it says that it is all right I know my way around and pretty soon came back with a spring. We think it is just over the next hill to where we are going. Finally at 8:30 p.m. we insist on stopping to eat. While we are eating Mr. Fix-it makes a long distance call up ahead which we didn't know about and some acquaintances (Dr. Busteed) (may be friends of his, or were) of ours were told that he was bringing us to their place for them to house over night. And then we drive about two mile when, Yep sure enough, there was a sign Rest Area ahead one mile. That wasn't enough, in about another two miles there was another sign with one on the other side of the road. We just can't win!

Each time we stopped the car Monday we heard Jolly and Smoke being unhappy with one another. When we had the rest stop at the trash barrel we found the reason they were unhappy. Dixie was in season again. She had just been over a season about three weeks. Well at least she waited until we were on our way home but she is sure fouling us up for the trial in a couple of weeks.

Finally arrived home at 8:45 p.m. Monday evening, two tired, but glad to be home travelers.

When we got Britt (Heady's Skip Britt) home he couldn't touch his right

foot to the ground and the first knuckle above the foot was badly swollen. Tuesday it wasn't much better so we took him to the vet. He told us that Britt seems to have "old man's" arthritis and we should quit running him. He said that each time we run him he will be crippled up worse and take longer each time to get over it. At age 11½ I guess he deserves to rest. It isn't easy to go and not take him but we knew it was going to happen one of these days. We are happy that he made a good showing and had the gallery all buzzing at the Lone Star.

This was a vacation that we will not be forgetting very soon and we will long have many happy, humorous, pleasant memories. We had fun, surprises, delays, troubles (none really serious) and we made more friends (we think). You know we MIGHT try Texas just once more. I guess there could be worse places to travel—but really now, so much of it???? Wonder if there are any other parts of the country with better offers????

REPORT FROM

Nebraska

The Resource Services Division of the Nebraska Game and Parks Commission is responsible for administrating all dog training and field trial activities in the state. This Division (1) maintains a roster of all Sporting Dog Clubs and Authorized Dog Training Areas in the state; (2) approves or disapproves all sporting dog field trials in the state; (3) maintains trial and training areas on stateowned property; (4) handles all correspandence from dog clubs and individual dog owners; (5) works closely with dog clubs and individuals on training and trial activities.

During 1971, a total of 29 organized Sporting Dog Clubs were listed on the State Roster. Sixteen clubs maintained training grounds on private lands. The State Game and Parks Commission continues to maintain three training areas and one trial area on state-owned property.

During 1971, a total of 23 club trials. and two sanctioned trials were approved by Resource Services. In addition, 17 Licensed Trials were approved, plus one AKC National Trial. Twenty-six of the above trials were conducted on lands managed by the Resource Services Division.

It is interesting to note that over 60 per cent of all trials held in Nebraska during 1971 were conducted on state property. It is expected that the use of state-owned land for trials will continue to increase, since it is becoming more difficult for clubs to maintain adequate facilities on private lands.

Branched Oak Lake Dog Trial Area **Development Activities:**

Development of the Branched Oak Lake Dog Trial Area continues to progress with each year. During 1971, additional permanent grass seedings were completed, and some construction work was accomplished on terraces to faciliwater-courses for the retriever breeds. A new sign for the entrance has been completed, and will be installed during the spring of 1972.

Some of the future needs of the area include: (1) better hitching posts on both the primary and secondary areas, (2) better parking facilities on the secondary Dog Trial Area, (3) and some improvement work on gullies on the secondary area.

In addition to the above improvements, there is a real need for some type of all weather building on the primary Dog Trial Area. This building would provide shelter for trial participants during bad weather, could be used for club banquets, could be used for small Bench Trials, and could serve other groups during off trial periods of the year.

Maintenance Activities:

The following is a list of routine maintenance activities accomplished on the Branched Oak Lake Dog Trial Area during 1971:

1. Mowed approximately 159 acres of land for weed control.

2. Planted and maintained 15 acres of milo for wildlife food plots.

3. Routine maintenance of roads and parking facilities. Applied an additional 30 yards of gravel.

4. Routine maintenance of barn, well,

trailer, and sanitary facilities.

The above items will be accomplished during 1972. In addition, it is anticipated that it will be necessary to spray annual weeds on approximately 125 acres of land recently seeded to permanent grass.

During 1971, thirteen Licensed Trials were conducted on the Branched Oak Lake Dog Trial Area plus one National Trial. Included in the list are two Brittany Clubs' trials: Mo-Volley Brittany Club wih 103 dogs and 200 people in the spring and 132 dogs and 175 people in the fall; and Nebraska Brittany Club with 125 dogs and 200 people in the spring and 96 dogs and 150 people in the fall.

It is interesting to note that the trials produced a total of 6,025 man-days of recreation. It is an increase over 1970. This is significant use, and justifies the continuation of this facility.

It is expected that the Branched Oak Lake Dog Trial Area will continue to receive heavy use. The size, location, and facilities on the area make it very popular with the Sporting Dog Clubs.

THE PRESIDENT SPEAKS

One of the many ideas and thoughts that came to my mind after being elected President of the American Brittany Club at Ardmore in 1971 was that of having a "President's Page" as a regular monthly item in the magazine. Now I would like to use this column to pass on to the membership what we have seen and heard around the country, the impressions I have received, the thoughts I have had and the ideas that have been generated by these things. There will be some interesting and humerous anecdotes to tell and it gives me the opportunity to let the membership know me better and understand how I think and what I think and what I hope to accomplish during my term of office. Hopefully we may develop a little better understanding of the problems of the other fellow from a different region and perhaps have a bit more of an appreciation of the problems facing the national organization and why the Board of Directors takes the actions it does in various matters.

There you have the background of this new column. I hope that by now you are all breathlessly awaiting the August issue to see what comes next. We'll start at the Quail Classic in January and work our way up through the year with the hope that we'll be somewhere near current by November, But there are a few of the items of considerable concern that I want to discuss here before the Board of Directors convenes at Paducah and I will work them in and if that puts the chronology a bit out of sequence, so be it. What are they? Well, horseback handling, dual concept, Nationals format for some. These and many others are topics on which I wish to take advantage of my office and this column to present to the membership points to be considerednot argumentatively or with the intention of dissuading or persuading anyone-only in the hope that sober consideration will be given by all and that perhaps some of us will see a different side to a particular subject than we thought of before. Your letters to me in reply to any comments I make will be welcomed and answered. And please, my opinions are my own and not that of the American Brittany Club.

John Sakas' Sue nailed down second—a good ground heat and three class finds. Third place Was taken by Sparton Town Red handled by Doug Croxton. Red was a little short on range, but compensated with a real good find. Doug hunted the quail single on his hands and knees. Bert Jones' Rusty Feller took fourth place with a good race and a good clean piece of birdwork. His excellent nose was not to be denied.

In the Open All-age, Hi Dolly Haven, handled by Jim Conen, continued her winning ways walking off with another blue. She wins for Judy, Gerry, or Jim. Handler does not seem to be a factor, a testimony to a fine dog. The Olund's Rusty Boy, handled by Lee Holman, was second with a good find. A slight let down in middle of race separated first and second place dogs. Cohen's Cutty Sark, handled by Gerry Cohen, was third with a good race, one find and a back. Fourth place went to Harper, handled by Doug Birchfield with a good find. His ground heat was not as forward as the top three dogs. Class races of the stake were laid down by Joel's Copper Jaques and Jacque of Connie. Both went birdless.

The Open Derby was won by Hi-Jake, handled by Lee Holman. Jake had an excellent ground heat with a stylish find and a derby chase. Pepperdust, a snappy liver and white, owned and handled by Bill Hoffman, annexed second place with a rolling ground heat, two finds on quail, handled with mature manners and a pheasant find to boot, Lady of Glory, handled by Williams, was third, exhibiting a wide range, hard hunting, ground heat. She disappeared twice, returning each time with a quail between her teeth. She had a good find, standing tall on the occasion. Spencer's Fritts, handled by Lee Holman, was fourth with a nice find. He did not handle as kindly as the top three. The class races of the stake were in the first brace with Holman handled Johnnie and Lawrence handled Bandit vying for front position. Martin's Bullet was in contention with one find and a good race, fading in the last five minutes.

Ty had the class race coupled with a voluntary back and a good bird field find. Second place was taken by Shawn, a German Shorthair, owned and handled by Mueller Doug Birchfield's Sioux had an excellent race hitting all likely spots. Sioux bracemate took out his bird with Sioux holding her position. Fourth place went

to Northrup's Pat. Pat had a good race, completing all his casts with no handling required. Pat had one well mannered find. OF HOMING PIGEONS

A British and an American scientist are pecking away at each other on the question: How do homing pigeons know which way to fly?

British bird expert G. V. T. Matthews weighing in with nine footnotes in a scholarly journal, defends his theory that the pigeons look in the sky, compare positions of the sun, make complex mental calculations and fly right.

The challenger, with 13 footnotes and a diagram, is William T. Keeton of Cor-

nell University at Ithaca, N.Y.

Armed with binoculars, a compass, a stopwatch and 20 pigeons, Keeton conducted experiments which he says prove that the way the birds view the sun has nothing to do with their path.

The American challenger explains it in Nature, a British science journal.

He kept half the pigeons in blackedout coops in Ithaca so they couldn't see the sun for 11 days. The other half could look at the sun as much as they wanted.

Since the sun shifted positions during that period, the blacked-out pigeons should have flown off the wrong way when they were released from a fire-tower 53 miles distant.

But they winged their way to Ithaca the same as the other pigeons. So Matthews is wrong. Or is he?

The Briton argues that Keeton's birds had been shown all the landmarks from the tower to Ithaca, so didn't have to take readings from the sun.

Jinx's Jim Dandy, owned by Curt Weyer and handled by Ted Hames, was fourth. Dandy scored with a nice find. His race was medium with a searching pattern to the front.

OPEN PUPPY STAKE

Jeu Chasseur Valentine, owned by Harry and Jean Klug of Portland and handled by Harry, topped the field of 23 puppies. Val's edge was a hard driving race, an excellent nose, and bird sense. She simply beat the field by going bird hunting—and finding them.

Ricky's Smiling Ranger, who has consistently been in the money in puppy stakes, was second. Owned by Wilson and Beulah Miars and handled by Wilson, Ranger delivered the same type of race as the winner, with perhaps a little less vigor. He stayed to the front, responded kindly and revealed potential values in his field of endeavor.

Dualite Mike et Pierre, handled by Ron Neumann, garnered the third spot. Mike showed a lot of hunting instinct and ran a strong forward race in seeking the likely objectives, and appeared to be just getting in the mood when time was

Arthur Johnson, took the third spot, just a notch behind the top two dogs with a good driving race and excellent bird work. Killey is a bird wise young dog with excellent style on point.

This was a fine lot of derbies and most of them showed well, many running for the first time in a trial on wild birds on multiple courses. A number of the entries in this stake showed enough range to make the "lost and found" column. The stake was started after the completion of the Amateur All-age on Sunday and most of the "week-end warriors" who take their amateur stakes seriously, had departed before it was concluded.

Way Kan Bing, owned by Art and Melba Stavik of Tacoma, Wash., and handled by Ronald Neumann, showed the benefit of previous experiences on wild birds as he wrapped up the stake on two excellent derby finds and forward race with lots of jump and class.

Chieftain's Little Dingo, owned by Isaac Vigil of Tucson, Aizona and handled by Dave Lachance, placed second. Dingo handled like a glove and hit the heavy cover well to make his finds. A trip to the rear on a turn hurt his chances.

Wyotana Buzzer, a consistent winner in puppy and derby stakes, ran his last derby race in this stake and he celebrated his second birthday with the third place win.
