1972 NATIONALS JUDGES

We'd like to preface this article with some very pertinent remarks made by David Michael Duffy in his dog column in OUTDOOR LIFE. He said, "Field trialers are addicted to the second-guessing of judges. That practice is usually pointless, since any qualified judge can give good reason for his picks and has the advantage of being on top of the action. Furthermore judging is an art rather than a skill. However, though there are basics that determine how well a dog does his job, there is plenty of latitude for opinion and interpretation."

Every year the National field trial committee and others who are interested make suggestions for judges for the Nationals. All suggested names are sent to the committee who vote. The names are listed in order of their popularity and the men are contacted to see if they will judge. It would seem basic that the judges most highly thought of by the majority are the ones chosen. Not always will the man on the top of the list accept the assignment, but primarily all the names that receive many votes are excellent judges. We can be assured that our national judges are the best and most popular judges that we were able to obtain.

There will be, as there are every year, criticisms of the judge's selections for placements. If the participants keep in mind two facts there will be less complaining about the judging. The first factor to remember is Mr. Duffy's

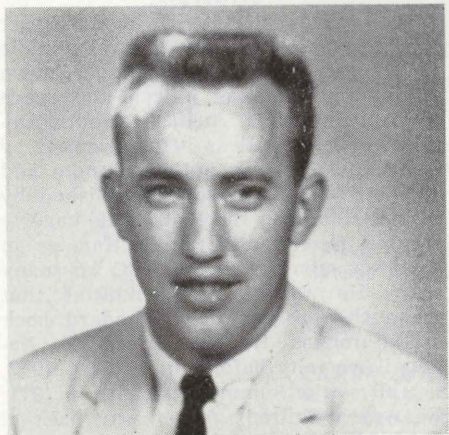
statement. The second factor is that in an assemblage of the best Brittannies from the entire country local favorites may shine, but not brightly enough to eclipse stars from other sectors. An excellent performance here can be topped by a superb performance from some other dog, and dog running being what it is, your own dog, or one in which you have a particular interest, may look better to your eyes than to those of an impartial observer.

The following are the selections for arbiters at the 1972 National events:

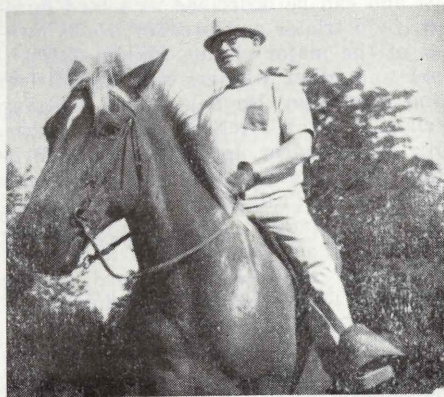
FUTURITY

Ferrel Miller, one of the Futurity judges has hunted and had dogs since a small boy. He owns dogs, both pointers and setters, that have won approximately 200 places in amateur trials. He is a member of three field trial clubs and serves as President of the Calloway County Field Trial Club. His judging experience has been varied, ranging from the National Open Shooting Dog Championship, the National Amateur Shooting Dog Championship to the American Brittany Quail Classic (1972). He bred, raised and trained Miller's Miss Knight that was called back for the run-off in the National Championship this past spring.

Dr. H. A. Gray the other Futurity judge is a veterinarian by profession and a resident of Kentucky as is Mr. Miller. Dr. Gray has been in dogs for many, many years, and though not campaigning actively in the past few years still keeps a good number of dogs. His judging assignments have been legion, National Free-For-All, National Open

Pheasant Championship the Continental Championship, both Quail and Pheasant Futurities, the All-American, the U. S. Chicken, the Quail Invitational Championships, etc., etc.

AMATEUR CHAMPIONSHIP

The Amateur Championship will be judged by Everett Metzger, John Malia and Dr. Bob Dudenbostel, the first time that three judges have been used in a National event.

Everett Metzger of Oregon is no newcomer to dogs, boasting of 50 years participation, first in other spaniels and then in Brittanies (since 1946). He has owned several top dogs of our breed, Evergray's Tic Toc Bobby (the first Dual Champion in the northwest), Fld. Ch. Evergray's Tic Toc Tommy II and his son a recent field champion, Evergray's Tic Toc Terry. Everett is presently president of the Willamette Amateur Field Trial Association and is one of the very few completely-Brittany fanciers to judge pointer trials with regularity. Last year he served as a judge in the National Amateur Shooting Dog (American Field pointer championship), a high honor. Besides being a field man, Everett holds an AKC license to judge Brittanies and Springers in dog shows.

James Malia, from New York state, is an avid Britfan, having devoted more than ten years to the breed. He owns Fld. Ch. Jamie's We-Go Jill, Fld. Ch. Mr. Who-He of Bordeaux as well as others. Other biographical material is not available at this writing.

Dr. Dudenbostel, of Illinois is a dentist and can be described as a bird hunter, field trialer and breeder. He is owner of the major circuit winner Calibaner and other winners such as Misban and Stop Sign. He has judged Brittany trials at Crab Orchard and St. Louis. His wife, Audrey, is well known to Britfans from the days when the Nationals were run at Crab Orchard. Their daughter, Jane, rides the trials and son Bobby, 11, is an able handler and scout. They are all looking forward to the Amateur Championship at Paducah.

OPEN CHAMPIONSHIP

The Open Championship will also be judged by three men, W. G. "Bud" Thompson, M. F. "Bo" Guest and Earl Clevinger.

Bo Guest has been around for quite a while, this year's renewal of the Sooner trial being his 30th time as field trial secretary. He is the only man to have bred two first place Futurity winners and his Hells Oklahoma designation appears in many pedigrees. More recently he has had fun with his Fld. Ch. Juchoir's Choctaw, Classics winner. The mail around Hollis, Oklahoma gets delivered in record time in the fall as Bo hurries to get through to do a little huntin' on the brown buzz bombers in his neighborhood. His wealth of experience and his many times in the judicial saddle will serve him well as the first of this year's Open judges.

Bud Thompson's cheery face has been seen on the trial circuit since 1960 when he appeared with a little dog named Debbie. His Ch. White Flash's Nikki, a Pheasant Classic winner, and his Field Ch. Ranger's Johnny Ringo were his early winners. More recently he has won with Fld. Ch. Magnum's Searcher. A popular judge all up and down the west coast circuit Bud can be counted on for a considered and impartial judgment, backed by the knowledge he has gained in training the above dogs plus several other hopefuls that he has owned.

The third judge will be Earl Clevinger of Mesquite, Texas. No biographical material on him was available at press time, except that he is a long-tailed trainer of great repute and that he was one of the judges for the first Texas Open Brittany Championship.

SHOWS

The judge for the National Winter Specialty Show will be Maxwell Riddle of Ravenna, Ohio. Max is a well known all-rounder who has judged all breeds over all the world; Australia, South America, etc., as well as being licensed by the AKC. He is an author of note and his new book soon to be published by Howell House on the Brittany is eagerly awaited. He is familiar to Britfans as an honorary member of the ABC for many years. He was on the committee that wrote the present show standard back in the forties. He has judged the National Specialty before; in 1945, in 1952, as well as the Summer Specialty in 1971. He was a Brittany owner way back at the beginning, though his major interest was in the Springer Spaniel. The first

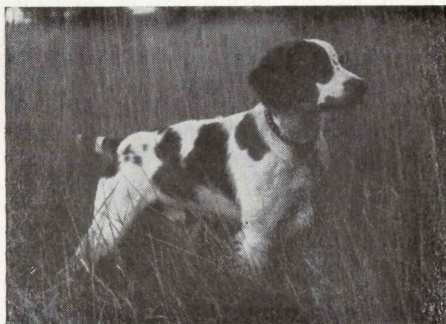
ABC Specialty Show catalog shows him as chairman of the event which was a combined Brittany-Springer show and field trial. Max has judged trials occasionally and is well aware of the dual type of dog that is expected to be entered at Paducah.

Robert Young of Glen Mills Pennsylvania, will judge the Futurity show. His Suzabob prefix (denoting dogs bred by Bob and his wife Sue) is a familiar one in both bench and field circles. The Youngs got their first Brittany in 1954. Bob finished his first bench champion, Suzabob's Dolly Dimples, in 1961. Since that time he has bred, shown and trialed many young dogs. He is listed as the breeder of 3 dual titlists, 3 others with field titles and innumerable bench champions. His record for selecting stock from among his prospects will stand him in good stead as he picks the best from the Futurity hopefuls. Though primarily an exhibitor, Bob has judged at a good many match shows, always drawing a good entry.

FROZEN *Semen*

A young Irishman has developed a technique that can remove many of the barriers in breeding dogs, making it easier and eliminating some of the risks. In so doing he may also have found salvation for breeds with widespread inherited disorders.

Veterinarian Stephen W. J. Seager, M.R.C.V.S., University of Oregon Medical School, in 1969 became the first person to produce a live litter of puppies from a bitch inseminated with frozen canine semen.

Since then he and his associates have done much studying into the use of stored canine semen. Funds have come from the American Kennel Club through the Morris Animal Foundation, Denver.

It has been said that the use of frozen canine semen and artificial insemination can revolutionize the breeding of dogs. At the least it can remove many barriers and eventually improve all breeds by making full use of good quality dogs and bitches.

Among the advantages of frozen semen are that it: makes possible maximum use of the semen of outstanding and disease-free dogs, even after death; eliminates the possibility of transmitting diseases through breeding or introducing dogs from outside colonies; avoids problems caused by shipping dogs and bitches for breeding; and allows dogs to be bred to bitches in foreign countries, despite strict quarantine regulations.

"In some of the larger breeds of dogs," Dr. Seager explained, "as many as 80% to 90% tend to be hip dysplastic. Using the semen of dogs without this condition could reduce the frequency of it and similar conditions."

Many times bitches must be transported to be bred, he added, and they can easily become ill during the trips. Also, the pregnancy rate is usually poor when bitches are subjected to changes in temperature and environment.

"This way," Dr. Seager commented, "the semen is taken to the bitch instead of the bitch to the semen."

Storing semen by freezing it for later

use is not new to the animal world. In fact, it has been used for artificial insemination with cattle, sheep, swine, and even man.

However, it was not until Dr. Seager had his first success, a litter of two puppies, that a bitch whelped from frozen semen.

"No one really knows why it was so difficult to get a pregnancy from frozen dog semen," Dr. Seager said. "Researchers had tried for 20 to 30 years. Artificial insemination itself had been performed in dogs since 1803 with fresh semen. They were just not able to freeze it."

Much still needs to be learned about the best techniques for freezing dog semen and inseminating the bitch, but Dr. Seager and those on his team at the University of Oregon feel they are making progress.

Dr. Seager explained in his thick Irish brogue that the litters of puppies have been growing larger. Litters now are including four, five, and even ten and eleven puppies. This he attributes to better freezing and thawing techniques, plus improved knowledge of the breeding cycle of the bitch.

"Also new," Dr. Seager added, "is our being able to freeze dog semen in straws, as well as pellets. We plan to go mainly with the straws since they use less storage space and identification is easier. The bitch can be inseminated directly from the straw. We have been able to freeze it in glass vials, too, which is the common procedure for bull semen."

For a thawing technique, Dr. Seager explained, they have found that the rapid thaw, immersing the container in water at dogs' temperature, is best.

The best diluent the University of Oregon scientists have used is egg yolk with glycerol and lactose. The diluent is necessary to protect the fragile sperm cells during the extreme drop in temperature from body heat to minus 320° F, the temperature necessary to freeze the spermatazoa but which can easily kill them.

Also, the diluent is used to extend the semen. However, it is not known how much it can be diluted and still successfully impregnate a number of bitches. This is one of the many things that must be learned.

An artificial vagina is used for collection of the semen. A teaser bitch is usually present and the dog allowed to mount her, but his penis is diverted into the artificial vagina, which is at body temperature. Dr. Seager explained that the artificial vagina, which can be adjusted, is suitable for all sizes of dogs.

To identify the sperm during storage, each container is carefully labeled. If there is any doubt of parentage after the puppies are born a blood test can make this determination.

When asked if one breed is more successful than another for frozen semen purposes, Dr. Seager answered, "So far, no breed significance has been found. No breed has been more or less successful than others. Of course, it varies from dog to dog and from time to time in the individual dogs."

Little scientific information is available on infertility in dogs and bitches. Therefore, the research team is conducting studies into reproduction and infertility as they affect the project.

And much must be learned about this relatively new technique of freezing dog semen, then using artificial insemination to impregnate a bitch.

For instance, the longest storage with a successful whelping has been two years. Dr. Seager is keeping some semen in storage which he plans to bring out in about 20 years to test its effectiveness.

Also it is not known exactly where in the bitch the semen should be deposited for best results. The rate of success has not been particularly high, with an overall rate of 43%, compared with an average of 65% in natural breeding. In some limited trials Dr. Seager has achieved as high as 75% success, and eleven out of the last twelve bitches he has inseminated are pregnant.

Dr. Seager expects the use of frozen semen for controlled application in the dog world will be possible in a year or so. Until then, he and his team are exploring better methods of freezing and

insemination and studying the number of sperm required for pregnancy.

"Quarantine regulations in many countries of the world severely hinder and sometimes prevent the importation of certain dogs. I have received many inquiries from all over the world asking for frozen canine semen to be used to improve the blood lines of these countries," Dr. Seager said.

"Breeding dogs by natural methods is best in most cases," he commented. "But there are many times when natural mating is impossible due to some physical or psychological deterrent.

"My opinion," he added, "is that only the surface has been scratched, and much further investigation is needed to bring the level of artificial insemination of the canine using frozen semen to that of the cattle breeding industry.

"The rewards of such work will be of great magnitude," Dr. Seager concluded.

WHY VOLUNTEER BRITTANY CLUB NEVER RUNS ITS TRIALS ON SUNDAY

"Were you ever stuck with a cast-iron spear?" Mr. Ralph demanded, eyeing the crowd sternly down his long Roman nose. "Well, I was, right then. Them hounds dragged that section of graveyard fence plumb over me, and plumb over the Preacher, slammed 'er up against the side of the church, and bayed that fox again!"

His audience sat transfixed — some helpless with long-sustained laughter, the rest mute with interest in the tale that Mr. Ralph was spinning. It was on a rain-whipped night in Somerville, Tennessee that the group had come together to draw the Volunteer Brittany Club's 1964 Spring trial. Noted handlers were there, giving accounts of winter training and last-minute assurances to eager owners. Bird dog interest and talk were electric in the air — the United States Club was running at Como, with the National Championship scheduled to begin at Grand Junction the following Monday.

The Britt fanciers had all feasted royally, up on the second floor above Di Gregorio's Cafe on the east side of the Somerville square; the "little dogs" (as some uncompromising pointer and setter men choose to call them) were all drawn and paired; and the sour-mash was flowing, when Mr. Ralph Cornwell, august secretary of the club, had risen to make a "brief" explanation.

The trial was scheduled for Thursday through Saturday, with puppies, derbies, and all-age dogs to run in that order. Finally the fond amateurs were to take their charges to the line. Some curiosity had been expressed, by visitors, as to why Sunday was not to be utilized for running. Many present knew that the nearby Ames Plantation, home of the National Championship, was by tradition closed to Sunday trialing, but the Britts were running on other lands. Mr. Ralph thus offered, with serious air, to explain to the group why "the Volunteer Brittany Club never runs its trials on Sunday."

"I was raised in central Georgia," the

good Secretary began, "and when I was about fifteen years old I had a pack of foxhounds and a horse—George—and I didn't even know there was anything else in the world a boy could want.

"Some of my friends had hounds too, and after workin' 'em all summer we agreed, late in August, to have a little go the next Saturday night. We were to meet over on the Ogeechee River. The Williams boy came, good friends of mine, but Billy Hart, and we 'specially wanted to beat HIM, didn't show up. I 'spect he ran a wheel off the trail, or somethin', on the way. So we didn't cast, but sat by the fire all night, eatin' onion sandwiches and drinkin' black coffee, and with plenty of lively conversation."

By this point in Mr. Ralph's narrative the group had become aware that this was no brief and ordinary explanation he was unfolding. Coffee cups were put aside, and cigars grew cold, while rain splattered against the windows of the warm and pleasant room, and he continued.

"The next morning I started home, ridin' George, and with my pack of hounds at heel. I didn't want to start a fox, in order to save the run for the next Saturday night, when we had agreed to meet again. As I rode up the trail toward the Ogeechee Primitive Unreformed Fundamentalist Church, set up on pilin's—" here Mr. Ralph paused, glanced about the room, and remarked, "you've all seem 'em like that—a fox came toward me, and before I could check em, the pack caught sight of him and off they went.

"There was nothin' I could do for it, so I just dismounted and set down on a little knoll to lissen. They were singin' in the Church, and I could turn my head one way and hear them hounds, and turn 'tother way and hear the congregation, and it was the sweetest music this side of Heaven.

"The pack took that fox down toward the river, out of hearin', and back around agin. Twice more they circled,

and on the third round I could tell that Reynard was tirin' and ready to go to earth. He swung in toward the church, and all at once my blood run cold with the thought—he had his den beneath it!

"I leaped on George and pounded leather hard for the church house, but too late! Before I reached 'er mister fox went flyin' underneath with the hounds close behind. He denned just beneath the altar, and when that pack bayed him there that hundred year old walnut box boomed like a Stradivarius fiddle!

"Inside the church they was foot-washin'. It was supposed to make 'em humble—and some of them needed it. I knew! But when that eighteen-hound choir bayed up through the altar, they come boiling out of the church like a swarm of angry hornets, in their sack dresses, and tight blue suits stretched across the shoulders and too short at the wrists, with their big bare feet poundin' acrost the smooth board floor and down the wooden steps. Aunt Midge still had the sperrit, and run around the churchyard shoutin' hallelujah. Deacon Tripp busted out of the door just as I galloped up on George, and pointing a long bony finger right at me he declared, 'Young man, you'll have to pay for it!' I didn't know what it was I'd have to settle for, but it sounded bad and I began to break out in a nervous sweat. It didn't help none, either, when Pastor Cowden, last man out of the church like the captain of a sinkin' ship, spied me and shouted, 'You and your pack of hounds have come straight from hell!' I'll admit that George, who didn't like crowds, was foamin' and snortin' like he'd been rid up from down below, but I didn't feel devilish, only scared.

Just then one member of the group to which Mr. Ralph was speaking, who may have sipped too freely at the festive bowl, and who was seated on the piano bench, dropped his head gently to the keys and slumbered, sounding a soft plaintive chord as if in sad punctuation to Mr. Ralph's confession of fear. The latter, apparently fully recovered from that emotion of forty years before, took advantage of the brief interruption to light a long cigar.

When it was pulling well, wreathing his senatorial head with blue and grey plumes of smoke, he continued. "All in

a sweat now I started draggin' them hounds out from under the church, and tyin' them one by one to the cast iron fence—it was the kind with them spikes all along the top, like spear points, like you've all seen—which surrounded the graveyard behind the church. It took every bit of rope and strap I had on me, and on George, to do the job. Just as I tied the last one, I realized with a start that sunk my heart into my boots, that I'd hung a thousand pounds of tuggin' yelpin' hound to one section of fence. Bang! she gave way! I leaped aside, but not in time, and that whole pack stomped me into the ground as they headed for the church."

Here Mr. Ralph paused as if to let his audience form mental pictures of that awful scene and then put the question with which this narrative began.

"Were you ever stuck with a cast-iron spear? Well, I was, right then. Them hounds dragged that section of graveyard fence plumb over me, and plumb over the Preacher, slammed 'er up against the side of the church, and bayed that fox agin! Believe me, it was a moment I'll never forget. There I lay, and there the Preacher lay, like we'd been cultivated with a spring-tooth harrow! Women and children were weepin', and men were cursin' (under their breaths, of course), as I gathered what was left of me up off the ground.

"The deacon was just climbing into his Model T, shouting that he was goin' for the sheriff. And that's where he made his biggest mistake. George was ordinarily a calm horse, but he knew somehow that the automobile meant the end for him and his kind. At the first 'pop' out of that Model T engine he rared, and then to make matters worse, the Deacon's big bare feet slipped on them pedals and he backed the whole contraption clean into George, where I had tied him to a little bench—with COURTESY OF SPENCE UNDERTAKING PARLOR printed on—at the edge of the graveyard.

"When THAT happened, addin' injury to insult, in George's opinion, he bolted through the graveyard, swinging that bench like a flail. Believe me, the marble flew! George cut a path through them headstones and markers like a mower at hayin' time. 'Crash!' Little

lambs and angels went aflyin'! 'Smash'! 'Died a heroic death in the War of 1812' split to bits. 'Bang'! 'Devoted wife of' separated forever more from her beloved! The bridle finally broke, and George, leavin' what seemed to me like an acre of shattered marble behind him, took the back fence like a Virginia hunter and made tracks for home.

"I started in all over agin draggin' them hounds out from under the church and tyin' 'em to trees—no more than two to a tree. When I was almost finished, expectin' the sheriff to come at any moment and take me off to jail, Nosey Elly Jo, the least hound of the bunch, busted loose and in the church door she went. Having two other hounds in tow at the time, and not wantin' THEM to get free too, it was a minute or two before I could go in after Elly Jo. When I got inside, she had tore up

a piece of rotten plank in front of the altar and had that fox hauled out!

"Hound and fox was spinnin' like a pin-wheel when I got to 'em, with the whole congregation hot behind me. I had only my belt left to tie with so I whipped it off and got it around Elly Jo's neck. As I dragged 'er back, and her throwin' pieces of fox fur all over the church, the Preacher made it in the door to join the rest and all hell broke loose! With my belt on Elly Jo, my pants wouldn't stay up, and I sunk down on the mourner's bench, rolled my eyes up to Heaven and beseeched: "Lord, just let me get these hounds home one more time, and I'll never hunt on Sunday agin'!"

"And that," concluded Mr. Ralph, "is why the Volunteer Brittany Club never runs its trials on Sunday."

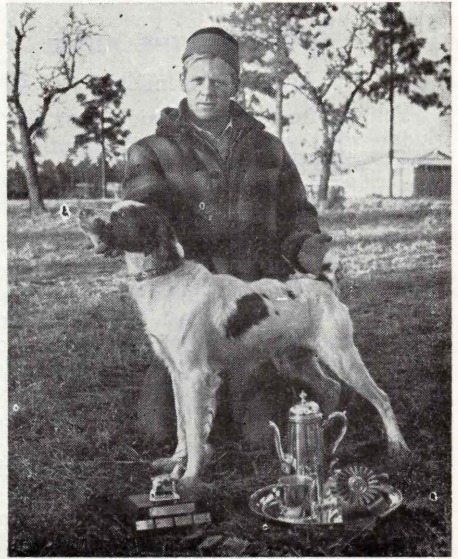

You BE THE JUDGE

by David Kenney

You've often heard it said—"you can't judge what you don't see." 'Taint necessarily so, my friends.

Sometimes the field trial judge should use his other senses too. For example:

Last year this writer was judging an all-age stake on continuous courses and wild birds. One dog—let's call him Dog—was turning in a class race and had scored a sketchy piece of bird work. No error involved, but not much that was meritorious either. Good enough to warrant a low placement if bird work remained at a premium.

Dog hit heavy cover to the right and did not reappear. His handler—let's call him Handler—asked for permission to send a scout. Permission granted, and Scout, too, vanished into the cover. Handler proceeded along the edge, singing to his Dog a little, and hoping to hear that welcome cry of "point!" from within the thicket.

Instead Handler—and Judge—heard an anguished cry from deep in the cover

—"Look out, Handler, look out!" There really wasn't much Handler could do, and if Scout had thought twice he wouldn't have done what he did. He might have done better to address his remarks to Dog.

At any rate, seconds after the cry of warning from the thicket, half-a-dozen Bob White came sailing out over our heads and on far to the front. Handler watched them go but said nothing. Judge did the same. Dog appeared to the front, and he too said nothing. We proceeded down the course, each of us thinking our own thoughts. Dog delivered a fine finish.

Now, you be the judge, gentle reader. The stake is over. Dog is credited with one of the better races. Few others were clean. We had a clear cut winner—fine race with impeccable work on a covey of birds. No question either about the second placement. Dog might be used for third or fourth. Is he in or is he out? You be the judge.

No one saw Dog err on birds. (Scout may have, but he wasn't talking.) Can you judge what you don't see? Write to this column and give us your decision.

Hip Dysplasia

It has been suggested by several that this magazine reprint the article found in the October 1971 issue of the American Kennel Club Gazette. This article, originating with the Puget Sound Council for the Detection and Elimination of HD, deals with the palpation of small pups, the method instigated by Dr. John Bardens of Indiana. As it has received widespread distribution, was summarized in the June 1971 issue of the American Brittany and other magazines, we will not reprint it here but suggest that those who are interested in reading it in its entirety obtain the October 1971 Gazette and read it there.

On the list of must reading should also be the article in the April 1972 Gazette in which a noted Swedish veterinarian and Dr. Schnelle give another side of the palpation question.

Recent literature reveals the fact that a breeder (breed not given) who started with Dr. Bardens early in his research program, was at the point in four or five years where she had a four generation pedigree that palpated normal on both sides. When she bred these animals they produced 100% dysplastic-free litters by palpation, radiograph and all were OFA certified.

On the other side of the question another breeder (Labradors) had a litter of seven palpated by Dr. Bardens with the following results.

Dog No.	Palpation	OFA evaluation	
1	grade 1-2	not xrayed	
2	grade 1-2	dysplastic	18 mos.
3	grade 2	normal	36 mos.
4	grade 1	dysplastic	18 mos.
5	normal	dysplastic	23 mos.
6	grade 1	normal	17 mos.
7	grade 3	normal	18 mos.

Dog No. 6 was evaluated as having the best set of hips in the litter. Considering these results and the ruling by AKC that dogs who have had their pectineus muscle cut are not eligible to be entered in AKC show or field trials it would behoove owners to consider carefully before having the operation performed. The operation might well be called for

when a pup shows signs of pain or extreme lameness, but just as a routine for any pup palpated as dysplastic better give it a second thought.

Dear Editor:

On the matter of an "Amateur Champion."

I am against this because it seems to me this would be a cheap Championship. Any time we make a Champion with only one small 3-point First place win and this could be against as few as only 12 other dogs, and the rest of the points could be 2nds or even 3rd placements. To me a title won this way just couldn't mean very much. And too many people, including some of our Judges, think that a fault in an Amateur stake is all right, but that same fault or mistake in an Open stake would disqualify a dog. They say, and I have heard this many times, "It's just an amateur stake," I believe a dog should have to be just as good to win or place in an Amateur stake as to win or place in an Open stake. Some of our members even believe that a dog trained by a professional shouldn't be allowed to compete in an Amateur event. But the difference between an Open event and an Amateur event, or any dog competing for that title should be good enough to compete against the best. After all, I believe to most people Champion means supreme. And I think any time we give a title of Champion it should mean just that. I know I wouldn't want my dog any other way.

Dear Mrs. Bissell:

Enclosed are the results of the poll concerning the amateur championship that you sent to us.

Some of the comments received from our members are as follows:

I think the term "amateur" needs to be clearly defined as it applies both to handlers and dogs before such a championship would mean anything.

There are too many people accepting money for training dogs and still running as amateurs.

I do not feel a dog and a handler that cannot finish or win in the open class should be allowed to get a cheap championship.

I feel that those amateurs that have their dogs trained and campaigned by professional handler/trainer that will nullify the purpose and objective of the "amateur field championship" . . . as for me . . . I had just as soon compete with the professionals as we are now doing.

I am in favor of an Amateur Stakes or Championship in a true amateur meaning . . . (1) a dog has never been handled by a pro; (2) a dog that has not become a champion; (3) a handler that is amateur as the definition applies.

To qualify my position, I am in favor of an amateur championship only if the dog is amateur trained and that the dog has not been in a professional string for at least six months prior to his being awarded the championship. We also need to define in no uncertain terms amateur, so that we may weed out or exclude the fence riders from amateur stakes, maybe we should also define professional in clearer terms. The only thing that frightens me is the possibility of a cheap championship for Brittany Spaniels, which would do us no service at all.

I believe that the members would get a kick out of running their own dogs. If the dog showed promise, then turn him over to a pro.

In the event the amateur rules could not be revised to create a "real" amateur championship, I would be in favor of the AKC version.

When we received your letter we repolled our membership.

Dear Editor:

I have just finished reading an article in Sports Afield (Ask Jerry About Dogs) in which he answered some questions about Brittanies.

I have a question I'd like answered and can't find anyone with it. Maybe you can.

Three years ago I bought a female Brittany. She wasn't registered but was supposed to be a purebred dog. When she got older her nose turned black and her hair is long but not curly. She is colored and speckled like the Brittany but doesn't have the nose and mouth of them. Now here is my question: Can I raise puppies from her and our registered male and then breed a pup from that litter to a registered male and then breed a pup from that litter to another registered male and then register this 3-generation puppies as registered Brittany puppies? I've been told I can but I can't find out where I would send for the papers and so forth.

Dear Nicky:

I recently had a very harrowing experience that almost killed my older dog. After the crisis was over, I thought that it might be a good idea to report it to you for possible publication in the magazine as a warning to other Brittany owners.

Here's what happened: My dogs were in top physical condition, but I felt they should have a dose of worming medicine. The adult dog weighs forty pounds, and the puppy weighs twenty. They both live in the same run. My vet sold me a product which I have since learned is derived from the organic phosphate chemicals which are commonly used for insecticides.

I gave each dog the appropriate dose with a little raw hamburger to help it go down. The puppy vomitted hers and the older dog ate it, so he got 1½ doses. Within a few hours he became very lethargic and uncoordinated. Through the night he had six grand mal convulsions (epileptic fits) and almost died in respiratory arrest. An emergency trip to the vet in the middle of the night and several days in the vet hospital were necessary. Several more days of intensive nursing care at home were

needed to get him back on his feet. The total financial loss was about \$75 in addition to several sleepless nights and a week of serious worry.

The ending is a happy one—Joker has recovered. But a nightmarish thought keeps entering my mind. What could happen if the same or a similar drug were used to worm a litter of 8 pups? If half of them vomitted and the other half ate it, the result could be 4 dead pups. I hope this worming will prevent that from happening.

Apparently these drugs have a very low margin between the effective dose and the lethal dose. Beware!

Let's all take a serious look at how to do the most for our breed and the owners of these good dogs.

I hope you may be able to give me some information on a problem we are having with our Brittany pup. She is 7 months old and seems to be developing an aggressive attitude that approaches meanness. We got her at 7 weeks; just my wife and I—no children; she is a house dog but has a large yard to run in; gets a 2-3 mile brisk walk every day plus 20 minutes or so chasing a ball in the yard; our vet finds no physical problems. She has always played rough with

us, but lately has started jumping and biting us. A reprimand or correction only causes resentment and more biting. The only solution seems to be leaving her or putting her in another room or outside. With strangers, she is very reserved and if they try to pet or touch her, she snaps. Is this normal behavior for a Brittany at this age? If not, can you suggest a remedy?

This is our first experience with a pup. We had a Brittany that we got when she was two years old and, after she had adjusted to being with us, no one could ask for a better dog. She was gentle, affectionate and very well behaved.

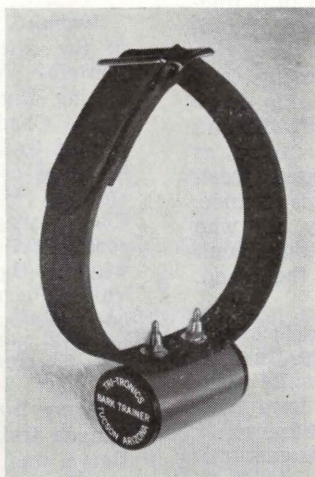

THE PRESIDENT SPEAKS

April and May were active months. Our part of the travelling circus got back from the Pheasant Classic, not without mishap, barely in time to repack and take off again for the East Coast. It's a long drive from Peru, Illinois to Orchard Park, N.Y. when you're pulling a trailer with two horses and four dogs in it but we almost made it in a day. However, a rear tire on the car developed a big blister somewhere west of Cleveland. Then one of the trailer wheels started to wobble and we feared bearing problems. The solution was easy. At seven that evening we were within five miles of Jim and Judy Cohen's so we got off the turnpike and called. Jim gave us directions and on our way to the house we met him. He wasn't coming to guide us, though, but was on his way to the grog shop for some necessities. We found the house, Jerry and Jeff fed our dogs and horses and put the horses in the barn, Jim mixed the drinks and Judy cooked the dinner.

It turned out to be a long evening. There was much to talk about and then Judy took us into her "lab" and proceeded to do fecal analysis on all our dogs for us. If you have a big kennel one can save a lot of money doing your own analysis for worms rather than paying a vet, all due respect to all our fine veterinarian members. Then Jim and Judy got to reading the old magazines and Ella and I finally turned in. I guess they read most of the night because they were pretty bleary-eyed in the morning.

The next week end we were at North Jersey and started catching up on the things doing on the East Coast. The stakes run are all from horseback We could learn from them. These are pointers and setters under rules of the American Field but the horses are used the way the ABC WOULD LIKE TO SEE THEM. The brochure on the trial has very explicit directions on how horses will be used and they mean it. I brought a bunch back for distribution to our board of directors and National Field Trial Committee and later will include that portion in one of these columns for all to read. Those that object to horseback handling might feel differently if they could see it done properly.

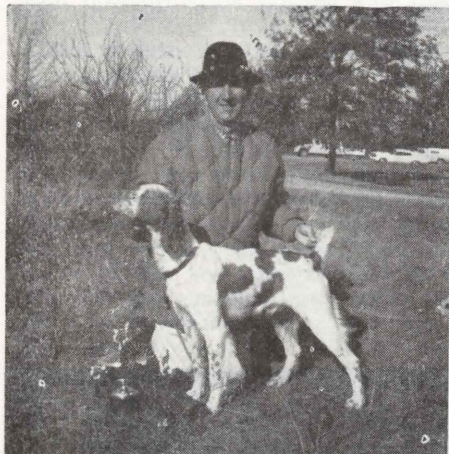

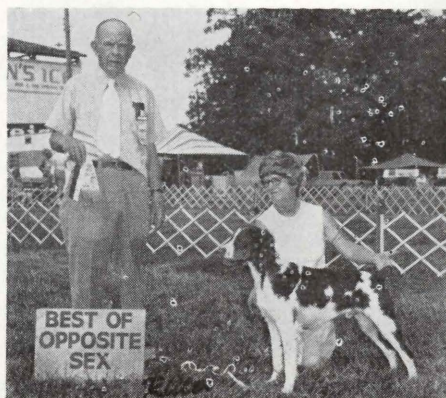

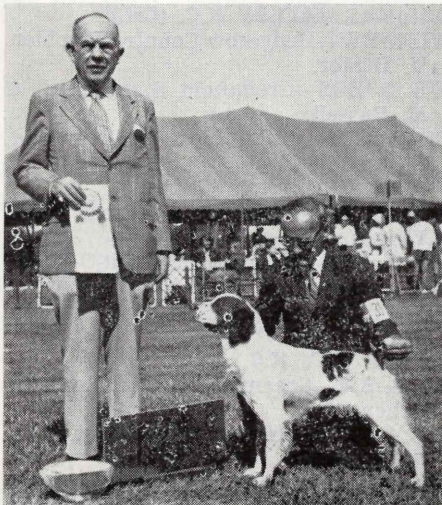

SPRING TRIAL

The Greater St. Louis Brittany Club held its 1972 spring trial on March 11 and 12 on the winding contiguous courses of the Busch Wildlife Area at Weldon Springs, Mo. A total of 74 dogs competed for honors in the four major stakes, during two days of summer-like weather, with the temperature hitting the 80's. Surprisingly, the dogs held up extremely well.

The Open All-age got underway at 7:25 a.m. Saturday under bright sunny skies. Two coveys of quail were moved in the first half hour, but not to the credit of the dogs. The winning dogs found birds right where you would expect to find them, with the finds equally spaced, two in the morning and two in the afternoon.

The top All-age dog was Augustus of Rivers, running in the 5th brace, and handled by Jim Holman. Gus had a wide forward race topped by a beautiful point of a covey at about 25 minutes as he followed the wood's edge of a disced corn field. Jacolet Blue, running a consistent forward pattern, with Jim Holman handling, had a boom-boom find on a covey, just inside the wood's edge, that nailed down second place. The Little Joker was handled to third place by Jim Holman in the 18th brace, with a ground pattern nearly comparable to the second place dog. Joker pointed a wild covey on a forward cast to a small thicket, that elected to flush after point was called. Elias Russ, handled by his owner, Dave Kenney, gained the 4th spot with a closer race than the other placed dogs, but with a dandy point on a covey, just at road's edge, where the course crossed two intersecting roads.

The Open Puppy stake was also run Saturday, over a single course, with considerable enthusiasm displayed by the winners. Dingo, a rangy liver and white, handled by club member Dave Capstick for his sister Joyce, was the stand-out winner, with a well applied puppy race. Coming in second was a Holman handled entry, Judy, followed closely by Way Kan Lil, Leon Briggs handling and Princess, handled by another club member, Don Moore.

The Open Derby, underway by 7:30 a.m. Sunday morning, was won by Buck de Lamont, handled by his fond owner, Roy Quick. Buck had a good forward race, hitting all the birdy objectives. The second and third place dogs braced together were Homer, handled by Holman, and Ranger, handled by his owner, Al Wolkey. These were two hard running young dogs. Fourth place dog was Thunder, handled by his owner, Mr. Springsteen. Thunder was to the sides and behind somewhat.

The Amateur All-age stake was held Sunday on a single course, laid out around one of the area's picturesque lakes. LeCar's White Smoke, handled by Roscoe Staton, wasted no time after the breakaway working forward through a tree line with a cast out and around a cornfield. He navigated the back course nicely. Two finds with perfect manners despite braccemate's chasing, put Smoke in first place. Britt of LeCar, with a nice breakaway, consistently in front hunting the objectives and two clean finds, wrapped up second place for his owner, Leon Briggs. Mo Kan Outlaw, handled by Ray Cox, started with a good breakaway and finished with four well handled finds to take third place. Dusty Spot with a good breakaway and back course and one clean find took fourth place for his owner, Dave Capstick.

A special thanks to all of the handlers for their fine sportsmanship and to our judiciary gentlemen, the Faron Brothers, Dr. Max Holcomb and Dale Marple for their time and patience. These fine people were quite complimentary about the over-all improvement displayed to them by the Brittany.

Our second bench match (Plan A) was held Friday evening, March 10, 1972 at the Parkway West High School gym. The tall gentleman with the short horse, from Kansas, Herman Bonine, thoroughly scrutinized our 27 entries. Best of Show and Best Puppy was an alert young male, Gabouri Skipper de Girardeau, owned and handled by Joe Victor of Flat River, Mo. The unpredictable Washington weather produced a snow storm Friday evening and very early Saturday morning making the roads and highway to the trial grounds quite slippery. The snow stopped before the trial started. Although the morning was quite cold the sun occasionally peeked through the clouds.

John Cunningham and Glynn Griffith judged the first stake the Open All-age. Way Kan Happy Hank, who ran in the fourth brace, emerged as the winner of this event. Hank, who had a classy find at 2 minutes, ran a wide driving race with bigger and bigger casts as time progressed. He topped off his performance with another fine piece of bird work in the bird field. Second place went to Loophole of Clipper Down who ran a shorter race but finished strong and nicely handled 3 bird field finds. The third and fourth place dogs were braced together in the third brace. Jocko's Lit'l Joe, after a modest start, finished strong with excellent casts near the end. Joe was credited with 1 find and 1 back and exhibited good manners in both instances. Fourth place went to Lutam's Gingles who ran a wide driving race and handled nicely. Had Gingles exhibited more intensity with his find he might have finished even higher.

The Amateur All-age which followed the Open All-age stake, was judged by Tom Knight and Dave Story. This was a closely contested event in which Evergray's Tic Toc Terry emerged as the winner for his owner-handler Everett Metzger. Terry earned this win with a combination of a fine backcourse run and classy bird work. Pacolet Cheyenne

Sam and Black Butte's Ace Wild provided an exciting 6th brace ending up earning 2nd and 3rd respectively. Fourth place was captured by Baron's Little Reno.

The Puppy stake was eagerly anticipated since several of the entries had already established reputations in the Southern circuit. This stake started amidst intermittent showers of large snow pellets. The snowfall increased and the trial was called after the sixth brace because of lack of visibility. The trial resumed early Sunday with 1 inch of snow covering the ground. It turned out to be a beautiful day, by 11:00 all coats were shed. Judges Tom Knight and Dave Story had their work cut out in this exceptionally competitive stake. No less than nine dogs could have won most any puppy stake. The five top pups included two pairs of litter mates. The eventual winner, Black Butte's Sassy Dee-Lite was judged number one for a fine balance of run and bird work. Dualite Mike et Pierre left the gallery buzzing with a big, forward pressing run which showed that a 20 minute stake and a five acre bird field were not enough for him. Mike however, had no bird contact. Pierres Bon Cheance, Mike's litter mate, had an equally big run but unfortunately turned the wrong way at the first turn and found himself boxed in a corner and out of range of his handler. A good run was wasted in trying to catch up. Cheance also found the time and course too small and closed out the brace going away looking for more room to run and earned a fine third place. Way Kan Dandy II who ran an impressive driving race in the snowstorm on Saturday and also as a bye dog on Sunday was the 4th place winner. Black Butte Chocolate Sundae, litter mate to the 1st place pup, challenged the other winners enough to earn an honorable mention.

The Derby stake was judged by John Cunningham and Glynn Griffith. The 1st and 2nd place dogs were paired together in the seventh brace. Right from their breakaways it was apparent what

these two were to be reckoned with. Both dogs ran big searching races with Frenchy a little wider at times. The race left little to be desired. The difference came in manners on birds. Jacolet Samson had 1 nice clean find with nearly all-age manners to earn 1st place. Frenchy had three finds and handled them in Derby fashion for 2nd place. Way Kan Bing ran a medium to wide searching race and had three finds with excellent style to place 3rd. Fourth place was earned by Ricky's Torch who ran wide with a consistent pattern and had 2 finds in the bird field. Jacolet Pride was awarded an Honorable Mention for a nice race. With acceptable bird work he might have upset the apprecart.

The Open Gun Dog stake was judged by Tom Knight and Dave Story. With an impressive overall performance 1st place was captured by Lindy du Blanche Happy. Killey pressed hard and earned a 2nd place. Baron's Little Reno and Way Kan Happy Hank received 3rd and 4th placements respectively, the second win for each in this trial. In all, the trial ran quite smoothly; field trial chairman George Perry and his committee should be commended for a fine job.
