

Breeders Code of Ethics



As a Blue Ribbon Breeder of Brittany Spaniels
I promise to:

1. keep accurate and complete records of all stock, their matings and their pedigrees.
2. maintain and pass on to purchasers factual health, breeding and registration records. I promise to furnish a signed registration application or transfer with each puppy sold unless a written agreement is made with the purchaser at time of sale that papers will be withheld. I will withhold registrations (by written agreement) on all dogs with hereditary faults of such nature as to make its use for breeding detrimental to the breed.
3. breed scientifically and selectively by mating only sound dogs of good type and field ability to reduce faults to a minimum and to secure puppies of type, ability and temperament that will be a credit to the breed. I will never breed dogs with known physical defects.
4. breed a bitch no oftener than two heats of three nor prior to one year of age.
5. humanely destroy all crippled and deformed individuals unless unable to do so for moral (never pecuniary) reasons, in which case such dogs will be neutered before being placed in new homes.
6. maintain the best possible standards of health and care in all my dogs. I will sell only pups that are healthy, free of parasites, never before they are 45 days old.
7. refuse to deal knowingly with unethical breeders, pet shops or wholesalers and will try to place each individual in a home where adequate facilities are available for the dog and where it will receive proper care.
8. seek the advice of other more experienced breeders when necessary.
9. show good sportsmanship in field trials, in the show ring and during the hunting season. I will not speak ill of other breeders or of their dogs.
10. keep in mind that the good of the breed comes before any personal benefits.

OF HENS AND HORSES

This interesting piece was printed in DOGS IN CANADA, the official organ of the Canadian Kennel Club to whom thanks is given for permission to reprint it. The author begins with a humorous report of a find on a barred rock hen in the International Brittany Championship and then goes on to say

The merriment enjoyed by mounted gallery and officials seemed to so stimulate the assembly that they immediately whipped their horses into a gallop and vanished over the rolling terrain.

"Sam," the much and deservedly admired Brittany, must surely be one of those touted horse-back shooting dogs. Your rather overweight but game foot reporter was by this time out of sight and sound of the multitude. Only their distant gales of laughter drifted across the plains of Upper New York State.

The use of the horse in an event such as this has always been permitted on the condition that "the horse shall be a means of conveyance and the mounted handler shall adjust to the pace of the foot handler." In this case, and unfortunately only too often, the conveyance speeds up and fat foot handlers are left behind. Indeed, this rapid conveyance must be the origin of that ringing field trial phrase "horseback shooting dog."

I have always wanted one. It is like a puma skinning knife and other things that I wished I needed.

I have not, nor have many of my dog training companions, had occasion to skin a lot of pumas. But it would be nice to have the knife just in case one was asked by your neighbor if you could drop by after work to remove the hide from one that just fell into a pit trap dug in his driveway.

It would really be rather satisfying to be showing people around the kennel, arrive in front of one saddlesoap-smelling run and introduce the visitors to "my horse-back shooting dog." The imagery would be in itself worth the keep of the dog. There we would be, in an alder or willow cover in Quebec's Eastern Townships, slipping into the saddle of a five-gaited horse while the under keeper releases our dog. Grouse and woodcock look out. For hens on the prairies, we could switch to a Tennessee Walker watching our Brittany, Shorthair, Weimar, Drahtharr or other Continental breed sail out as we trotted gaily across the rolling ranchland.

The field trialer is getting dangerously close to improving his breed of dog to the point where it may not be of too much use to the gunner. Increasingly the thinking behind such

concepts as the horse-back-shooting dog is being challenged by sportsmen who are not the least concerned with imagery but want a good setter or pointer to hunt with on foot in cover. Complaints are appearing in the letters columns of field dog publications that the "trial" business is not and cannot meet the needs of the ordinary gunner. These complaints are justified, as in my experience too many trial people worship the so called big running all-age specimen and downgrade the closer working but birdy-shooting dog.

At a recent gathering of bird dog people, planning a forthcoming event, the planned "gun dog" event was certainly relegated to second class status. The "all-age" stake received the most enthusiasm, money and hopes for patronage. This is to be lamented.

In this writer's experience, we should honor the shooting man's gun dog in events that recognize the best of this class of dogs with full honors. For here, dear hearts, are the dogs that 99% of the fancy want to own. We who are responsible for organizing trials should make sure that the foot handled shooting dog is well received by judges, gallery and club officials.

Let's be clear, we are not referring here to stakes for the pottering, lifeless specimen. What we want to honor are the vibrant, exciting, easily handled bird finders so sought after by the guys who buy our pups. These animals are not as described by one field trial expert, "the dogs that don't make the grade at all are sold off as grouse dogs." Such a remark again downgrades not only the gun dog but shows abysmal ignorance about what constitutes a good grouse dog. If all we had to do to obtain one is to pick up the all-age field trial culls then we would have an easy task.

The top hunting dog is not a cull from field trials. He may not run as far but he is a classy bird finder with all the savvy that hundreds of wild birds can produce. He doesn't usually go so far because he is very eager to be near the gun. This exciting dog has been hunted and the sport has increased his desire to do so in partnership with his owner. This quality of closeness is exactly what the foot handler is looking for. Closeness in relationship, not necessarily in range, is what the pointer needs.

Of course, in certain grand field trials areas in a very few parts of the South, and on our Prairies, such a union could be achieved with a horse as a little more than a means of conveyance. Then, I suppose, "Old Zeke" could be conferred a true "Horse-back Shooting Dog." Meanwhile, back in the chicken yard it was very lonely listening to the merry shouts fading over hill and dale.

THE INNOCULATION PICTURE

The vaccination schedule which has been compiled from recommendations and opinions of noted canine immunologists is as follows:
I. Canine Distemper (CD)

- A. Immunizing agent: Use of modified live-virus (MLV) vaccine of chicken embryo origin or tissue culture origin.
- B. Age Considerations: Orphan pups that did not get colostrum can be vaccinated when only 2 weeks old. If under 3 months old, a pup of unknown immune status should be given 2 doses of vaccine.

Dose 1: Give as soon after weaning as possible.

Dose 2: Give when pup is between 12 and 16 weeks old, but not sooner than 2 weeks after dose number 1. Alternate method: Give vaccine every 2 weeks until pup is 16 weeks old. This method provides maximum protection.

If more than 3 months old, a pup of unknown immune status needs only 1 dose of vaccine for adequate protection.

- C. Revaccination: Annually revaccinate all dogs.

- D. Vaccination precaution: Do not vaccinate pregnant bitches, the effect of the vaccine virus on the fetus is not known.

Do not take a dog into an area where he may be exposed to CD unless he has been given MLV within the previous 12 months.

II. Infectious Canine Hepatitis (ICH).

- A. Immunizing Agent: Inactivated-virus vaccine or MLV vaccine is acceptable.
- B. Age Consideration: Immunization is recommended at the time of CD immunization. Vaccines combining ICH and CD antigens are satisfactory.
- C. Revaccination: Annually revaccinate all dogs.
- D. Vaccination Precautions: Antiserum should not be used for short term protection prior to active immunization because it may interfere with subsequent active immunization. MLV vaccines containing ICH virus (canine adenovirus I) may produce transient opacity of the cornea 10 days to 3 weeks after vaccination.

III. Canine Leptospirosis:

- A. Immunizing Agent: *Leptospira canicola* and *Leptospira icterohemorrhagiae* bacterin is acceptable.
- B. Age Considerations: Give first dose when pup is 9 weeks old, this is when most pups lose their immunity that was obtained from the mother. Give second dose 3 weeks later or when the final dose of CD-ICH vaccine is given.
- C. Revaccination: Revaccinate all dogs annually.
- D. Vaccination Precaution: Anaphylactoid reaction may occur and should be treated with epinephrine or atropine sulfate and corticosteroids. An anaphylactoid reaction is similar to a severe penicillin sensitivity in humans. It consists of, in severe cases, hard breathing and possible convulsions which may lead to death of the animal. This is an extreme and rare example.

IV: Rabies:


- A. Immunizing Agent: Rabies Live-Virus (RLV) grown in chicken embryo or from tissue cultures composed of canine or porcine kidney.
- B. Age Considerations: Pups should be vaccinated at 3-4 months of age followed by a booster shot at one year of age. If first vaccination is later than 4 months of age, booster should be given one year after first vaccination.
- C. Revaccination: With RLV, revaccinate every 3 years after booster. If an inactivated-virus vaccine is used, a booster is given 3-4 weeks after first vaccination and revaccination once a year afterwards.

This vaccination schedule is recommended for optimum protection. Although modified schedules can be used, this schedule has been proved the most effective.



THE FUTURITY

What is a Futurity? It's a gamble made by a breeder that he can produce better quality pups than other people. It's a statement of faith in himself and his ability to plan a correct mating of two individual dogs and either to bring the outstanding pup along to its greatest potential, or to place the pup in the hands of someone who will accomplish the same end.

What do you as a breeder gain from nominating a litter? By nominating you are openly stating that you are trying to breed a quality dog. Such litters are much more in demand as the chance of getting an excellent pup from a Futurity mating is better on the average than purchasing a pup from a mating with less thought behind it. So you can expect more demand for your excess pups. You gain the satisfaction of being able to pit your breeding against that of other top breeders in a special stake and, if you should be lucky to have bred one of the winners, either field or bench, you will receive a monetary reward.

Isn't nominating a Futurity litter expensive? No, not really. The actual cost to the breeder is only \$16.00. The rewards to be reaped, if one can produce a winner, are great. Not only does one receive money but prestige as well. Future pups from a successful breeding are much in demand so you can be assured of placing them in the hands of people who will do something more than hunt with them.

Let's take a mythical Futurity winner through from start to finish so that you may fully understand what is involved.

Mr. Brittany Owner (BO) decides to breed Sally to a well-known producing stud and the stud dog owner suggests he Futurity nominate the litter. This sounds like a good idea so BO joins the local Brittany Club to fulfill the first requirement, that owners of Futurity litters and Futurity hopefuls shall be ABC members. As soon as the bitch is bred he sends the \$8.00 fee to the ABC office knowing the forfeit must be paid within 30 days of breeding and that the rule is strictly adhered to. With the fee he includes the form that he finds on the inside front mailing cover of the magazine, filling it out as completely as possible, being sure to give the name of the sire and dam and the breeding date. He has Sally's registration number but not that of the sire although he knows the sire is registered because he has run regularly in trials. (The Futurity is open only to dogs registered or eligible for registration in a recognized stud book.)

BO is unlucky. Sally doesn't have any pups. He writes the ABC office within 30 days to let them know. He receives a card for an \$8.00 credit. What to do now! He is discouraged

and thinks he may give his credit to Mr. Show Breeder who is thinking of breeding his bitch. Or should he wait until Sally comes in heat again either late summer or the following winter? (The credit is good for the present Futurity or the one that follows.) No, she may come in heat after July 1st and before October 31st, the period when no Futurity nominations may be made. BO finally settles on breeding his other bitch, Suzette, and uses the \$8.00 credit for the first forfeit on her litter.

He sends in the form and the credit card as soon as Suzette is bred and keeps his fingers crossed that she will whelp. If she does not his \$8.00 is down the drain for only one transfer is allowed. But she does whelp, 9 beautiful pups, the prettiest BO has ever seen. When BO paid his first forfeit he received in addition to a receipt that he retains a form to be sent with his second forfeit. Now he fills this out, being sure he gives the date of whelping and the number and sex of the pups. He sends this to the ABC with \$8.00 before the pups are 30 days old.

He receives a receipt and, this time, a form for each puppy. He passes these forms along to people who purchase the pups because they tell about keeping up the nominations due on individual pups the following summer.

BO decides to keep the sturdiest male pup for himself. He begins its training both bench and field, registers it and enters it in a few trials and shows when it is 6 months old: There is no competition in the puppy class at the shows but one judge admires the pup so BO is encouraged. Britt, as the pup is called, meets competition in the puppy stake in the fall trials. Here his extreme youth is against him. He shows promise but not enough to be in the ribbons. Luckily he was born in February which makes him near the maximum age for the Futurity, January 1st being the first allowable day for whelping.

Not discouraged BO and Britt learn from their experiences in the ring and in the field and feel much more at home when spring trials come around. Now Britt does his thing in the puppy stakes again and comes home with a few ribbons. BO is so proud he almost busts his buttons. He cannot wait until fall and the Futurity roll around.

In June, when Britt is about 16 months old, BO gets more forms from the ABC. These are sent automatically to all owners who bred litters. BO sends forms on to the people who purchased pups from him with a reminder that they must pay the fee due August 1st if they intend to enter the Futurities. He sends a personal note to the one or two that he feels have outstanding prospects.

BO decides to go the whole way and pays

the fee for both the show and field for Britt. The \$15.00 won't break him and it will give him until a week before the actual trial and show to make up his mind whether he wants to actually compete. If the August forfeit is passed by there is no way he can compete in November.

When the list of eligibles is printed in the Brittany magazine BO adds up the \$16.00 per litter, plus the \$15.00 per dog for the August forfeit and figures out the total purse. He figures roughly what his share might be as owner of a winner, or what he might get as breeder if one of the pups that he sold won a place.

As Britt has matured well BO has spent the late spring and early summer in taking him to dog shows. Britt breezes right through to his show championship. This is a plus for BO as now the dog is automatically qualified for the show end of the Dual Award. If he didn't have his championship he would have to place in a class in the Futurity Show, defeating at least one dog.

Britt is running well when fall trials come and takes his share of placements in the Derby Stakes. BO keeps his ears open, listening to those who know talk about what kind of a dog will win the Field Futurity. He comes to the conclusion it will just be a super-derby dog, one that will point and hold till the birds are flushed and one that will be endowed with a lot of "class." No plodder or mechanical dog will be a Futurity winner! The wild bird bit is going to be hard he knows because he has seen how much more difficult it is for Britt to pin wild birds than pointing planted birds in a birdfield, but he aims towards getting Britt to hold his wild birds until they are flushed for him. Luckily Britt is born with a lot of natural staunchness on point and the job is thus made easier. The class he hears will be expected of a Futurity winner he can't put in the dog. Here again Britt is lucky in that he runs with a smooth easy gait, has a high head and tail and a naturally good pattern.

His plans are all made for the trip to the Futurity when, alas, a big business deal comes up that will require BO's presence at Futurity time. He decides the dog is good enough to gamble a little more money on and sends Britt to a well-known professional field trainer. He is a little disturbed when he talks terms with the pro to find that it is usual for a pro to take all cash purses won by a dog, with the owner getting only the trophies and ribbons. He considers costs and decides to go along with the pro. If Britt should be so lucky as to place he would still have his one-third of the purse that is paid directly to the breeder.

The entry forms arrive and are filled out and returned promptly with the required fees (\$25.00) and Britt is eligible to start in the field and show. At the last minute the business trip is cancelled and the Futurity trip is on again! BO decides to let the pro run the dog because he has been working him for the past 6 weeks so Britt is now more used to the pro's ways. Anyway that extra edge of pro handling may pay off though a look at the statistics of past winners shows a good many were owner handled.

BO arrives the day before the trial starts and gets Britt to pretty him up for the show. His ring experience from the previous summer helps and the judge gives him a first in his class. The gaitting around the ring and the posing for examination are old stuff to Britt! BO sees a couple of other dogs in the class that look mighty good to him but both refuse to lead without pulling and tugging at the leash and won't stand still long enough for the judge to properly evaluate them. BO is glad he spent the time getting Britt properly prepared for the procedures and mannerly as well.

The field stake starts the next morning and dog after dog gets put down and picked up early. BO rides all the braces and privately is sure Britt is much better than the dogs he has seen that have been picked up early. But he keeps his fingers crossed as both cover and terrain are strange to his dog which is probably the reason why so many of the youngsters aren't making the full route.

BO watches as some of the big name dogs that have done so well in local trials make the complete half hour. He puzzles as to why some of them run so well for the first two-thirds of the brace and then slow down and work in close. Suddenly it occurs to him that these dogs are so indoctrinated to one course trials that they are putting out for 20 minutes and then coming in to work a birdfield. He gives himself a pat on the back that he has worked Britt on a good many wild birds and has conditioned him to run full out for the entire time he is down.

He watches a couple of the threats that he had feared run beautifully. One runs right through his birds as though he does not even smell them. BO decides this one must have been pushed to run too fast for his nose or that he is just running and not hunting. The other slows down when he smells game, points and moves up. Of course the inevitable result as BO knows is that the birds flush. BO is riding to the side where he happens to be in a position to see all the action but even quick riding on the part of the judge does not put the official in a position to see



the dog stopped. All he sees is the dog disappear behind some brush and birds bust out with the dog in hot pursuit.

It comes Britts turn and BO is as nervous as when his first son was born. Britt starts well and the hours hunting elusive wild birds pay off as Britt's knowledge of their habits leads him to find a covey at the half way mark. He points staunchly and lets the handler flush. He stays for a few seconds, then succumbs to temptation and takes gayly off in the direction of the flight but swings quickly around to the front again, a fine derby performance.

BO sweats out the remainder of the stake—and to make a long story short Britt did win the stake and BO went home proud and happy with his trophy, his breeder's share of the purse and the thing he was most proud of, his certificate saying he was the breeder of a Futurity winner.

Dear Editor:

I have a "gripe" that I would like to share with the readers of the American Brittany. It is my personal opinion. I am sure it has happened to others and not just in the Brittany ring.

Professional handlers—What a category to cover! But my point will be the injustice done the owner-handler. Don't get me wrong,

I think professional handlers are great. But I have seen, too many times, a professional handler go up to a judge before entering the ring and flash his little professional handler's pin under the judge's nose as if to say, "See this pin. I'm a professional handler. Now don't forget it." And all too often he wins no matter what his dog looks or acts like. And a lot of the time his dog looks and acts terrible. I have seen this happen many times, as I'm sure others have, and I don't mean just in the Brittany ring.

What does this mean to the owner-handler that has a good looking dog? Disappointed? Yes! Angry? Yes! But what can he do about it? Nothing! Maybe the American Kennel Club should give out owner-handler pins so that they can be flashed under the judge's nose also. Does it do any good to complain? Who do you complain to? Even if you do find someone to let off steam to, it does no good. Why? Because the judge's decision is final and if complaints are sent to him it doesn't make a heck of a lot of difference. He keeps on picking the professional handler that does the most pin flashing and not the best dog. Some of us can't afford to hire a professional or just enjoy showing our own dogs too much to use one. Just what can the owner-handler do?

DISTEMPER-MEASLES VACCINE

Norden Laboratories have announced the production of Enduracell D-M, the first canine distemper-measles vaccine. According to the release it is a unique combination of modified live canine virus and modified measles virus and is especially useful in protecting young puppies against distemper.

Enduracell stimulates two types of immunity that work together to protect the puppy. The measles virus stimulates immunity against distemper even though a puppy's maternal antibody level is high enough to resist regular distemper vaccine. Regular distemper vaccine, if given to 6 weeks old pups will only immunize 50% of them. With Enduracell it is estimated that 96% of the pups will receive immunity. This is because the two immunizing agents act independently, protecting the pup whose natural immunity is still high enough to resist regular distemper vaccine.

It is important to protect pups by 6 weeks of age because then some are weaned and sold. Chance of exposure is increased right at the time the puppy's maternal immunity is falling off.

The measles virus used is fully attenuated—that is it cannot cause a measles reaction in either humans or dogs. The product is now available at most veterinarians. It should not be used on females over 12 weeks of age.







PEOPLE AND THE NATIONALS

It was woman's lib at this year's Nationals. At one time judge Gene Brown looked at the two lady handlers in front of him, Marie May and Raedell Poling, then looked behind to see marshal Eva Lewis and reporter Joy Watkins. We'll never know what went through his mind but it must have been an interesting thought from that little smile that passed over his face.

It was woman's lib again when the show was won by Ch. Credence Skoshi. The last (and only) time that a bitch had won the National Specialty was in 1947 when Retta of Avono was Best of Breed. An unbelievable coincidence—Retta was bred by a woman named Loretta Stroup from a bitch she had imported from Italy. It was the Stroup's only contribution to Brittans and they vanished from the scene to reappear, believe it or not, at the Lake Murray Lodge where they came on other business. Mrs. Stroup introduced herself when she found the Britfans were there and was able to contact someone who had actually seen the 1947 win of the bitch she had bred.

And also—Ruth Lee was elected by the membership as an Honorary Member of the American Brittany Club. She's the first of her sex to attain that distinction, a well deserved honor.

And—Jan Hoover is one of the new members of the Board of Directors.

And that's enough women's lib to last out the year . . .

The hottest item of the trial was best related by Astrid Dorrough who said she'd heard they'd run trials through sleet and snow and hail and rain, and even through hell and high water, but now she thought we had better add fire to the list. The story goes like this. The Jeep burnt up—a total loss. While following the Futurity on one of the days when it was too muddy for passenger cars to follow the dogs the Jeep started to cross a fairly deep ditch with the loaded dog wagon right behind. The red to the certain performer who tried to show Herman Bonine that he could stand up on Herman's horse. The yellow to Ma Cohen. Pa Cohen was more shook up than she when he saw her stretched out on the ground. Grandson was most concerned because she had got a run in

her stocking. You can't keep a good one down and Ma was up and at 'em again the next day even though her leg was blue and swollen almost from ankle to knee. Her award was third because her problem was a kick, not a fall.

Mrs. Johnson was seen riding double with Lyle but it was the wrong Mrs. Johnson, Janice had taken the most available Rumble Seat to see husband Jim handle their dog.

Doug Birchfield, waiting for the other handler to flush as he stood beside his backing dog must have been a trifle nervous for he accidentally shot his pistol in his back pocket—made riding and sitting a bit painful.

Informal voting of the gallery gave Harry Wirth the Pro-Am award as he handled 4 amateur dogs besides his own. Runner-up honors went to Mack Smith who would have won if he hadn't lost his voice about mid-trial.

Just horsing around. Jim Holman unsnapped one of Darrell Gaynor's reins. Jim was chuckling at his own joke and did not realize until almost too late that Loyd Budd had removed the whole bridle from Jim's horse.

Bill Clougher claims that he used to be called Wild Bill in his younger days but now he's known as a Sexy Senior Citizen.

Dub Emde's red polka dot hat matched his dune buggy just fine, but, boy, did it ever clash with his orange jump suit.

Stirrup, stirrup. whose got the stirrup? Bill Cline gets the prize for riding the farthest without one and George Taylor from Canada gets the prize for bouncing the highest when he lost one.

You should have seen Ken Idol's classy hat retrieve from the top of his horse. When judge Ferrell Miller tried it he managed to retrieve the handler's hat, but lost his own!

THE NEW CHAMPION and others

The new Open Champion Ban-Dee is presently owned by Wayne Oliver and is in the string of Loyd Budd. His original owner was Dick Lee under whose ownership the dog was campaigned some as a puppy and derby, winning four puppy places and his points plus one derby placement. Wayne obtained the dog when he was three years old and put him with Bill Hunt who broke him and finished his championship with the help of Wayne who put two amateur firsts on the dog.

As Hunt could not make many Brittany trials, Wayne planned to give the dog to Budd to campaign but before that could be accomplished the dog suffered a serious accident in which his front leg was broken. He had to have a transplant of bone marrow and was in a cast for six months. During all this time it was necessary to keep him as quiet as possible but along towards the end he would jump the fence, cast and all, in the hopes of being allowed to run.

Sent to Budd three seasons ago Ban-Dee was almost returned because he limped so badly. But birds made him forget the limp and soon there was no sign of an injury. This past summer the dog was shown a few times and won two four-point majors.

Ban-Dee placed 15 times in trials in 1973, seven of them firsts. These wins included the U.S. Open, the ABC National Open and the largest all-age stake ever held by a local Brittany Club (77 starters).

To round out the picture Ban-Dee spent the time directly after the Nationals at home where Wayne did his usual gunning over him.

Students of breeding will be interested in his pedigree. His sire is well known as a producer, having 3 field champions to his credit, including the former National Amateur winner, Gringo de Britt, as well as 2 bench champions. Lady Joyce's Ginger is a field winner and producer. Penny's Pecos Bill is an Olتمان field winner directly out of Alamuchy Valley Warrior and Dual Ch. Penelope de Evanston, thus making Ban-Dee closer than most to the basic early greats of the breed.

Fld. Ch. Goldtone Duke needs no introduction to Britfans. It was announced that this would be Duke's last appearance in trials, he having passed his tenth birthday some months ago. His age was not evident in his perform-

ance. He still ran as big as he did when he won the title in 1968 on these same grounds. His record shows 23 AKC places with 11 of them firsts and besides this 2nd place in 1973 shows a 3rd in 1969 in the Open Championship and a 2nd in the Quail Classic. His American Field record shows 3 placements, two wins of the Oklahoma Quail Championship and runner-up in the U.S. Open. As a producer he is responsible for 26 winners (to August 1973) including the field champions Goldtone Sadie, Boju's Tygo Duke and Paul's Goldtone Whiskers.

His pedigree shows no winners in the first two generations but the National's winner Jeffrey of Argard, whom Duke strongly resembles, is on the top sire line in the 3rd generation.

The third place Fld. Ch. Augustus of Rivers, an 8 year old, won this championship in 1970. He has won the Quail Classic and the Chicken Classic and placed in both Grouse and Quail Classics among his 31 placements. He has 16 firsts, most of them in wild bird trials. He had sired 26 winners (to August 1973). He is the sire of 6 bench champions.

His pedigree shows no winners in the first two generations but one granddam is daughter of Tex of Richmond while most of the breeding on the lower half of his pedigree is Kaymore for some distance back and includes Doctor Joe and his brother Jig.

The fourth place dog, Fld. Ch. Evergray's Tic Toc Terry, is a 6 year old with 28 places, 13 of them as a juvenile. Over half of his adult placements are firsts. This is his first National placement.

His pedigree is of interest, his sire being a Classic's winning field champion and full brother to Fld. Ch. Pin Oak Guy. His dam traces back to some of the Hells Oklahoma dogs.

AMATEUR CHAMPIONSHIP

THE ENERGY CRUNCH

It's upon us and the big question is how to get to the trials on the available gas. A share-the-ride policy may be the order of the day. Problems can develop when you try to squeeze a bunch of people, their gear, dog food, crates and of course the dogs in one vehicle. The obvious answer is a trailer. But suppose no one in the club has a trailer. An inexpensive solution is for several club members to get together and build a "jig-saw puzzle" trailer.

It's what its name implies, a trailer made up of pieces that can be assembled and broken down easily. It consists of a flat bed base on which crates are fitted with a top to tie them down. It can be assembled in five minutes, and as easily broken down when the crates are needed for other purposes. It's cheap and fast to build because any available crates may be used, each member perhaps contributing his own for his own dog.

The big expense will be the wheels and frame. It is possible to purchase a stripped down boat trailer chassis for a nominal amount of money. A boat trailer is necessary because it has the small wheels and so the assembly can be kept low enough to the ground to be stable at high speeds. The extra long tongue can be cut to the necessary length when the trailer is completed by using just a good old hack saw and a lot of elbow grease. Otherwise no alterations are necessary.

If you are suspicious of the small wheels don't be. A trailer built in a similar manner to that described below has gone all the way across country and back and been used for several seasons with never a problem. The prediction was that the bearings would not stand the high speeds because they would dry out too rapidly. This did not prove to be so. Perhaps the bearings on boat trailers burn out quickly because of the immersion of the wheels in water every time the boat is loaded or unloaded. To be on the safe side the bearings should be repacked before each trial season. Most boat trailers are well built, sturdy and balanced so that they pull straight and true at maximum speed limits.

First construct a platform to go on the wheels, not making it any wider than the width of the vehicle that will be pulling it. The bed should be fastened in such a position that it balances well for easy attaching to the car. When you are absolutely sure of the location of the platform you can figure the turn radius and cut the tongue, being sure you don't get it so short the corner of the finished trailer will rub the car on a short turn.

Fasten a rail securely to the outer edge of the flat bed. This should be made of 2x4s. The dimensions will be governed by the size of the crates to be used. Take your crates and those of other members and plan the length and width needed to hold 6 crates. It may be necessary to place a couple of stringers down the center of the flat bed if some of the crates have handles on ends. These stringers might be used when you use smaller crates and removed when you want to put on larger ones.

Build a 2x4 frame the same size as the rails on the flat bed and cover it with a piece of exterior plywood, well painted, or, if you want to spend more money, with some type of corrugated aluminum or plastic. This will serve as the roof or top.

Now put your crates on the flat bed, being sure they are firmly wedged in place against the outer rails. If you use a different combination of crates each time out you may have to cut spacers of various lengths as needed. Place the top over the crates so that it fits firmly down on them with the crates inside the 2x4 frame. This will hold them from shifting.

Install four large hooks on the sides of the top rails near the four corners and four large eyes directly under them on the rails on the flat bed. Get four lengths of strong but small chain and four sturdy turnbuckles. Install these by hooking the chain in the upper hook threading it through the eye and hooking it onto one end of the turnbuckle. The other end of the turnbuckle will hook onto the hook where you started. Now tighten the turnbuckles until the chain is taut. This will hold the roof down and will keep the crates from bouncing off the flat bed.

With this kind of rig the guys can get together at one house, load their own crates and take off for the trial. Upon arriving home the top can be removed and each man can have his own crate to take home and use between trials. By adjusting spacers on the base almost any normal Brittany-sized crate will fit in. By seeing that the four tallest crates are in the corners and are approximately of the same height the top can be made to fit securely.

If you want to get fancy you can have a frame welded to the front side that will hold a water can—or the ultimate would be to build a permanent box on the back edge to accommodate dog dishes, cans of food, leashes and other gear.

As a bonus the flat bed can be used as a utility trailer. One could build a box to fit inside the rail and the trailer would be usable in almost any way that one could use a regular utility trailer.

MEMBERSHIP MEETING

The meeting was called to order by the President, Lloyd Conable, Jr. He announced that this meeting could be held on Sunday, November 18, 1973 when there would probably be more of the membership here during the Amateur Stake and arriving for the Futurity, so he would entertain a motion that the meeting recess to reconvene on Sunday, November 18, 1973. The motion was made by James Cohen, seconded by several and carried.

The Annual Membership Meeting of the American Brittany Club, Inc. was called to reconvene on Sunday, November 18, 1973 by the 1st Vice-President Marvin Lewis in the absence of the President.

The following introductions were made; Clifton Hulsey, Specialty Show Judge; Herman Bonine, Amateur Championship Judge and Mrs. Bonine; Darrell Gaynor, one of the Futurity Judges and another Futurity Judge, Carl Robeson accompanied by Mrs. Robeson. J. W. "Dub" Emde was introduced as coordinator for the 1973 Nationals and commended for the great job he has done.

The chairman entertained a motion to accept the 1972 Membership Meeting minutes as printed in the January issue of the American Brittany. It was moved, seconded and carried.

OFFICERS' REPORTS

President—As President Conable was not present Jack Beck read his report which gave an account of the trials he had attended during the year and stated the goals he had when he took office. These goals were to improve the image the ABC members had of the AKC, to return the management and direction of the affairs of the ABC to the Board of Directors and to break down provincialism among the regions. He also touched on the proposed new constitution and by-laws that will go to the AKC for approval before being submitted to the ABC membership for a vote, the new officers' duties, the Magazine Management Committee and the financial status of the club. He wished his successor a successful and productive administration.

I would like to express my appreciation and thanks to Mr. Dan Buster, National Open Championship stake manager; Dr. Terry Poling, National Amateur Championship stake manager; Mrs. LaReine Pittman, National Field Trial Secretary; Mr. Dub Emde, Coordinator; all members of the Field Trial Committee; and the ABC Membership for

their support and assistance in preparation for and running the National Trials.

There has been an increase of Regional Clubs holding Specialty Shows in the past year, many of them in conjunction with their field trial. The ABC National Specialty Show will be Monday, November 19, 1973. We have an entry of 122 dogs for an entry of 147. This is among the largest national shows that we have ever had. The AKC is changing its method of measuring dogs and as the Brittany has a disqualification on size we will be affected by this. Whether it will present a serious problem or not remains to be seen. As far as we know it will go into effect some time in the spring. While not under the jurisdiction of the 3rd Vice-President, I would like to compliment the Susquehanna Club on the excellent job they did on the Summer Specialty Show. It was one of the finest Specialty Shows that I have ever seen.

As executive secretary I wish to submit a resume of recent Board action at the all-day meeting on Friday and the second session that was completed at 2 o'clock Sunday morning.

The Board voted to request the AKC delegate, Dr. Utzinger, to go to the December AKC delegate's meeting to oppose the new measuring system for shows.

The wording of the Dual Dog award was clarified. All entries of show champions that show in non-regular classes with single dog entry (like veteran, field trial, parade of champions, etc., but NOT those with multiple entries like Stud Dog and Brood Bitch) will

automatically receive points towards the Dual Award.

The Show Standards Committee was re-activated.

A committee was appointed to look into a modification of the qualifications for the 1975 Nationals. The committee will be headed by Dan Buster.

Qualifications for 1974 were approved as being the same as 1973 with the exception that 3rd and 4th in the National Open Championship would be qualifying placements.

The appointments of Warren Montgomery as Futurity Chairman for the Futurity which began October 31, 1973 and of Ray Porter as replacement for Perry Chisum, Jr., on the Junior Handler's committee were confirmed.

The ABC will purchase accident insurance on all judges for all ABC National events, including the Classics.

The Nationals for 1974 were set for November 13 to 25 at Ardmore with the Open to be run first, the Amateur to follow. A decision was made to split the Futurity in 3 sections for 1974 and a committee consisting of the 3 Futurity Chairmen was appointed to report back with necessary regulations no later than March 1st.

A committee will be appointed to look into the possibility of using Camp Robinson in Arkansas as a future site for the Nationals.

A new set of officers' duties were adopted. The new by-laws were discussed, some changes made and the entirety adopted subject to AKC approval.

The resignation of Nicky Bissell was not accepted. Her verbal resignation as Club Secretary was accepted and LaReine Pittman was appointed to fill the unexpired term, Ms. Bissell retaining the Executive Secretary's position and the Editorship.

Dues were raised to begin in 1975 to \$12 per year with half year membership set at \$9. Associate memberships will remain at \$3.

Two new trophies were accepted, one of the top scoring obedience dog of the year and the other for the bitch winning the highest placement at the Nationals.

The Board voted to pay the traveling and living expenses for the Treasurer for the Nationals.

A donation of \$500 was made towards the barn fund at the Lake Murray grounds and the legal advisor was instructed to see about the setting up of a fund for individuals to donate through the ABC.

Darrell Gaynor resigned as director from the Central region and C. Kent Lipsey was appointed to fill his unexpired term.

Lloyd Conable, Jr. was appointed as AKC delegate.



BREEDER'S FORUM

by Eric Van Patten

Now let's consider the case of puppies. Puppies can be real fun. We breed very sparingly, usually for replacement stock for ourselves or special friends. We also breed to prove or strengthen some characteristic in our own strain which we have carefully observed and developed for some time. We practice inbreeding, so we can shorten the process of selective fixing of desired traits and put more purpose into the program. Here I must caution that a successful inbreeding program requires the utmost care in selection of breeding stock, careful screening of the get and candid hard headed culling if and when necessary. There is no room for the "willy-nilly" back yard breeding approach. You must know your stock and what to look for. You must be prepared to put more management effort than normal into your entire program. However, inbreeding can bring very successful results. We have had good results. To me it is a big thrill and is always amazing how you can see individuals from a close mating show many of the personality traits of the parents.

At present, we have two male puppies, a product of just such a close mating. In fact, Rebel is both the grandsire on one side and the great grandsire on the other. Rebel's sire was Jeffery of Argard, so you can see what our purpose is.

I have bred dogs of a variety of different breeds for over 25 years with well over 100 litters and have witnessed what is interpreted and described in the American Brittany as "swimmers." Discussing this with many experienced breeders and vets and from my own findings, I learned that in most cases one will find that the so-called "swimmers" appear as the result of the whelp being over-nourished from a good milk supply from a very productive bitch and the metabolism of the pup being such that it rapidly develops in size and mass during the nursing stage to a point where at around 3-4 weeks of age, when the pup usually starts to get up on its feet, it is so fat it is almost impossible to get its legs under it. Along with this, the fat puppy is usually flattened out with its still plyable rib carriage spreading out on each

side of its body and the belly portion becomes almost perfectly flat from laying in this position. The flatness is the result of the excessive weight of the body, creating the plyable rib carriage and bone structure to distort accordingly.

This phenomena seems to appear in cases where the litter is very small, and/or the bitch's milk production is excessively good. Where the pups are chronic "chow hounds" they develop in size and weight usually more rapidly than those who do not wind up as so-called "swimmers."

Also it has been noted that most heavier pup will have more difficulty getting on their feet if the surface of the whelping box is smooth or slippery, and the pups getting heavier with time, hence slipping so much, they too will start swimming.

Years ago I was advised by a renowned vet in my area, to gently roll the puppy with both hands like I would roll a piece of dough, in a manner that would tend to slowly round out the rib carriage and component parts of the body. This was done every four hours for a few days and surprisingly the rib carriage always returned to its normal shape and the pups would get up and walk at the regular time with no problems at all—or any trace that they originally were flattened and so-called "swimmers." No pulling or restraining of legs in a special position was ever required.

If a diet of vitamins and minerals were needed, it is my conclusion that the breeder waited too long to find this problem of a swimmer in the first place, since such a condition should have been detected and noted long before the pup was weaned and while it was still nursing on its dam.

A routine daily check of all pups should detect this problem long before the pup attempts to get up on its feet and corrective measures as described herein should be instituted upon detection.





The 33 entries created a four point major for dogs and a five point major for bitches.


The judging was very capably handled by Miss Dorothy Nickles of Ft. Worth, Texas.







To complete the Cooper's day, their flashy **Ch. Handle-Bar-Sal of Edwards**, breeder/handler R. H. Edwards was WB to complete her championship. Her wins were 5, 4, 3, 2 and 1 point shows. She has 5 field placements under the handling of Jerry Cohen. The "icing on the cake" came as Sally was awarded BOS at the 1973 Futurity Show in Ardmore. Sally will be taking a rest from showing and trialing to raise a family.



Yaucher's Ra-Pa-Lu, owned by John W. Lee, completed his Dual title with Carol Montgomery handling him on the bench. Lu is sired by Nat'l. Amat. and Fld. Ch. Little Rapa Luke out of the winning Rujohn Rip's Annabel. Lu has won 23 field placements, ten of them firsts and placed in the National Amateur Championship in 1970. He has sired 5 winners to date. He has been handled primarily by his present owner though he also won under his first owner, Ray Yaucher, and was in the string of Holmans for a time.



ACTION AT AKC



Confirmation of new champions, obedience degree holders and group winners is taken directly from the Purebred Dogs (official AKC publication). Do not notify us that your dog has finished unless his name is not published at the end of six months. It takes this long for official confirmation to reach the pages of the American Brittany.

At the December meeting of the AKC Delegates the new system of measuring at shows was adopted to become effective on July 1, 1974. Measuring committees were eliminated.

Measuring will now be done in the ring by the judge with the handler posing the dog. The judge may make the measurement if he is in doubt about the dog being of eligible height. Any exhibitor or handler then in the ring may request a measurement of a dog under judgment but must do so prior to the

time the judge marks the placements in his book.

The equipment used will be a wicket that the judge will slip over the dog's shoulders from the rear. All-breed shows will have adjustable wickets while fixed wickets will be available for Brittany clubs if they hold separate specialty shows. The price of wickets has not been released but the ABC will be prepared to purchase a set for rental to local clubs if the price proves impractical for them to manage.

Any dog disqualified may not be shown again until such time as the owner has applied to the AKC and received official notification that the dog's show eligibility has been reinstated.

The system should do away with some of the ills of the present measuring system. No longer can one dog be substituted for another in pre-show measurement. Theoretically measurements will be more accurate and with less variance. The untrained dog who refuses to pose will still not be accurately measured but at least there may be a better chance of controlling him with his own handler doing the job rather than a strange person from a measuring committee.

HOOSIER FALL TRIAL









Harper of Mount Tom, handled by the other red head, Doug Birchfield, Sr., combined his winning streak with a tremendous run and top bird work but shorter on the range than





GREATER INDIANAPOLIS FALL TRIAL



The air was crisp with a rising sun as the first brace of the all-age broke away. The cover being heavier than normal made the course a little tighter than you would like to see for keyed up all-age dogs.

As the first brace was running it was obvious that if a dog was going to run the judges were not going to see much of them. Although birds were plentiful on the course, the stake was finished with only two dogs with clean bird work and anywhere near acceptable run. One of these was Bob Morris's Juchoir's Neakanie Jenny, with an outstanding forward race that had handler and judges worried at times if she was going to get lost. Jenny always managed to show just at the last second. At about mid-point in the course she nailed a single dead to rights just off a hedgerow that was right where she said it was and she looked like she was three feet tall. She went on to finish strong, giving handler and judges some anxious moments at the end. It was a great week-end for the Morris's. This win finished Jenny's field championship and to show that she not only has it, but can pass it on, Jenny had three of her pups placing in the Derby stake—two owned and handled by Bob and one owned and handled by John Lee.

Blue Grass Tex gave an excellent account of himself with three finds and acceptable race, running in the warmer part of the day. Just after he was picked up a quail was seen hot footing it down the road and did not want to fly or leave the road. Luther Lawrence was heard by everyone to remark that time had run out not a second too soon.

Warren Montgomery's Brandy ran the first brace and had an outstanding race that had handler and judges anxious about his return; but he showed and always to the front. He went birdless and was called back for a placement.

John W. Lee's Ra-Pa-Lu had an excellently handled, strong forward race, but ran at the time of day that birds seem to be scarce and he, too, went birdless but was called back to show on birds for his placement.

Other dogs that had the judges standing up

in the stirrups and the gallery excited were Pepperdust and Harper but, unfortunately, both were lost at the same spot. Bud Moore's Thunder was running an excellent race till he had some bird problems. Don Juan ran a hard driving forward race but was pushed somewhat by the horses.

The Derby dogs seemed to be somewhat erratic. They had a multitude of problems caused by heavy cover, deer, immaturity and handling. Kremblas's Sam was the only Derby to make it around with an acceptable race and birdwork. The judges saw fit to call back three dogs for placements; these being Bob Morris' Jack and Dynamo and John Lee's Julius. Other dogs that impressed the judges were Tex's Airman, lost on deer; Welker's Jacques was doing everything right until he



Fld. Ch. Juchoir's Neakanie Jenny





The Puppy stake started out with a bang when Red Welker and Jesse Lyons broke away their charges. The gallery knew from the start that Polly Ann and Ginger were the dogs to

beat. Both pups ran well with Polly having an edge in range. wind for bird scent.


